Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Williams Form Engineering Corporation 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 - DESCRIPTION OF PLAN

The following description of the Williams Form Engineering Corporation 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement or Summary Plan Description for a more complete description of the Plan's provisions. Williams Form Engineering Corporation (the "Company") is the plan sponsor and administrator.

General: The Plan, established January 1, 1976, restated June 20, 2022, is a defined contribution plan that provides for employee contributions under Section 401(k) of the Internal Revenue Code (IRC). The Plan covers substantially all employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility: Employees, excluding leased employees and certain non-resident aliens, are eligible to participate in the Plan upon completion of 30 days of service and attaining the age of 21. In order to be eligible to receive discretionary employer matching contributions, participants must also be employed at the end of the year. Plan entry dates are the first day of each month.

Contributions: A participant can make voluntary salary or wage deferral contributions of his or her eligible compensation, within the maximum allowed by the Internal Revenue Service. Participants who have attained age 50 by the end of the Plan year may also make catch-up employee deferral contributions in accordance with Code Section 414(v). The Plan also provides for a discretionary employer matching contribution. For the year ended December 31, 2024, the Company elected to match 25% of employee contributions, excluding catch-up contributions. The Company has the option for discretionary contributions up to an additional 25% of employee contributions for those employees who are still employed as of December 31. The Company elected to make a discretionary contribution of 25% of employee contributions, totaling \$309,359, as of December 31, 2024.

Participant Accounts: Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contributions and (b) Plan earnings and is charged with his or her withdrawals and an allocation of administrative expenses. Discretionary company matching contributions are allocated to participants who made salary or wage deferrals in the current year and who remained employed by the Company on the last day of the Plan year. Allocation of Plan earnings or losses are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Retirement, Death and Disability: A participant (beneficiary) is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contributions plus earnings thereon is based upon years of service. A participant is 100% vested after six years of credited service with graduated vesting beginning at 20% after two years.

Payment of Benefits: On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her vested account or installment payments. Benefits are recorded when paid. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

Notes Receivable from Participants: The Plan provides that participants can borrow funds against their employee account balance limited to the lesser of \$50,000 or 50% of their vested account balance. The loan amount must also not be less than \$1,000. Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Forfeitures: The nonvested portion of discretionary employer matching contributions of terminated participants are used to offset future discretionary employer matching contributions and administrative fees. During 2024, \$3,486 of forfeitures were used to offset Plan year 2024 administrative fees. There were \$946 of forfeitures available to pay Plan expenses or reduce employer contributions at December 31, 2024.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

Administrative and Investment Management Expenses: Nearly all administrative fees of the Plan are paid for by the Company (Note 6). Investment management fees are charged to the Plan as a reduction of each participant's account.

Subsequent Events: Plan management has performed an analysis of activities and transactions subsequent to December 31, 2024 to determine the need for any adjustments to or disclosures within these financial statements for the year ended December 31, 2024. Plan management has performed their analysis through August 19, 2025, which was the date that the financial statements were available to be issued and has determined there are no subsequent events to disclose.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments, except for the fully benefit responsive contracts disclosed in Note 5, are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties: The Plan provides for investment options in various mutual funds, collective trust funds, pooled separate accounts and an investment contract. The investments are exposed to various risks, such as, interest rate, market, liquidity, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participants' individual account balances.

NOTE 3 – CERTIFIED INFORMATION - INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustee of the Plan.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit.

Collective Trusts: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds a fully benefit-responsive investment contract that is reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the Plan's fully benefit-responsive investment contract, by general type, are presented below:

The Plan holds a fully benefit-responsive investment contract with Principal Life Insurance Company ("Issuer"). Principal maintains the contributions in its general account. The Issuer guarantees the Plan a return of principal and interest under the terms of the contract. The interest crediting rate is updated quarterly based upon contract provisions, and it may not be less than the guaranteed minimum interest rate, as shown on the contract specifications. Principal Life Insurance Company's general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which the Issuer may terminate the contract. Examples of circumstances which would allow the Issuer to terminate the contract include the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, the Issuer could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

NOTE 6 - PARTIES-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Transactions during the year with parties-in-interest include administrative services. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan for these services. Investment management fees are paid for by the Plan to investment managers who qualify as parties-in-interest, including Principal Life Insurance Company, Principal Global Investors Trust Company, Morgan Stanley and SBHU Life Agency, Inc. These investment management fees are reflected in the financial statements as a reduction of each participant's account. The majority of administrative fees of the Plan were paid for by the Company. The collective trust funds are issued by Principal Trust Company, the current Plan trustee, and as such, qualify as party-in-interest investments. The pooled separate accounts and the investment contract are issued by Principal Life Insurance Company, an affiliate of the current Plan trustee, and as such, qualify as party-in-interest investments. Notes receivable from participants held by the Plan also qualify as party-in-interest transactions.

NOTE 7 - TAX STATUS

The Plan has adopted a prototype document, which received a favorable opinion letter dated June 30, 2020. Plans that adopt prototype documents are no longer required to file for an individual determination letter. Although the Plan has been amended from the original adopted prototype document, the Plan sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.
