**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan document is controlling at all times. The Plan's trustees are David Clarke and Kristina Miloti (the "Trustees"). The Plan's custodian is Voya Retirement Insurance and Annuity Company (the "Custodian").

**GENERAL**

The Plan is a defined contribution plan covering all employees of the Company who have attained the minimum age requirement of 21. The Plan is subject to the provision of the Employment Retirement and Income Security Act of 1974 ("ERISA").

**CONTRIBUTIONS**

Each year, participants may elect to contribute up to 100% of their eligible compensation, pre-tax or post-tax (not to exceed the maximum dollar limit allowable under current regulations). Catch-up contributions of up to \$6,500 are allowed for participants who have attained age 50. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company contributes 100% of the participant's contribution up to 3% of such participant's employee compensation, plus 50% of the participant's contribution that exceeds 3% up to a maximum of 4% of the participant's employee compensation. For the year ended December 31, 2024, the Company made matching contributions of \$618,899.

Additionally, the Company has the option to make a profit-sharing contribution. Participants will be eligible to receive an allocation if they have completed at least 1,000 hours of service during the Plan year and are employed by the Company on the last day of the Plan year. The profit-sharing contribution is allocated to each participant's account based on the ratio each participant's total compensation for the Plan year bears to all participants' total compensation for the year. For the year ended December 31, 2024, the Company made no profit-sharing contributions.

**NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)**

**PARTICIPANT ACCOUNTS**

Separate accounts are maintained for each participant. Participant accounts are credited with participant contributions, rollover contributions, allocations of Company contributions and investment earnings and losses and are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit which can be provided from the participant's vested account.

**INVESTMENT OPTIONS**

Upon enrollment in the Plan, participants may direct the investment of their individual accounts among alternative investment funds provided under the Plan. Participants may change their investment elections at any time, as well as transfer existing balances between investment funds. As of December 31, 2024, the Plan provides for investment in separate accounts with underlying investment of 30 mutual funds and one fully benefit-responsive investment contract.

**NOTES RECEIVABLE FROM PARTICIPANTS**

The Plan does not permit notes receivable from participants.

**PAYMENT OF BENEFITS**

Upon termination of service, death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount, a series of equal payments or in the form of an annuity. In-service distributions are allowed for participants who have reached the age of 59 ½ or normal retirement age. Hardship withdrawals are permitted from participant deferrals and rollovers, within limitations and conditions as defined by the Plan.

**VESTING**

Participants are always fully vested in the Elective Deferral Account, Rollover Contribution Account, Qualified Non-Elective Contribution Account, Safe Harbor Matching Contribution Account, Discretionary Non-Safe Harbor Matching Contribution Account and Profit-Sharing Contribution Account.

**FORFEITURES**

Forfeited non-vested accounts may first be used to pay any administrative expenses of the Plan, and remaining balances may be used to satisfy contribution that may be required. During the year ended December 31, 2024, no forfeited non-vested accounts were utilized for administrative expenses or matching contributions. The company had \$1,686 and \$1,646 in forfeited non-vested accounts for the years ended December 31, 2024 and 2023 respectively.

**NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES**

**BASIS OF ACCOUNTING**

The accompanying financial statements are prepared on an accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

**USE OF ESTIMATES**

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions which affect the amounts reported in the financial statements and accompanying notes and schedules. Accordingly, actual results could differ from those estimates.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

The Plan’s investment in separate account funds are stated at Net Asset Value (“NAV”) of the underlying mutual funds, which is calculated daily upon close of the New York Stock Exchange and is based on the fair values of the underlying securities. Fair value is the price which would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The net change in the fair value of investments is reported in the statement of changes in net assets available for benefits in the period of change.

Contract value is the relevant measurement for the portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The contract value of the Plan’s investment contract is representative of fair value.

**INVESTMENT VALUATION AND INCOME RECOGNITION (CONTINUED)**

Purchases and sales of securities are recorded on a trade-date basis. Expenses related to the purchase or sale of investments are added to cost or deducted from proceeds. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**PLAN EXPENSES**

Certain fees for services charged by the Custodian may be directly charged to a participant. Investment management and advisory fees are charged to the Plan. Other administrative costs of the Plan charged by the Custodian are generally paid by the Company.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The Plan measures and reports certain assets and liabilities at fair value within a hierarchal disclosure framework which prioritized and ranks the level of observable inputs used in measuring fair value. Level one inputs include inputs which are unadjusted, quoted prices for identical assets or liabilities in active markets. Level two measurements include inputs which are either observable prices for identical assets or liabilities in inactive markets, observable prices for similar assets or liabilities, or other inputs derived principally from, or corroborated by, observable market data at the measurement date. Level three inputs are unobservable inputs which are significant to the fair value measurement. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input significant to the fair value measurement.

The Plan's investment in separate account funds are stated at Net Asset Value ("NAV") of the underlying mutual funds, which is calculated daily upon close of the New York Stock Exchange and is based on the fair values of the underlying securities.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Although the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 – INFORMATION CERTIFIED BY THE CUSTODIAN**

The Plan’s financial information included in the financial statements and supplemental schedule is based on the information certified by the Custodian as complete and accurate in accordance with 29 CFR 2520.103-5(c) of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. The certified information includes total investments of \$17,269,931 and \$15,318,446 at December 31, 2024 and 2023, respectively.

The Plan’s administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5 (c) of Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. The assets of the Plan are held by the Custodian. Accordingly, the Custodian has certified the following data included in the accompanying financial statements and supplemental schedule as complete and accurate.

**NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan entered into a guaranteed investment contract (the “Contract”) with the Custodian. The Contract is fully benefit-responsive; therefore, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Contract. Contract value, as reported to the Plan by the Custodian, represents contributions made under the Contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Funds allocated to the Contract are placed in the Custodian’s general account where they are invested in accordance with the Custodian’s investment policy. The account is credited with earnings on the underlying investments and charged with participant withdrawals and administrative expenses. The Contract issuer is contractually obligated to repay the principal and a specified interest rate, which is guaranteed to not be less than 1.00%, to the Plan.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (b) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions; or (c) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such event which would limit the Plan’s ability to transact at contract value with participants is probable.

**NOTE 6 – INCOME TAXES**

The prototype plan and trust agreement established by the Custodian to hold the Plan's assets is exempt from federal income taxes pursuant to the appropriate sections of the Internal Revenue Code by a letter dated March 31, 2014; and accordingly, the Plan’s net investment income is exempt from income taxes. The prototype has been amended since receiving the determination letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

**NOTE 7 – ADMINISTRATION OF PLAN ASSETS**

The Plan’s assets are held and certain administrative functions are performed by the Custodian of the Plan. The Company provides certain administrative functions and absorbs certain administrative costs on behalf of the Plan.

***NOTE 8 – PARTY-IN-INTEREST***

Net assets available for benefits include investments managed by the Custodian at December 31, 2024 and 2023. As a result, these assets and all transactions relating to these assets qualify as party-in-interest transactions. These transactions are exempt from being prohibited transactions by ERISA. Administrative expenses are mostly paid directly by the Plan Sponsor to the Custodian. Certain participant transaction fees totaled \$15,150 were charged directly to participant accounts for the year ended December 31, 2024.

Additionally, the third-party administrator and Plan auditors are considered parties-in-interest. These transactions are exempt from being prohibited transactions by ERISA. For the year ended December 31, 2024, no fees were paid by the Plan to the third-party administrator or the Plan auditors.

***NOTE 9 – RISKS AND UNCERTAINTIES***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible change in values of investment securities will occur in the near term and such change could materially affect participant's account balances and the amount reported in the statement of net assets available for benefits.

***NOTE 10 – PLAN TERMINATION***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan in whole or in part subject to the provisions of ERISA. In the event of Plan termination, the Custodian will distribute all assets remaining after payment of any expenses chargeable to the Plan to participants or their beneficiaries in accordance with the Plan's provisions.

***NOTE 11 – SUBSEQUENT EVENTS***

The Plan has evaluated subsequent events through the date of the independent auditors' report, the date which the financial statements were available to be issued. No matters were identified affecting the accompanying financial statements which have not been disclosed.
