NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

A. Description of the Plan

General

The following brief description of the Standard Sales Company Medical Plan, Inc. (the “Plan”) is provided for general information purposes only. The Plan is sponsored by Standard Sales Company, L.P. (the “Plan Sponsor”). Participants should refer to the Plan document for more complete information. The Company’s corporate offices are in Odessa, Texas.

The Plan was effective July 1, 1989, restated effective March 1, 2017, and is a defined benefit plan available to all regular full-time employees of the Company who have completed a 30-day waiting period. Retirees are eligible upon completion of at least 10 years of service during which they were covered under the Plan. In addition, the retiree must be at least 62 years old. Eligible employees may enter the Plan on the first day of the first month following the service period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The purpose of the Plan is to provide hospital, dental, major medical, disability, and death benefits to the Company’s employees.

Funding

The Plan requires the Employer to contribute amounts necessary to fund the employee benefits provided by the Plan. Prior to June 1, 2014, employee contributions were only required for coverage of spouses and/or dependents. Effective March 1, 2015, employees may elect to participate in program wellness screenings. Participation in the program qualifies employees for a reduced rate. This provision was discontinued March 1, 2023. The Company requires employees to contribute the following per pay period to participate within the Plan. The employer determines these rates on an annual basis.

Retirees who have served 10 years of employment, at least 62 years of age, and on the insurance program for a minimum of 10 years may remain a part of the plan. If their dependents were covered for a minimum of two years, they may continue as well. For retirees who are at least 62 years old but less than 65 years of age, are required to pay COBRA rates. Once age 65, they are no longer covered by the primary insurance, but are eligible to participate in the prescription only coverage at no cost to the retiree.

A. Description of the Plan – continued

The Plan Administrator has obtained excess loss insurance which limits aggregated annual claims paid directly from Plan assets to \$195,000 per participant for years ended December 31, 2024 and 2023. Claims expense was reduced by reimbursement from insurance of \$614,889 for the year ended December 31, 2024, and was not reduced by reimbursement from insurance for the year ended December 31, 2023.

Benefit Payments

The Plan provides hospital, dental, major medical, disability, and death benefits. The maximum lifetime benefits payable under hospital and major medical is unlimited. Claim benefits are disbursed by a claims administrator selected by the Plan Administrator. All benefits automatically terminate at the end of the month in which the participant terminates employment.

Plan Expenses

All administrative expenses, including fees to the claims administrator, are paid directly by the Employer from the funds of the Plan.

B. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates

The preparation of the financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

Contributions

Employees are required to contribute to the Plan based on certain elections, at rates determined by the Plan Sponsor pursuant to salary reduction elections by the participants. The Plan Sponsor makes monthly contributions to the Plan at a rate necessary to provide for anticipated current benefits.

Payment of Benefits

Benefits are recorded when paid.

B. Summary of Significant Accounting Policies – continued

Cash and Cash Equivalents

All highly-liquid investments with a maturity of three months or less when purchased are treated as cash equivalents. At December 31, 2024 and 2023, the Plan held such investments primarily in one financial institution, which at times exceeded amounts covered by insurance provided by the U.S. Federal Deposit Insurance Corporation (“FDIC”). The Plan has not experienced any losses related to amounts in excess of FDIC limits.

Reserves for Medical Claims

The Plan reserves for medical claims incurred during the year but not paid for by the end of the plan year. At December 31, 2024 and 2023, the Plan had approximately \$336,000 and \$448,000 in reserves.

C. Tax Status

Once qualified, the Plan is required to operate in conformity with the Internal Revenue Code Section 419(e) to maintain its qualification. The Company believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (the “IRS”). The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

D. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. Upon termination of the Plan, the assets attributable to this Plan must be used for the continuance of the benefits provided by the Plan, until such monies have been exhausted.

E. Parties-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

The Plan paid certain expenses related to plan operations. These transactions are party-in-interest transactions under ERISA which are exempt from the prohibited transaction rules.

F. Postretirement Benefits

During 2024 and 2023, the plan's sponsor contributed \$378 and \$917, respectively, to fund retiree premium prescription coverage.

G. Subsequent Events

In preparing the accompanying financial statements, management has evaluated all subsequent events and transactions for potential recognition or disclosure through August 22, 2025, the date the financial statements were available for issuance.
