Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Multivac, Inc. Profit Sharing 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

Note 1. Description of the Plan

The following description of Multivac, Inc. Profit Sharing 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Multivac, Inc. (the Company or Plan Sponsor). To participate in the Plan, an employee must be age 18 or older and have completed one month of continuous service. Employees are eligible to enter the Plan on the first day of each month. Employees who are participating in the Plan are eligible for the nondiscretionary employer matching contributions and the discretionary profit sharing contribution. The Compensation Committee is responsible for oversight of the Plan. The Compensation Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state tax law. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Participants may elect to defer between 0% and 60% of their annual eligible pre-tax compensation, as defined in the Plan. Participants are also permitted to contribute Roth after-tax deferrals to the Plan. Participants may change their deferral election as of the first day of each month. Participants meeting certain criteria under the plan will have their deferral increased annually by 1%. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. Participant contributions are subject to certain IRC limitations.

For the year ended December 31, 2024, the nondiscretionary employer matching contribution was equal to 100% of each participant's elective deferral on the first 3% of the participant's annual compensation and 50% of each participant's deferral on the next 4% of the participant's compensation.

The Company may also make a discretionary profit sharing contribution. For purposes of the discretionary contribution, compensation does not include bonuses, commissions or overtime pay. No discretionary profit sharing contribution was made for the 2024 Plan year.

Participants have the option of directing their contributions, the allocations of the nondiscretionary employer matching contribution, and the employer discretionary profit sharing contribution to various registered investment company funds and an interest-bearing cash fund managed by Fidelity Management Trust Company.

Participant accounts: Each participant's account is credited with the participant's salary deferral contribution and nondiscretionary employer matching contribution and allocations of: (a) the employer's discretionary profit sharing contribution, if any, and (b) Plan earnings, and is charged with an allocation of administrative expenses. Allocation of the discretionary profit sharing contribution, if any, is based on the ratio of the participant's eligible compensation to the total compensation of all eligible participants for the Plan year. Plan earnings and administrative expenses are allocated based on participant account balances, as defined by the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the vested participant's account.

Forfeitures: Forfeitures are used to reduce future employer contributions. No forfeitures of nonvested discretionary profit sharing contributions were used to reduce nondiscretionary employer matching contributions for the year ended December 31, 2024. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5,876 and \$4,545, respectively.

Note 1. Description of the Plan (Continued)

Vesting: Participants are immediately 100% vested in their salary deferral contributions, the nondiscretionary employer matching contributions, rollover contributions and earnings thereon. Vesting in the Company's discretionary profit sharing contributions is based on a graduated vesting schedule. Participants with one year of service are 20% vested. Vesting increases 20% each year. Participants are 100% vested when they reach five years of service. Years of service are based on whole years beginning with the participant's date of employment.

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. These transactions are treated as transfers between the investment fund and the participant notes receivable fund. The terms of the notes receivable range from one to five years unless the note receivable is for the purchase of the employee's principal residence, in which case it may be repaid over a 10-year period. The notes receivable are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan Administrator. The interest rates ranged from 4.25% to 9.50% for all outstanding loans at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

Payment of benefits: Participants may receive their benefits in the form of a lump-sum amount equal to the value of his or her vested account or elect to receive installment payments upon reaching retirement age. The Plan also has special provisions covering death and disability. Additionally, the Plan allows for withdrawals to be made from a participant's account once he or she reaches 59½. Participants meeting specific requirements noted in the Plan document may also take a hardship distribution.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Contributions: Contributions from Plan participants and the nondiscretionary employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation. Employer discretionary profit-sharing contributions are recorded in the year in which the employees' underlying service occurred.

Allowance for credit losses: The measurement of expected credit losses under the current expected credit loss (CECL) methodology is applicable to financial assets measured at amortized cost, which include employer and participant contributions receivable. An allowance for credit losses under the CECL methodology is determined using the loss-rate approach and measured on a collective (pool) basis when similar risk characteristics exist. Where financial instruments do not share risk characteristics, they are evaluated on an individual basis. The CECL allowance is based on relevant available information, from internal and external sources, related to past events, current conditions and reasonable supportable forecasts. Management recorded no allowance for credit losses as of December 31, 2024 and 2023, as all amounts were determined to be fully collectable.

Note 2. Summary of Significant Accounting Policies (Continued)

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Compensation Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for a discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Payment of benefits: Benefits are recorded when paid.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make the scheduled repayments, and the Plan Administrator deems the participant to be in default, the participant's note receivable is reduced and a benefit payment is recorded based on the terms of the Plan.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, schedule H, line 4i—schedule of assets (held at end of year).

Expenses: Certain expenses of the Plan are paid by the Plan Sponsor and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable from participants, which are charged directly to the participant's account as well as certain recordkeeping fees paid by the Plan. Investment-related expenses are included in net appreciation of fair value of investments.

The trustee also certified to the completeness and accuracy of \$9,697,040 of net appreciation in fair value of investments, \$3,188,260 of interest and dividends related to the aforementioned Plan assets, and \$70,359 of interest income on notes receivable from participants for the year ended December 31, 2024.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Note 4. Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Investments in registered investment companies are valued at the daily closing price as reported by the fund. Registered investment company funds held by the Plan are open-end registered investment company funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment company funds held by the Plan are deemed to be actively traded.

Interest-bearing cash: Interest-bearing cash is valued at cost, which approximates fair value.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers between levels and no transfers in or out of Level 3.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances.

Note 6. Related-Party and Party-in-Interest Transactions

Certain Plan investments are shares of registered investment companies and a money market fund managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Fidelity Management Trust Company totaled \$36,317 for the year ended December 31, 2024.

Note 7. Income Tax Status

The plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Subsequent Events

Management has evaluated and disclosed subsequent events up to and including August 25, 2025, the date the financial statements were available to be issued.
