NOTE A – DESCRIPTION OF PLAN

The following description of the AKRS Equipment Solutions Inc. (Employer and Plan Administrator) 401k Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was effective January 1, 1995. The Plan is a defined contribution plan for the benefit of its employees who have attained age 18 and completed 1 month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute a certain percent of their compensation, as defined by the Plan, and as allowed by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. AKRS retains a discretionary right to contribute to the Plan a matching contribution proportionate to the elective contributions made by participants. For the Plan year end, AKRS elected to make matching contributions equal to 50 percent of the aggregate salary reduction contribution, to the extent the aggregate salary reduction contribution does not exceed 8 percent of compensation. Effective January 1, 2020, the Plan added an automatic enrollment feature, whereby all newly eligible participants are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 8% of eligible compensation. Additionally, the Plan includes an auto-escalation feature in which deferral percentages for employees who are automatically enrolled into the Plan increase 1% annually on the anniversary of the participant's date of hire.

Participant's Accounts

Each participant's account is credited with the participant's contributions (including rollovers) and allocations of (a) the Employer's contributions and, (b) Plan earnings (losses) on the participant's and Employer's contributions, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions (including rollovers) plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on the following schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates determined by the Administrator based on the prevailing interest rates charged by person in the business of lending money for loans which would be made under similar circumstances. Interest rates for notes receivable for the years ended December 31, 2024 and 2023 ranged from 4.25% to 9.50%. Principal and interest are repaid through payroll deductions, if available.

Payment of Benefits

Upon retirement, termination of service, disability or death, a participant (or his or her beneficiary) may elect to receive the vested portion of his or her account. In addition, participants may elect in-service distributions, as defined by the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, remaining forfeited non-vested accounts were not significant. During the years ended December 31, 2024 and 2023, approximately \$127,500 and \$47,000 in forfeitures were used to reduce employer contributions. These accounts were used or will be used to reduce future employer contributions.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates

Management uses estimates and assumptions in preparing these financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the reported additions to and reductions from net assets. Actual results could vary from estimates used.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is measured at the end of the year if there is an active market for the investment. For investments with no quoted market price, fair value is determined based on the yields currently available on similar instruments. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative fees and expenses of operating and maintaining the Plan may be paid out of the Plan's assets unless paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements.

Income Taxes

Management evaluated the Plan’s tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

Subsequent Events

The Plan has evaluated subsequent events through August 8, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, the Plan amended the adoption agreement to increase the minimum age requirement for employee eligibility from 18 to 20 years of age.

NOTE C – INFORMATION CERTIFIED BY FIDELITY MANAGEMENT TRUST COMPANY (FIDELITY)

NOTE D – FAIR VALUE MEASUREMENTS

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. There is a hierarchy of three levels of inputs that may be used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described below:

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: The shares of mutual funds are actively traded in a public exchange and the quoted prices are readily available. These quoted prices are used to determine the fair values of mutual fund shares held by the plan at year-end.

NOTE E – PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE F – RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds and registered investment companies managed by Fidelity Investments. Fidelity is the trustee/custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Recordkeeping fees paid to Fidelity amounted to \$83,492 and \$85,641 for the years ended December 31, 2024 and 2023, respectively.

NOTE G – INCOME TAX STATUS

The Plan has adopted a pre-approved plan document. The pre-approved plan document has received an opinion letter from the IRS dated June 30, 2020 as to the pre-approved plan document's qualified status. The pre-approved plan document's opinion letter has been relied upon by this Plan. Although the Plan has amended the pre-approved plan document, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for periods after December 31, 2021.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of AKRS Equipment Solutions Inc. 401k Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management has obtained a certification from Fidelity Management Trust Company (Fidelity) as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

NOTE A – DESCRIPTION OF PLAN

The following description of the AKRS Equipment Solutions Inc. (Employer and Plan Administrator) 401k Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was effective January 1, 1995. The Plan is a defined contribution plan for the benefit of its employees who have attained age 18 and completed 1 month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute a certain percent of their compensation, as defined by the Plan, and as allowed by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. AKRS retains a discretionary right to contribute to the Plan a matching contribution proportionate to the elective contributions made by participants. For the Plan year end, AKRS elected to make matching contributions equal to 50 percent of the aggregate salary reduction contribution, to the extent the aggregate salary reduction contribution does not exceed 8 percent of compensation. Effective January 1, 2020, the Plan added an automatic enrollment feature, whereby all newly eligible participants are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 8% of eligible compensation. Additionally, the Plan includes an auto-escalation feature in which deferral percentages for employees who are automatically enrolled into the Plan increase 1% annually on the anniversary of the participant's date of hire.

Participant's Accounts

Each participant's account is credited with the participant's contributions (including rollovers) and allocations of (a) the Employer's contributions and, (b) Plan earnings (losses) on the participant's and Employer's contributions, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions (including rollovers) plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on the following schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates determined by the Administrator based on the prevailing interest rates charged by person in the business of lending money for loans which would be made under similar circumstances. Interest rates for notes receivable for the years ended December 31, 2024 and 2023 ranged from 4.25% to 9.50%. Principal and interest are repaid through payroll deductions, if available.

Payment of Benefits

Upon retirement, termination of service, disability or death, a participant (or his or her beneficiary) may elect to receive the vested portion of his or her account. In addition, participants may elect in-service distributions, as defined by the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, remaining forfeited non-vested accounts were not significant. During the years ended December 31, 2024 and 2023, approximately \$127,500 and \$47,000 in forfeitures were used to reduce employer contributions. These accounts were used or will be used to reduce future employer contributions.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates

Management uses estimates and assumptions in preparing these financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the reported additions to and reductions from net assets. Actual results could vary from estimates used.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is measured at the end of the year if there is an active market for the investment. For investments with no quoted market price, fair value is determined based on the yields currently available on similar instruments. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative fees and expenses of operating and maintaining the Plan may be paid out of the Plan's assets unless paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements.

Income Taxes

Management evaluated the Plan’s tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

Subsequent Events

The Plan has evaluated subsequent events through August 8, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, the Plan amended the adoption agreement to increase the minimum age requirement for employee eligibility from 18 to 20 years of age.

NOTE C – INFORMATION CERTIFIED BY FIDELITY MANAGEMENT TRUST COMPANY (FIDELITY)

NOTE D – FAIR VALUE MEASUREMENTS

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. There is a hierarchy of three levels of inputs that may be used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described below:

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: The shares of mutual funds are actively traded in a public exchange and the quoted prices are readily available. These quoted prices are used to determine the fair values of mutual fund shares held by the plan at year-end.

NOTE E – PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE F – RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds and registered investment companies managed by Fidelity Investments. Fidelity is the trustee/custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Recordkeeping fees paid to Fidelity amounted to \$83,492 and \$85,641 for the years ended December 31, 2024 and 2023, respectively.

NOTE G – INCOME TAX STATUS

The Plan has adopted a pre-approved plan document. The pre-approved plan document has received an opinion letter from the IRS dated June 30, 2020 as to the pre-approved plan document's qualified status. The pre-approved plan document's opinion letter has been relied upon by this Plan. Although the Plan has amended the pre-approved plan document, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for periods after December 31, 2021.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.
