## ***Auditor's Responsibilities for the Audit of the Financial Statements***

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. **NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Linklaters LLP 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all U.S. employees of Linklaters LLP (the Company or the Employer) except for associate attorneys. Employees become eligible for participation in elective salary deferral contributions on their employment commencement date if they have attained the age of 21. Employees become eligible to participate in the employer non-elective discretionary contributions (Employer Contribution) when they complete one year of service as defined in the Plan. Employees will also need to be employed by the Company on the last day of the plan year to be eligible to receive additional discretionary contribution (Additional Contribution) and/or Employer Contribution (collectively, Company's contributions).

Plan transfers in of \$191,854 are the result of newly elected partners transferring from the Linklaters LLP 401(k) Plan for Associates to the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Participants may elect to contribute not less than 1% and not more than 70% of compensation, as defined, subject to certain limitations, as a reduction of salary. Employees are automatically enrolled at a 7% deferral rate upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time. The Plan allows employees who attained age 50 by year end to make catch-up contributions up to \$7,500 in 2024. The Plan also allows for Roth elective deferrals. On the first of May each year, the Plan processes automatic increase rate is 2% up to a maximum of 15%.

The Employer may make an Additional Contribution to be determined annually equal to a uniform percentage of each participant's deferred compensation. Participants must work 1,000 hours in order to receive an allocation of the contribution. There was no Additional Contribution for the year ended December 31, 2024.

The Employer may also make an Employer Contribution on behalf of each group of participants, as defined by the plan document. To the extent necessary, the Employer shall contribute to the Plan the amount necessary to provide the top-heavy minimum contribution. This amount, if any, shall be deemed an employer non-elective contribution. The Employer approved \$2,277,006 of such contributions for the year ended December 31, 2024.

The Plan provides that participants may direct the investment of their contributions into various investment options offered by the Plan. Company contributions will follow the participants' investment instructions.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) plan earnings, and (c) forfeitures of employer contributions, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

**NOTE 1 - DESCRIPTION OF THE PLAN (Continued)**

Vesting: Each participant has a non-forfeitable right to 100% of the value of his/her salary reduction contributions and rollover contribution accounts. For any participants who terminated employment prior to January 1, 2016, he/she shall have a vested interest in his/her Employer Contribution account according to the following vesting schedule:

<u>Years of Service</u>	<u>Vested Interest</u>
1	20%
2	40%
3	60%
4	80%
5	100%

Effective January 1, 2016, a participant who is employed on or after January 1, 2016 is 100% vested in his/her Company's contributions accounts immediately. A participant is fully vested in his/her Employer Contribution if he/she dies or becomes disabled prior to the termination of employment.

Payment of Benefits: The plan administrator shall direct the trustee to distribute to a participant or such participant's beneficiary any amount to which the participant is entitled under the Plan in either a one lump-sum payment or in monthly, quarterly, semiannual, or annual payments. In connection with the merger of the Linklaters LLP Money Purchase Pension Plan into the Plan, the Plan was amended to add a Qualified Joint and Survivor Annuity payment option. Payment of benefits shall commence after any of the following occurs:

- Death of participant while an employee;
- Termination of a participant's service on or after his/her normal retirement date or by reason of disability;
- The participant's termination of employment; or
- Approval of in-service distribution.

Notes Receivable from Participants (Participant Loans): Participants may borrow from their fund accounts up to 50% of their vested account balance but not more than \$50,000 subject to certain limitations. Such loans bear interest at the prime rate plus 1% and are subject to certain restrictions as further defined in the Plan. All loans shall be repaid under a fixed schedule in substantially equal installments over a period not to exceed five years.

Forfeitures: Forfeitures of employer contributions are used to offset future employer contributions or administrative expenses of the Plan.

Retirement: Normal retirement age is the date on which the participant attains age 65.

Plan Expenses: Certain administrative expenses are paid by the plan sponsor. Plan expenses paid by the Plan consist primarily of loan origination fees associated with notes receivable from participants, and record keeping and investment management fees.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through August 25, 2025, which is the date the financial statements were available to be issued.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payments of Benefits: Benefits are recorded when paid.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, and credit risks as well as risks associated with global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Mutual Fund Fees: Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees, which are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940, are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity and thus not separately identifiable as an expense.

**NOTE 3 - RIGHTS UPON PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan holds shares of mutual funds managed by Charles Schwab Investment Management Inc. (Schwab), an affiliate of Schwab Retirement Plan Services and Charles Schwab Trust Bank, the Plan's recordkeeper and custodian, respectively; therefore, these transactions and the Plan's payment of record keeping fees and investment management fees to Schwab qualify as party-in-interest transactions. These transactions, as well as mutual fund fees charged against the Plan's investment earnings described in Note 2, also qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company.

**NOTE 6 - TAX STATUS**

The IRS issued an opinion letter dated September 21, 2020 indicating that the prototype plan document adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the prototype plan document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

GAAP require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
