**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of First State Bank of Louise Employee Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits - modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of First State Bank of Louise Employee Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Emphasis of Matter - Basis of Accounting**

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of First State Bank of Louise Employee Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1. Plan description

The following description of the First State Bank of Louise Employee Savings Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees who are age 21 or older and have completed 90 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employee contributions

Each year, participants may contribute through deferral of their earned income, up to 90% of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer contributions

For the 2023 and 2024 Plan years, the plan sponsor provided a safe harbor matching contribution equal to 100% of employee contributions up to 3% of compensation plus 50% of employee elective deferrals that exceed 3% of compensation for the Plan year, but do not exceed 5% of compensation.

Participant accounts

The Plan currently offers a fully-benefit responsive investment contract, mutual funds and self-directed brokerage accounts as investment options for participants. Each participant's account is credited with the participant's contribution and allocations of Plan earnings and the employer's contribution. Allocations are based on participant earnings or account balances, as defined. Each participant is entitled to the benefit that can be provided from his or her vested account.

Vesting

Participants are immediately vested in employee and employer safe harbor contributions plus actual earnings thereon. Vesting in the plan sponsor's contribution portion of their accounts is based on years of continuous service. A participant is fully vested in employer discretionary matching and profit sharing contributions after six years of credited service.

Forfeitures

Forfeited accounts may be used to offset future employer contributions or pay administrative expenses. At December 31, 2024 there were no forfeited non-vested accounts. At December 31, 2023, the balance of forfeited non-vested accounts was \$51. During the year ended December 31, 2024, \$52 of plan expenses were paid with forfeited accounts.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum of \$50,000. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Payments of benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of his or her account, or installments over a period of time, not to exceed the participant's life expectancy.

For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution, if the vested interest is less than \$5,000. For vested interests greater than \$5,000, the participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installments over a reasonable period of time, not to exceed the participant's life expectancy.

The Plan also allows for in service withdrawals in limited circumstances, as defined by the Plan.

2. Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared using the modified cash basis of accounting. This basis differs from accounting principles generally accepted in the United States of America in that contributions and interest income are recognized when received and expenses are recorded when paid or deducted from the Plan.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment valuation and income recognition

The Plan's investments are stated at fair value based on quoted market prices, except fully benefit-responsive investment contracts, which are stated at contract value. Shares of registered investment companies are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest income, dividends, and capital gains are recorded on the cash basis.

Payment of benefits

Benefit payments to participants are recorded upon distribution.

Administrative expenses

Participant loan fees or transaction expenses are deducted from loan or distribution proceeds, as applicable, or are charged directly to the participant's account. Certain administrative expenses incurred in connection with the operation of the Plan have been paid by the Company and are excluded from these financial statements.

Use of estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Date of management's review

Management has evaluated subsequent events through August 20, 2025, the date the financial statements were available to be issued. No additional disclosures or modifications were deemed necessary.

3. Certified investment information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net increase (decrease) in fair value of investments and interest and dividend income for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians of the Plan.

4. Investments

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The three levels of the fair value hierarchy are described below.

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; or other inputs that are observable or can be corroborated by observable market data for substantially the full terms of the assets or liabilities.

*Level 3* - Inputs to the valuation methodology are unobservable.

The Plan's investments in mutual funds and self-directed brokerage accounts are based on quoted market prices in active markets.

5. Fully benefit-responsive investment contracts

The Plan has a fully benefit-responsive group annuity contract with an insurance company totaling \$154,134 and \$548,510 as of December 31, 2024 and 2023, respectively. The Key Guaranteed Portfolio Fund is issued by Empower Annuity Insurance Company of America, and provided to the Plan as a general account product. The insurance company is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: premature termination of the contract by the Plan, plant closings, layoffs, plan termination, bankruptcy, mergers, and early retirement incentives. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. The insurance company may not terminate the contract at an amount less than contract value.

6. Tax status

The Plan sponsor has adopted a non-standardized pre-approved plan and is relying on the plan sponsor's IRS opinion letter for qualification. In the plan sponsor's opinion letter dated June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

7. Party-in-interest transactions

Empower Annuity Insurance Company of America and Empower Trust Company, LLC are the custodians of the Plan's assets. As discussed in Note 5, the Key Guaranteed Portfolio Fund is issued by Empower Annuity Insurance Company of America and, therefore, these transactions qualify as party-in-interest transactions. Plan assets also include notes receivable from participants. These transactions also qualify as party-in-interest transactions. Investment fees and expenses associated with Plan administration are paid to certain parties-in-interest. All of these transactions are exempt from the prohibited transactions rules under ERISA.

8. Plan administration

Certain administrative functions are performed by officers or employees of the employer. No such officer or employee receives compensation from the Plan.

9. Plan termination

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

10. Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

11. Subsequent events

Effective August 1, 2025, the Plan was amended to allow for in-plan Roth rollover contributions and in-plan Roth rollover transfers.
