We have performed audits of the financial statements of Emergency Radio Service, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Notes to Financial Statements

Note 1. Plan Description

The following description of the Emergency Radio Service, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a safe harbor defined contribution plan covering substantially all employees of Emergency Radio Service, LLC, ERS Tower LLC d/b/a Mission 1 Communications, Aircraft Charter Services and Goshen Air Center, Inc. (collectively, the Company) with three months of service that are not subject to exclusion based on a written agreement or non-resident alien. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During the year ended December 31, 2024, Aircraft Charter Services and Goshen Air Center were sold to unrelated parties and ceased participation in the Plan.

Contributions: Each year, participants may contribute a percentage of their annual pre-tax compensation, as defined by the Plan agreement. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions from participants and the matching contributions from the employer are recorded in the year in which the participant's contributions are withheld from compensation.

For the year ended December 31, 2024, the Company contributed amounts as a safe harbor matching contribution equal to 100% on the first 4% of compensation that a participant contributes to the Plan. The Company may also make an additional discretionary matching contribution or a profit-sharing contribution to the Plan for participants employed on the last day of the Plan year-end. For the Plan year ended December 31, 2024, the Company did not make any additional discretionary or profit-sharing contributions to the Plan. Company contributions are allocated in a manner similar to participant contributions. Contributions are subject to certain limitations.

Contributions from participants and the matching contributions from the employer are recorded in the year in which the participant's contributions are withheld from compensation.

Participant accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contribution and (b) Plan earnings and charged an allocation of certain administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Notes receivable from participants: Participants may borrow funds from their account at a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their account balance or \$50,000, which is reduced by the highest outstanding note balance attributable to the participant during the 12-month period immediately prior to the new note application date. The notes are collateralized by the balance in the participant's account and will bear interest at a reasonable rate, which is based on rates charged for similar types of notes by other lenders. Principal and interest are paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans (if material) are treated as distributions based upon the terms of the Plan document.

Notes to Financial Statements

Note 1. Plan Description (Continued)

Vesting: Participants are immediately vested in their voluntary contributions, discretionary employer match contributions and safe harbor match contributions plus actual earnings thereon. Vesting in the employer profit-sharing contributions is based on years of continuous vesting service, as defined by the Plan agreement. A participant is 100% vested in the employer profit-sharing contributions after three years of credited service.

Payment of benefits: Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested account or regular periodic payments over a specified period of time, not to exceed the life expectancy of the participant or the joint life expectancy of the participant and the participant's beneficiary. In addition, participants may make withdrawals of vested funds upon reaching a normal retirement age of 65, an early retirement age of 59.5 or by determination that a financial hardship, as defined by the Plan Agreement, has been incurred.

Benefit payments are recorded when paid.

Forfeited accounts: Forfeitures of the employer's contributions will be used to reduce future employer matching contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, the Plan had no available forfeited non-vested accounts. No forfeitures were used to reduce employer contributions or plan administrative expenses for the year ended December 31, 2024.

Administration of Plan assets: Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative expenses are paid by the Plan sponsor.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan trustees determine the Plan's valuation policies utilizing information provided by the custodian. See below for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note 2. Significant Accounting Policies (Continued)

Fair value measurements: The fair value framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Shares of pooled separate accounts: Valued at the net asset value (NAV) of shares held by the insurance company in their pooled accounts at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Subsequent events: The Company has evaluated subsequent events for potential recognition and/or disclosure through August 19, 2025, the date the financial statements were available to be issued.

Note 5. Guaranteed Interest Account

The Plan entered into a fully benefit-responsive investment with Standard. Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged to participant withdrawals and administrative expenses.

Standard is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a monthly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the Plan's ability to transact at contract value, but these are primarily limited to termination of the Plan contract with Standard. The Plan administrator does not believe that the termination of the contract, which could limit the Plan's ability to transact at contract value, is probable.

For the year ended December 31, 2024, the average crediting rate was 2.16%.

Note 6. Related-Party Transactions

Certain Plan investments are managed by Standard. Standard provides services to the Plan; therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for the year ended December 31, 2024, amounted to approximately \$6,700.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 8. Income Tax Status and Uncertain Tax Positions

The Plan has adopted a non-standardized preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

The Plan's administrator has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state or local tax authorities for years before 2021.

Note 9. Delinquent Contributions

During the year ended December 31, 2024, the Company inadvertently failed to deposit \$10,266 of participant contributions within the required time frame as stated by the United States Department of Labor (DOL). The DOL considers late deposits to be prohibited transactions. The Company plans to correct the Plan for lost earnings during the year ended December 31, 2025. Additionally, the Company intends to complete the Form 5330 and pay the applicable excise tax, which will be paid from Plan Sponsor assets and not assets of the Plan.
