Note 1. Description of the Plan

The following description of Imperative Logistics Group, LLC 401(k) Plan (fka Magnate Holdings, LLC 401(k) Plan) (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator. Effective May 6, 2024, the Plan name changed to Imperative Logistics Group LLC 401(k) Plan.

General

The Plan is a defined-contribution plan sponsored by Imperative Logistics Group, LLC (fka Magnate Holdings, LLC) (Company) for the benefit of its full-time employees, scheduled to work > 1,000 hours per year, who are age 18 or older. Imperative Worldwide, LLC (fka Magnate Worldwide, LLC), Trump Card Holdings, LLC, Masterpiece International Limited and Masterpiece Security Group, LLC are participating employers of the Plan. Effective May 6, 2024, the Plan sponsor name changed to Imperative Logistics Group LLC and the participating employer name changed to Imperative Worldwide LLC. A new participating employer, Imperative Logistics, LLC, was also added on May 6, 2024. Employees can begin participation on the beginning of each month upon meeting eligibility requirements. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Principal Trust Company and Principal Life Insurance Company (Principal) serves as Plan custodians. Hunter Benefits Consulting Group, Inc. (Hunter Benefits) serves as the recordkeeper of the Plan. Members of the Company's management serve as trustees of the Plan.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 75% of eligible compensation up to the maximum allowed by law. Through the Qualified Automatic Contribution Arrangement (QACA), the Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 4% of eligible compensation unless they elect otherwise. Effective May 1, 2024, the Plan was amended to increased automatic enrollment percentage from 4% to 6% for newly enrolled participants. Roth and rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company may make a discretionary non-elective contribution and/or matching contribution as determined annually by the Company's Board of Directors. For 2024, the Company elected to make an employer matching contribution of 50% of a participant's deferral on the first 6% of eligible compensation. For 2023, the Company elected to make an employer matching contribution of 50% of a participant's deferral on the first 4% of eligible compensation. Contributions are subject to certain limitations.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of credited service. Participants are 100% vested in Company contributions after five years of credited service based on an annual 20% vesting schedule starting in the participant's first year of service. The non-vested balance is forfeited upon termination of service. Forfeitures are used to reduce Company contributions.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 reduced by the participant's highest outstanding loan balance in the previous 12 months or 50% of their vested account balance. Participants may only have one loan outstanding at any given time. Loan terms may not exceed five years unless used for the purchase of a primary residence, in which case the repayment period may not exceed 15 years. The loans are collateralized by the balance in the participant's account and bear interest at prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the vested value of his/her account. Withdrawals other than for termination are permitted under certain circumstances provided by the Plan. Partial withdrawals are also allowed under the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,369 and \$245, respectively. During 2024 and 2023, approximately \$64,600 and \$51,000, respectively, of forfeitures were used to reduce the Company's contributions.

Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end. Pooled separate accounts are valued at estimated fair value as provided by Principal Trust Company utilizing quoted market prices of the underlying mutual funds on the last business day of the Plan year. Pooled separate accounts have no restrictions and redemptions are allowed daily.

The Plan's interest in the Morley Stable Value Fund is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year end. The investment objective is to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile and liquidity for benefit-responsive payments. Redemption frequency is daily.

The Plan's interest in the collective investment trusts are valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year end. The collective investment trusts provide for daily redemptions with no advance notice requirement. The investment strategy of the income fund is to seek current income, and as a secondary objective capital appreciation. The goal of the target date funds are to seek total return consisting of long-term growth of capital and current income, consistent with the investment strategy of an investor who is expected to retire in that respective year. Collective Investment Trusts have no restrictions and redemptions are allowed daily.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a prototype retirement plan and custodial document sponsored by CCH incorporated, DBA ftwilliam.com. The Plan has not been submitted to the Internal Revenue Service (IRS) for an individual determination letter as the non-standardized prototype document has a favorable opinion letter from the IRS. The Plan has been amended since the prototype received their favorable opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Custodians

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust Company and Principal Life Insurance Company, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets held at year end as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. There are no Level 2 investments held. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 3 investments held by the Plan.

Note 5. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invests in certain funds of the Plan custodian. The Plan paid \$138,147 and \$146,781 of fees to Principal during 2024 and 2023, respectively. The Plan paid Hunter Benefits for recordkeeping services of approximately \$12,000 and \$10,714 during 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

The Plan also holds an expense reimbursement account in which credits received are used to pay Embree Financial Group advisory fees. Credits used during the years ended December 31, 2024 and 2023 were approximately \$74,300 and \$72,600, respectively. Unused credits as of December 31, 2024 and 2023 were \$19,842 and \$19,500, respectively.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7. Nonexempt Transactions

Defined-contribution plans are required to remit employee contributions and loan repayments to the Plan as soon as they can be reasonably segregated from the employer's general assets.

For the year ended December 31, 2024, participant contributions for 2024 pay dates totaling \$4,503 were deposited late but were deposited to the Plan by December 31, 2024. Participant contributions for 2024 pay dates totaling \$1,847 were deposited in January and February 2025. Participant loan repayments of \$519 were also remitted late.

For the year ended December 31, 2023, participant contributions for 2023 pay dates totaling \$1,185 were deposited late but were deposited to the Plan by December 31, 2023. Participant contributions for 2023 pay dates totaling \$8,160 were deposited in January and March 2024.

Note 8. Subsequent Events

Subsequent events have been evaluated through August 5, 2025, which is the date the financial statements were available to be issued.
