In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date of the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.



In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of asset (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

(1) Description of plan

The following description of the Dellinger Group Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions, which is available from the Plan administrator.

General - The Plan was formed on November 1, 1989 by merger and consolidation of the Profit Sharing Plans sponsored by Dellinger Group entities. Dellinger Management Services, LLC is the Plan’s primary sponsor and administrator. Participating employers are Dellinger Management Services, LLC, Chemical Products Corporation, and New Riverside Ochre Company, Inc. (collectively – the “Employers”). The Plan is a defined contribution plan covering all employees of the Employers who have completed one year of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan is administered by the Administrative Committee (“Committee”), which consists of senior officers from the Employers. The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

In June 2024, Chemical Products Corporation permanently closed its plant and terminated a large portion of their workforce. This reduction in force event was deemed to be a partial plan termination under the IRC. Accordingly, the terminated participants’ account balances became 100% vested at the time of termination. Participants terminated as a result of a reduction in force are eligible to take distribution of their profit-sharing account balance.

Contributions - All employees that are age 21 or older are eligible to participate in making employee deferrals to the Plan after completion of a two month period in which they have completed one hour of service. Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, subject to annual limits. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. The Plan has auto-enrollment provisions whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at six percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Employers make a safe harbor employer matching contribution at one hundred percent of the first one percent of employee deferrals plus fifty percent of the next five percent of employee deferrals. Participants will be eligible for the safe harbor employer matching contribution after two months of service, and safe harbor employer matching contribution will be one hundred percent vested after two years of service. The safe harbor matching contribution was \$250,366 for the year ended December 31, 2024.

The Employers also make discretionary profit sharing contributions, as defined below. All employees are eligible to participate in the profit sharing contribution after completion of a twelve month period in which they have completed one hour of service, and must be employed on the last day of the year or separated from employment during the year due to death, disability, or retirement. Employer profit sharing contributions are allocated to eligible participants based on their compensation in relation to their employer’s total eligible compensation.

Chemical Products Corporation and New Riverside Ochre Company, Inc. contribute an amount equal to the lesser of the following two amounts:

- (a) An amount equal to fourteen percent of defined net income of the employer in excess of certain stated amounts.
- (b) The maximum amount deductible by the employer for such plan year under Internal Revenue Code Section 404(a)(3).

(1) Description of plan - continued

Contributions – continued - In addition to this calculation, Chemical Products Corporation and New Riverside Ochre Company, Inc. have the right to contribute an additional employer contribution based upon management's discretion.

Dellinger Management Services, LLC contributes an amount determined by the Board of Directors and its members.

Participant investment account options - Participants direct the investment of all contributions into various options offered by the Plan. The Plan offers various mutual funds, and a common/collective trust fund as investment options for participants.

Participant accounts - Each participant's account is credited with the participant's contribution and an allocation consisting of (a) the employers' profit sharing contributions (if any); (b) Plan earnings; (c) forfeitures of terminated participants' non-vested accounts, and; (d) is charged with an allocation of administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participant's contributions plus actual earnings are immediately vested. Employer contributions are subject to the following vesting schedule:

Payment of benefits - Participant salary deferral contributions and employer safe harbor contributions are payable to participants or to their designated beneficiaries immediately upon termination of employment with the Employer. Employer profit sharing accounts are payable to participants upon termination of employment due to a reduction in force, reaching normal retirement age, as defined in the Plan, disability, or to participant's designated beneficiaries upon death. Distribution of participant and employer contributions shall be in the form of a lump sum distribution or a rollover distribution. In-service distributions are not allowed under the Plan.

The Plan may make force-out distributions for terminated participants with vested account balances of less than \$5,000, including the vested portion of the participant's employer profit sharing account.

Forfeitures - Forfeiture of a participant's employer contribution account occurs when the participant incurs five consecutive one-year breaks in service or receives a complete distribution of the vested portion of the participant's account. Forfeitures can be utilized to reduce the safe harbor employer matching or discretionary contributions, pay plan expenses, or allocated to participants as an additional discretionary nonelective contribution. Forfeitures allocated to participants as an additional discretionary nonelective contribution are allocated to participants employed as of the last day of the year based on each participant's Plan compensation in relation to total employer Plan compensation. At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$6,000 and \$2,000, respectively. During 2024, forfeitures of approximately \$5,000 were utilized to pay Plan expenses, and none were used to reduce the employer safe harbor matching contributions.

(2) Summary of significant accounting policies

Basis of accounting - The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gains distributions from mutual funds are recorded as dividend income. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits - Benefits are recorded when paid.

Administrative expenses - Certain fees and expenses of the Plan are paid by the Employers and are not included in the statement of changes in net assets available for benefits. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

(3) Fair value measurements

FASB Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

(3) Fair value measurements - continued

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Stable value common collective trust: A stable value fund that is composed primarily of fully benefit-responsive investment contracts is valued at the NAV of units of the financial institution collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Gains and losses (realized and unrealized) included in the changes in net assets for the periods above are reported in net appreciation in fair value of investments in the statements of changes in net assets available for benefits.

(4) Information prepared and certified by the trustees

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, the trustee of the Plans, has certified that the following data included in the accompanying 2024 and 2023 financial statements and supplemental schedule are complete and accurate with respect to investments:

- Investments at fair value
- Net appreciation (depreciation) in fair value of investments
- Interest and dividends
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

(5) Plan termination

Although it has not expressed any intention to do so, the Employers reserve the right under the Plan to amend or terminate their participation and/or the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

(6) Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. At December 31, 2024 and 2023, approximately 46% and 42%, respectively, of the Plan's investments were invested in two and three investment options respectively, as elected and directed by the Plan participants.

(7) Tax status

The Internal Revenue Service has determined that the non-standard prototype Empower Retirement, LLC Defined Contribution Pre-Approved Plan is designed in accordance with applicable sections of the Internal Revenue Code (the "IRC") and informed the third party administrator of such in a letter dated November 14, 2022. The Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

(8) Related party transactions and party-in-interest transactions

Empower Trust Company and its affiliates (“Empower”) provide certain administrative services. Empower receives revenue from mutual fund service providers for services Empower provides to the funds. This revenue is used to offset certain amounts owed to Empower for its administrative services to the Plan. If the revenue received by Empower from such mutual fund service providers exceeds the amount owed under the agreements with the Plan, Empower remits the excess to the Plan’s trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of participants. The Plan received revenue sharing credits of approximately \$2,000 in 2024.

The Plan or Plan Sponsor may make payment to Empower for administrative expenses not covered by revenue sharing. The Plan made direct payments to Empower of approximately \$51,000 for the year ended December 31, 2024, that was not covered by revenue sharing. The Plan paid certain expenses related to the Plan’s operations and investment activity to various service providers. These transactions are party-in-interest transactions. The Plan Sponsor pays directly any other fees related to the Plan’s operations.
