Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Great Clips, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1. Plan Description

The following description of Great Clips, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is sponsored by Great Clips, Inc. (the Company, Employer or Plan Administrator). The Plan is a defined contribution plan covering employees of the Company who meet the eligibility requirements, except for nonresident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan's trustee is Capital Bank and Trust Company.

Eligibility: Employees are eligible to participate in the Plan after the completion of 30 days of service and obtaining the age of 21. Temporary employees are eligible after the completion of six months of service.

Participants are eligible to receive employer nonelective contributions if they are employed by the Company on the last day of the plan year.

Contributions: The Plan permits participant elective deferral contributions, including Roth deferrals, in whole increments from 1% to 100% of the participant's eligible compensation, as defined, subject to limits established by law. Participants satisfying certain criteria are eligible to make catch-up contributions to the Plan. Participants may also make rollover contributions to the Plan.

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. After the initial automatic enrollment, the contribution level will increase by 1% each year (unless a participant chooses a different level) until it reaches 6% of eligible compensation.

The Plan also allows the Company to make a safe harbor matching contribution as defined in the Plan. For the year ended December 31, 2024, the Company made a safe harbor matching contribution of 100% of participant's contributions not to exceed 2% of the participant's eligible compensation and 50% of a participant's contributions that exceed 2% of the participant's eligible compensation not to exceed 6% of compensation.

The Plan allows for discretionary nonelective contributions as defined in the Plan. For the year ended December 31, 2024, the Company did not make discretionary nonelective contributions.

Participants' accounts: Participants' accounts are credited with their participant contributions (elective deferrals, catch-up, and rollovers), safe harbor matching contributions, an allocation of employer nonelective contributions, if any, and an allocation of Plan investment results. Allocations are based on eligible participant compensation, participant account balances or specified participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participant elective deferral and rollover contributions plus actual earnings thereon are fully vested and nonforfeitable at all times. Vesting in employer safe harbor matching contributions is 100% after two years of service, with provisions for full vesting at the normal retirement date, as defined in the Plan, or upon death, retirement, or permanent disability during the term of employment. Plan contributions attributable to discretionary nonelective contributions vest on a graduated scale of 20% per year of service to 100% after five years of service, with a provision for 100% vesting at the normal retirement date, as defined in the Plan.

Note 1. Plan Description (Continued)

Notes receivable from participants: Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note repayment terms generally range from one to five years. If the proceeds from the note are used by the participant for the purchase of a primary residence, then the note term can be up to 15 years. The notes are secured by the participant's vested account balance. Such notes bear interest at the prime rate plus 1%, which generally approximates rates charged by independent commercial lenders. Principal and interest are paid through payroll deductions, no less frequently than quarterly over the term of the note. A participant may have no more than one outstanding note at one time.

Forfeitures: Forfeitures occur when a participant terminates prior to being fully vested. Forfeited amounts of terminated participants' nonvested balances are used to fund Employer contributions in the year they occur. Forfeited nonvested accounts totaled approximately \$400 and \$100 at December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, approximately \$49,000 of forfeited nonvested accounts were used to fund Employer contributions.

Benefits paid to participants: On termination of service due to death, permanent disability, retirement or termination for other reasons, the payment of benefit method depends on the vested account balance. If the vested account balance does not exceed \$1,000, a lump-sum distribution, net of tax, will be made. If the vested balance is between \$1,000 and \$7,000 and the participant does not specify whether the distribution should be paid directly to an eligible retirement plan or paid directly to the participant, the Plan Administrator can pay the distribution in a direct rollover to an individual retirement account designated by the Plan Administrator. If the vested balance exceeds \$7,000, a participant may elect to keep the vested account balance in the Plan, receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account, receive installment payments, or roll over the entire vested portion to a qualified plan or an individual retirement account. In-service withdrawals from a participant's account are available in accordance with the Plan agreement. The Plan allows for in-service distributions to participants under certain circumstances, including financial hardship.

Investment options: Participants may direct the investment of their account balance into various funds on a daily basis.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The Plan's financial statements are presented on the accrual basis of accounting.

Investment valuation and income recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by investment advisors, the trustee and other third parties. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year. Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Delinquent notes are reclassified as distributions based upon the terms of the Plan agreement. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Note 2. Summary of Significant Accounting Policies (Continued)

Notes receivable from participants are classified as an investment asset for Form 5500 reporting purposes and, accordingly, are included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

Contributions: Deferral contributions from participants and the related safe harbor matching contributions from the Company are recorded in the year in which the deferrals are withheld from employee compensation.

Benefits paid to participants: Benefits paid to participants are recorded by the Plan when paid.

Administrative expenses: Administrative expenses are shared between participants and the Company as specified in the Plan agreement. Other administrative expenses, such as audit and legal fees are paid by the Plan at the discretion of the Plan Administrator. No audit or legal fees were paid from the Plan for the year ended December 31, 2024.

Risks and uncertainties: Participants are allowed to invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities have occurred since December 31, 2024, or will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events: The Plan Administrator has evaluated subsequent events for recording or disclosure in the financial statements through August 25, 2025, the date the financial statements were available to be issued.

Note 3. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to change or discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 4. Fair Value Measurements

Accounting guidance establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Note 4. Fair Value Measurements (Continued)

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Investments in registered investment companies are valued at the unadjusted quoted market prices of the shares held by the Plan at year-end in the active market on which the individual securities are traded.

Collective trust fund: The collective trust fund is valued at the net asset value (NAV) of the shares of the funds held by the Plan at year-end, as reported by the funds' investment managers. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less liabilities. The practical expedient would not be used if it is determined to be probable that the Plan will sell the fund for an amount different from the reported NAV. The underlying assets of the collective trust fund vary by type and include primarily investment contracts.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6. Income Tax Status

The Plan adopted the nonstandardized pre-approved plan sponsored by Capital Group Retirement Plan Services. Capital Group Retirement Plan Services received an opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Related-Party and Party-in-Interest Transactions

Transactions with the trustee, Capital Bank and Trust Company, as well as other service providers, qualify as party-in-interest transactions. Certain plan investments are shares of registered investment companies managed by affiliates of Capital Bank and Trust Company. Fees paid by the Plan to the trustee, and other service providers are included in administrative expenses in the statement of changes in net assets available for benefits. During the year ended December 31, 2024, the Company paid certain administrative expenses for the Plan, which have been excluded from these financial statements. For the year ended December 31, 2024, the Plan received approximately \$40,000 in revenue sharing from registered investment companies, which is included with net appreciation in fair value of investments on the statement of changes in net assets available for benefits. Certain administrative functions are performed by employees of the Company. No such employee receives separate compensation from the Plan.

Notes receivable from participants are also considered party-in-interest transactions.
