Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Unique Vacations, Inc. 401(k) Profit Sharing Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1—Description of the Plan

The following description of the Unique Vacations, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the Plan administrator.

General – The Plan was established on August 1, 1998 and restated effective January 1, 2023 to allow participants to make Roth contributions. The Plan is a profit sharing and 401(k) Plan covering all permanent, nonunion full-time/part-time employees of Unique Vacations, Inc. (the "Company" or "Employer") who have completed one hour of credited service as defined in the Plan, excluding temporary employees whose scheduled service is less than 1,000 hours during the year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Participants are eligible for matching contributions after six months of credited service and are fully vested in three years.

The Plan is overseen by the Company's 401(k) Committee ("Committee"), which is a committee of the management of the Company. The Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance. The Plan's recordkeeping services and maintenance of participant account records are managed by Newport Trust Company (the "qualified institution").

Participants' Contributions – Participants may contribute up to 100% of eligible compensation, up to the maximum allowable by Internal Revenue Code ("IRC") limits and as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Participants are automatically enrolled into the Plan upon meeting applicable eligibility requirements at a deferral of 7.5%. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan.

Employer Contributions – Each year the Employer may make matching contributions at its discretion. For the year ended December 31, 2024, the Company elected to contribute an amount equal to 100% of the participant's elective deferral contribution, not to exceed 7.5% of the employee's annual compensation. The Company contributed approximately \$1,393,000 in employer matching contributions during the year ended December 31, 2024. The Employer may also make discretionary contributions. These contributions are made at the discretion of the Company's Board of Directors but may not exceed amounts permitted under the IRC. No discretionary contributions to the Plan were made for the year ended December 31, 2024.

Participant Investment Account Options – Upon enrollment in the Plan, a participant may direct contributions into any of various investment options. Participants may change their investment options at their discretion. Additionally, participants may select and manage their own investment options through a personal choice investment account. Participants are allowed to choose the investments of their choice, within specified limitations as defined in the Plan.

Participant Accounts – Each participant's account is credited with the participant's contribution and, if applicable, allocations of (a) the Company's matching and discretionary contributions, if any, and (b) Plan earnings (losses) and charged with participant distributions and an allocation of administrative expenses. Allocations are based on either participants' compensation or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contributions portion of their accounts plus earnings thereon is based upon years of continuous service.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance on the date of the loan. Loan terms are limited to five years; however, any loan used for the purchase of a primary residence cannot extend beyond ten years from the date of the loan. The loans are secured by the balance in the participant's account and bear interest at prime rate plus 1 percentage point. Principal and interest are paid ratably through payroll deductions. On December 31, 2024 interest rates ranged from 4.25% to 9.50% with maturities through April 2047.

Payment of Benefits – Participants are allowed in-service withdrawals of their participants' vested interest in his or her account upon attainment of early retirement age. On termination of service due to death, disability, retirement, and other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or installments as permitted for required minimum distributions as defined in the Plan.

Forfeited Accounts – On December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$90,000 and \$54,000, respectively. Forfeitures can be used to reduce employer contributions and/or to reduce Plan expenses. During the year ended December 31, 2024, approximately \$3,000 in forfeitures were used for plan expenses and approximately \$8,000 were used for employer contributions.

Note 2—Summary of significant accounting policies

Basis of Accounting – The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – Investments held by a defined-contribution plan are required to be recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value determinations are made based upon a hierarchy that prioritizes the inputs to valuation techniques. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Three levels of inputs may be used to measure fair value:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for Plan instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy, if applicable. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within the Level 1 of the valuation hierarchy.

Common Collective Trust – This investment is a public investment vehicle valued using NAV of units of a bank collective trust. NAV, as provided by the qualified institution, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the trust less its liabilities and then divided by the number of shares outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Transactions (purchases and sales) may occur daily. These investments measured using NAV practical expedient are exempt from classification under the fair value hierarchy.

Self-Directed Funds – These investments are valued at current value based on published market quotations from individual investments composing the brokerage accounts. Such assets are classified as Level 1.

The methods described above produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when paid.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Administrative Expenses – Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants and for distributions are charged directly to the participant's account and are included in administrative expenses totaling \$39,357. Investment related expenses are included in net appreciation of fair value of investments.

Newport Trust Company, (the “qualified institution”) of the Plan, has certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedule.

As of December 31, 2024 and 2023, the collective investment trust has no unfunded commitment and redemptions are processed daily with a 30-day notice period.

Note 5—Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 6—Parties-in-interest transactions

Certain Plan investments are managed by the qualified institution of the Plan, as well as Charles Schwab & Co., Inc. that manages the self-directed funds and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants.

Note 7—Tax status

The Company adopted a prototype non-standardized profit-sharing plan with a cash or deferral arrangement. The prototype plan received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan is designed in accordance with applicable sections of the IRC. The Plan has not received a determination letter specific to the Plan itself and the Plan has been amended since the prototype plan received the opinion letter; however, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The Company believes the Plan has no income subject to unrelated business income tax and, therefore, continues to be tax exempt.

Note 7—Tax status (continued)

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8—Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9—Subsequent events

The Plan has evaluated subsequent events through August 5, 2025, which is the date the financial statements were available to be issued.
