We have performed audits of the accompanying financial statements of OBXtek, Inc. 401(k) Profit Sharing Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### Note 1—Description of the Plan

The following description of the OBXtek, Inc. 401(k) Profit Sharing Plan (the “Plan”) is provided for general purposes only. Participants should refer to the Plan Agreement, as amended and restated, for a more complete description of the Plan’s provisions.

*General* – The Plan was established on January 1, 2010, and was most recently restated effective June 20, 2021. The Plan is a defined-contribution plan covering substantially all the employees of OBXtek, Inc. (the “Company” or the “Plan Sponsor”). New employees may enter the Plan on their date of hire. The Plan is intended to qualify under Section 401(k) of the Internal Revenue Code (“IRC”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan’s assets are held in the custody of Empower Annuity Insurance Company of America and Empower Trust Company, LLC (“Empower”, “Custodians” or “the qualified institution”).

*Administrative Expenses* – The Plan is administered by the Plan Sponsor. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Investment management fees are paid out of Plan assets and are recorded as reductions in participant allocations. Substantially all other administrative expenses and accounting fees are paid by the Plan Sponsor.

*Participant Contributions* – Participants may contribute a percentage of their eligible compensation, as defined in the Plan, on a pre-tax basis subject to statutory limitations of the IRC. In addition, participants 50 years of age or older may elect to make a catch-up deferral contribution of up to \$7,500 for the year ended December 31, 2024. Distributions from other qualified retirement plans can also be contributed to the Plan and retained as a rollover contribution.

*Plan Sponsor Contributions* – The Plan Sponsor may make a discretionary-matching contribution to the Plan, with the amounts determined annually, not to exceed 6% of a participant’s elective deferrals. Each year the Plan Sponsor may also make a discretionary non-elective contribution to be allocated to participants based on total compensation. A participant must be employed on the last day of the Plan year, as well as complete 1,000 hours of service during the Plan year to share in the allocation of Company discretionary non-elective contributions. There were no discretionary-matching or non-elective contributions made during the year ended December 31, 2024.

The Plan Sponsor also makes safe harbor matching contributions to the Plan. For the year ended December 31, 2024, the safe harbor matching contribution is a uniform percentage of a participant’s elective deferrals, not to exceed 4% of a participant’s elective deferrals. Total safe harbor contributions totaled \$1,068,983 for the year ended December 31, 2024. For employees who perform work on certain contracts, the Plan Sponsor will make a prevailing wage contribution. The prevailing wage contribution is determined by prevailing wage laws and will offset any additional employer contributions made during the Plan year. Employees that receive a prevailing wage contribution are not eligible to receive any safe harbor contributions. Prevailing wage contributions totaled \$352,358 for the year ended December 31, 2024. Contributions are subject to certain limitations.

*Vesting* – Participants are immediately vested in their salary deferral contributions, rollover contributions, prevailing wage contributions, and safe harbor matching contributions, plus actual earnings (losses) thereon.

A participant also becomes 100% vested upon death, becoming disabled, or reaching retirement age, as defined by the Plan.

*Participant Accounts* – Individual accounts are maintained for each participant and include participants' salary deferral contributions, rollover contributions, safe harbor matching contributions, and prevailing wage contributions, plus an allocation of the Plan Sponsor's discretionary-matching contribution, if any, discretionary non-elective contribution, if any, and Plan earnings (losses), including realized and unrealized gains and losses on investments, and charged with the participants' distributions and the allocation of Plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Payment of Benefits* – On termination of service, a participant (or designated beneficiary) may elect to receive an amount equal to the value of the participant's vested interest in his account. The Plan allows for distributions upon termination of service, death, disability, attainment of age 59½, or in certain hardship situations. A participant may elect to receive a lump-sum payment, an annuity, or may rollover the value of their account into another qualified plan. In the event a participant terminates or retires and the participant's vested account balance is less than \$5,000, the balance will be paid out as a lump-sum distribution at the discretion of the Company.

The Plan also allows, in certain hardship situations as defined in the Plan, participants to withdraw from their vested account balances while actively employed. These hardship withdrawals are subject to IRC restrictions and penalties.

*Forfeitures* – As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$9,154 and \$8, respectively. Per the Plan Document, these amounts may be used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. During the year ended December 31, 2024, approximately \$325 of forfeited nonvested accounts were used to reduce employer contributions.

*Notes Receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have up to two notes outstanding during a period of 12-consecutive months. Notes must be repaid within five years unless it is for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50% with maturities through September 2035, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through monthly payroll deductions.

*Investment Options* – Upon enrollment in the Plan, a participant may direct employee and Plan Sponsor contributions in any of the investment options offered by the Plan.

**Note 2—Summary of significant accounting policies**

*Basis of Accounting* – The accompanying financial statements have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

### Note 2—Summary of significant accounting policies (continued)

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

*Investment Valuation and Income Recognition* – Investments in the Plan are reported at fair value, except for the fully benefit-responsive investment, which is reported at contract value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to the fully benefit-responsive investment contract because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

*Benefits Paid to Participants* – Benefits paid to participants are recorded when paid.

*Administrative Expenses* – Certain expenses of maintaining the Plan are paid by the Company and are, therefore, excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

### Note 3—Information certified by the Custodians (unaudited)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower, the qualified institution, has certified to the completeness and accuracy of the following data included in the accompanying financial statements:

- Investments, at fair value, investments, at contract value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

**Note 3—Information certified by the Custodians (unaudited) (continued)**

The Plan’s independent auditor did not perform auditing procedures with respect to the certified information, except for comparing such information to the related information included in the financial statements and supplemental schedule, Schedule of Assets (Held at End of Year).

**Note 4—Fair value measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. This hierarchy consists of three broad levels:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

There are no plan assets requiring the use of Level 2 or Level 3 inputs for the years presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

The following is a description of the valuation methodology used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

*Mutual Funds* – These public investment vehicles are valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and these investments are classified within Level 1 of the valuation hierarchy.

The Plan believes its valuation method is appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5—Guaranteed interest contract, fully benefit-responsive investment

The Plan has a group annuity contract with Great-West Life & Annuity Insurance Company that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract since the contract was determined to be fully benefit-responsive. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. The guaranteed interest account does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### Note 6—Parties-in-interest transactions

Certain Plan investments are shares of a guaranteed interest account managed by Great-West Life & Annuity Insurance Company and Great-West Trust Company, LLC; therefore, these transactions qualify as parties-in-interest transactions for which a statutory exemption exists. Fees paid to the Custodians totaled \$145,455 for the year ended December 31, 2024.

Notes receivables from participants qualify as parties-in-interest transactions.

### Note 7—Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become fully vested in their accounts.

**Note 8—Tax status**

The prototype plan adopted by the Plan obtained its latest opinion letter on November 14, 2022, in which the Internal Revenue Service (“IRS”) stated the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has not received an opinion letter specific to the Plan itself; however, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax and, therefore, the Plan and related trust continue to be tax-exempt.

U.S. GAAP requires Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9—Risk and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 10—Subsequent events**

In accordance with U.S. GAAP related to subsequent events, the Plan has evaluated all events subsequent through August 25, 2025, the date these financial statements were available to be issued.
