Opinion

We have audited the financial statements of Lester Electrical of Nebraska, Inc. Employee Stock Ownership Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). As discussed in Note 4 to the financial statements, the financial statements include Lester Electrical of Nebraska, Inc. common stock valued at \$5,120,388 and \$5,027,937 at December 31, 2024 and 2023, respectively, whose fair values have been estimated using an independent appraisal, in the absence of readily determinable fair values, with the assistance of management. Because of the inherent uncertainty of the valuation, the estimated values may differ significantly from the values that would have been used had a market value for the investments existed, and the differences could be material. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Notes to Financial Statements

December 31, 2024 and 2023

1. Plan Description

The following brief description of the Lester Electrical of Nebraska, Inc. Employee Stock Ownership Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established effective November 1, 1972 to enable eligible employees to benefit from common stock ownership interests in the Lester Electrical of Nebraska, Inc. (the Company). The Plan is intended to be an employee stock ownership plan (ESOP) within the meaning of Section 4975(e)(7) of the Internal Revenue Code of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act (ERISA) of 1974 as amended. The Plan was established to provide retirement benefits for the employees of the Company. GreatBanc Trust Company (GreatBanc) is the Plan's trustee.

Eligibility

Employees of the Company are eligible to participate in the Plan on January 1 or July 1 of the Plan year upon the completion of one year of service, which is defined as a consecutive twelve-month period during which the employee completes at least 1,000 hours of service with the Company.

Employer Contributions

Company contributions are discretionary and determined annually by the Board of Directors of the Company. The Company made discretionary contributions of \$89,638 and \$0 during the years ended December 31, 2024 and 2023, respectively, to help fund distribution payments.

Participant Accounts and Forfeitures

Each participant's account is credited with a) discretionary Company contributions, b) forfeiture of terminated participants' non-vested accounts, and c) Plan earnings or losses. Only those participants who are eligible employees of the Company on the last day of the Plan year and have at least 1,000 hours of service on each anniversary year of employment will receive an allocation of the Company contribution or shares of the Company's common stock forfeited. Allocations of Company contributions and forfeitures are based on a participant's eligible compensation relative to total eligible compensation. Plan earnings, including interest and dividends, and losses are allocated on the basis of actual results of the Company common stock and other Plan investments. Allocations of shares of the Company's common stock previously released by the Plan trustee was based on a participant's eligible compensation relative to total eligible compensation. All shares have been allocated. Investments are maintained in individual member accounts managed by GreatBanc.

Forfeitures of terminated non-vested account balances allocated to remaining participants at December 31, 2024 and 2023 totaled \$0 of cash and approximately 234 and 0 shares of common stock, respectively.

Vesting

A participant's interest in discretionary Company contributions and allocated Company common stock is vested based on years of completed service. A participant is 20% vested after two years of completed service and vesting increases 20% per year until a participant is 100% vested after six years of completed service. Participants terminating due to normal retirement, death, or disability will be 100% vested.

Put Option

Under Federal income tax regulations, the Company common stock that is held by the Plan and its participants and is not readily tradeable on an established market, or that is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its common stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The purpose of the put option is to ensure that participants have the ability to ultimately obtain cash for their Company common stock.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. There were 1,989 and 983 common stock shares diversified for the Plan as of December 31, 2024 and 2023, respectively.

Payment of Benefits

Distributions from the Plan will be made when a participant retires, dies, or otherwise terminates employment with the Company, as defined by the Plan. Distributions are made in cash or, if the participant elects, in the form of Company common shares plus cash for any fractional shares. The Plan requires mandatory distribution payments between \$1,000 and \$7,000 (\$5,000 prior to January 1, 2024) be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. Terminated Plan participants with an amount in excess of \$7,000 that do not timely elect a specific type of distribution will have their converted cash funds remain in the ESOP account. Distributions may be made in lump-sum or in annual installments over a term of up to five years. Distributions over \$150,000, except in cases of death or disability, must be made in annual installments. Participants may also receive in-service distributions, as permitted in the Plan document. Benefits are recorded when paid.

Voting Rights

With respect to Company common stock, GreatBanc, as trustee, is generally entitled to vote for all shares of the common stock of the Company owned by the Plan as directed by the ESOP Committee.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements. Purchase and sales of investments are recorded on a trade-date basis. Interest and dividend income is recorded on an accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Other

Substantially all administrative expenses are paid by the Company and are excluded from the Plan's financial statements. Administrative expenses related to distributions are paid from the applicable participants' accounts and are included in the Plan's financial statements.

Risk and Uncertainties

The Plan invests in Company common stock and a money market fund. These investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with the investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through August 18, 2025, noting no items requiring disclosure.

3. Administration of Plan Assets

The Plan's assets, which consist of the Company's common stock and money market funds, are held by GreatBanc, the trustee of the Plan.

Company contributions are held and managed by the trustee, as instructed by the Plan Committee, which is appointed by the Company's Board of Directors. Distributions to participants are made by the trustee.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses for the Plan are paid by the Company.

4. Investments

The Plan's investments in the Company's common stock (non-participant directed) at December 31 are presented in the following table:

During 2024 and 2023, the Plan's investments (including gains and losses on investments bought and sold as well as held during the year) in the Company's common stock appreciated (depreciated) in fair value by \$316,012 and (\$132,631), respectively.

5. Fair Value Measurement

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) terms, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Lester Electrical of Nebraska, Inc. Common Stock: Valued at fair value based upon an independent appraisal. This appraisal was based upon the discounted cash flow method. The appraiser took into account historical and projected cash flow and net income along with estimated fair value of Company assets and liabilities.

Money Market Fund: Valued at the daily closing price as reported by the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated September 28, 2011, that the Plan is qualified and the trust established under the Plan is tax-exempt, under the applicable sections of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Plan Termination

The Company reserves the right to terminate the Plan at any time, subject to the Plan provisions. Upon such termination of the Plan, participants will become 100% vested and the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code.

8. Related Party Transactions

Certain Plan investments are common stock of the Company held under the ESOP fund which is managed by GreatBanc. These transactions with the Company qualify as party-in-interest. The Plan distributed 7,659 and 16,445 shares of Company common stock during the years ended December 31, 2024 and 2023, respectively.
