Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Martin-Baker America, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 PLAN DESCRIPTION

The following description of Martin-Baker America, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Martin-Baker America, Inc. (Company). Employees are eligible to participate in the Plan on the date of hire. The Plan has an automatic salary deferral feature for employees who meet the eligibility requirements. Under the terms of this arrangement, participants are automatically enrolled at a pre-tax deferral percentage of 4% per year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants are permitted to make elective deferrals up to the maximum percentage of compensation and dollar amounts permissible under the Internal Revenue Service Code, not to exceed certain limits. Participants may also elect to contribute after-tax Roth deferrals to the plan. Contributions to the Plan are recorded in the period that payroll deductions are made from participants. Company contributions are accrued based upon the period those contributions relate to. Participants who have attained age fifty (50) by the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

In addition, the Company will make a matching contribution equal to one hundred percent (100%) of the participant's elective deferral, not to exceed four percent (4%) of the participant's compensation. At the direction of the Board of Directors, the Company may also make a discretionary contribution to the plan. There were no discretionary contributions made to the plan during the year ended December 31, 2024.

Participants may direct the investment of all contributions into various investment options offered by the Plan. The Plan offers a money market fund as well as various registered investment companies as investment options.

Participant Accounts

Each participant's account is credited with (a) the participant's contribution and related Company matching contribution, (b) an allocation of the Company's discretionary contribution, if any, and (c) investment earnings and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants may direct the investment of all contributions into various options offered by the Plan. The Plan currently offers pooled separate accounts as well as an investment contract with an insurance company sponsored by Voya Retirement Insurance and Annuity Company (Voya).

Vesting

Participants are always fully vested in their voluntary contributions, Company matching contributions, rollover contributions, and any earnings thereon. Vesting in the nonelective employer contribution portion of their account is earned in accordance with the following schedule:

Notes Receivable from Participants

Loans are issued to participants in accordance with a Participant Loan Program. Participants may borrow from their accounts a maximum equal to the lesser of \$50,000 or fifty percent (50%) of their vested account balance. Loans are secured by the vested balance in the participant's account and bear interest at 4.25% to 9.50%, which is commensurate with local prevailing rates as determined by the plan administrator at the time the loans are issued. Loans generally must be repaid within five (5) years, unless the loan is for the purchase of a primary residence. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon retirement, disability, death or termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum distribution. For minimum required distributions, participants may elect to receive either partial or installment distributions over a period of time not to exceed the participant's life expectancy. Participants with account balances of less than \$5,000 upon termination will automatically receive a lump-sum distribution. Upon reaching age fifty-nine and a half (59 ½), participants may elect to receive in-service withdrawals. The Plan also maintains a provision for hardship withdrawals.

Forfeitures Accounts

Forfeited amounts may be used to offset administrative expenses or reduce employer contributions. Cumulative forfeited non-vested amounts totaling \$-0- remained unallocated as of both December 31, 2024 and 2023.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a description of the valuation methodologies used for assets measured at fair value.

Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Administrative expenses are paid by either the Company or the Plan. Administrative expenses paid by the Plan consist primarily of administrative fees paid to the record-keeper and third party service providers.

NOTE 3 FAIR VALUE MEASUREMENTS

The Plan performs fair value measurements in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, which defines fair value as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance. ASC 820 also establishes a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The hierarchy establishes three (3) levels of inputs that may be used to measure fair value:

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs are unadjusted quoted prices in active markets for identical assets or liabilities;

Level 2 – Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or

Level 3 – unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled separate accounts: Valued at net asset value (NAV). The values of the pooled separate accounts are expressed in units as determined by valuing the underlying assets owned by the fund, minus its liabilities, and then dividing the value of the entire account by the total number of units in the plan account.

Investment Contract with Insurance Company: The investment contract with the insurance company is the Voya Fixed Account and is a part of Voya Retirement Insurance and Annuity Company's Group Annuity Contract. The fund represents a fully benefit-responsive investment contract and guarantees a fixed rate of interest. See Note 4 for valuation methodology for the investment contract with insurance company.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Voya Fixed Account (Fixed Account) is a fully benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company (Voya). Voya maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment in the Fixed Account is included in the financial statements at fair value and then adjusted to contract value of the underlying investment contract as reported to the Plan by Voya. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The contract has certain restrictions that may impact the ability to collect the full contract value. Market value adjustments and surrender charges could limit the ability of the Plan to initiate and complete a transaction at contract value. A market value adjustment is a feature of the contract that protects Voya and its clients against sudden movements in the bond markets and offsets losses if assets are sold at a loss. In addition, Voya reserves the right to terminate the contract by providing ninety (90) days written notice. The Plan's management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The credited interest rates for the Fixed Account are determined based on the performance of Voya's general account, and other factors. The Fixed Account guarantees a minimum interest rate of one percent (1%) and has a maximum interest rate of three percent (3%). Each calendar year Voya sets a guaranteed floor interest rate which is never less than the minimum guaranteed rate. The minimum guaranteed interest rate, the floor interest rate and the current credited interest rates are each expressed as an annual effective yield. Interest is credited on a daily basis, and all funds invested by the Plan in the Fixed Account receive the same credited rate. Once credited, the interest becomes a part of principal.

NOTE 5 CERTIFIED INVESTMENT INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, The Standard has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Investment and participant loan information included in the Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown on the ERISA required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA required supplemental schedule.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants will become one hundred percent (100%) vested in their accounts.

NOTE 7 TAX STATUS

The Plan adopted a volume submitter profit sharing plan sponsored by FIS Business Systems, LLC. The prototype plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The prototype plan has been amended since receiving the determination letter. The plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities held by the Plan, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 RELATED PARTY TRANSACTIONS

Certain Plan investments were managed by Voya Retirement Insurance and Annuity Company. This firm was the custodian as defined by the Plan; therefore, transactions with the custodian qualify as party-in-interest. CBIZ, Inc. is the Plan's third party administrator. There was no direct compensation paid to CBIZ by the Plan for the year ended December 31, 2024.

NOTE 10 SUBSEQUENT EVENTS

Subsequent to the plan year-end, the Company amended and restated provisions of the Plan to become effective on January 1, 2025.

Subsequent events were considered through August 20, 2025, which is the date that financial statements were available to be issued.
