Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Kamco Supply Corp. 401(k) Savings and Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (in liquidation) and 2023 (ongoing), and the related statement of changes in net assets for the year ended December 31, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Kamco Supply Corp. 401(k) Savings and Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Kamco Supply Corp. 401(k) Savings and Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter — Plan Termination and Liquidation Basis of Accounting

As discussed in Notes 1, 2 and 8 to the financial statements, the Board of Directors of the Plan approved a plan of liquidation on February 28, 2024, effective the same date and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the ongoing plan basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Kamco Supply Corp. 401(k) Savings and Profit Sharing Plan's ability to continue as a going concern for at least one year following the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

1. Description of Plan

The Plan includes as employers (the Employer)

- a. Kamco Supply Corp.
- b. Kamco Services LLC
- c. Kamco Supply of NJ, LLC
- d. Kamco Supply Bronx LLC

The following description of the Kamco Supply Corp. 401(k) Savings and Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective June 1988, as restated July 31, 2022. The Plan covers all eligible employees of the above-mentioned employers who have completed three months of service and have attained age 21. Employees whose employment is covered by the terms of a collective bargaining agreement, leased employees and employees employed in a nonmanagerial position as warehouse employees are not eligible for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The administrator is responsible for oversight of the Plan. The Plan utilizes a third-party consultant who determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan administrator.

On February 28, 2024, the Board of Directors formally approved the termination of the Plan effective the same date. Upon termination, all assets remaining in the Plan will be distributed to the participants subject to the applicable requirements of ERISA and in accordance with the provisions of the plan document.

Contributions

Each year before the termination, participants may contribute up to 70% of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants will have their deferral rate increase by 1% on the anniversary of their enrollment date until their deferral rate reaches 10%. The Employer may elect to make a matching contribution, on behalf of participants who are eligible, as defined, equal to a uniform percentage, to be determined each year by the Employer, of each participant's deferral amount. For the year ended December 31, 2024, the matching contribution was \$80,563. The Employer, also in its sole discretion, may make a profit sharing contribution on behalf of participants who are eligible, as defined. Any profit sharing contribution shall be allocated in the proportion that each eligible participant's compensation for the plan year bears to total compensation of all eligible participants for the plan year. For the year ended December 31, 2024, there were no profit sharing contributions to the Plan. Additionally, the Employer may make qualified nonelective contributions on behalf of participants who are eligible, as defined, equal to a uniform percentage of each participant's compensation. For the year ended December 31, 2024, there were no qualified nonelective contributions to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Administration of Plan Assets

The Plan is administered by Matrix Trust Company (Trustee), the trustee of the Plan. The Trustee appointed OneAmerica Retirement Services LLC to provide record-keeping services for the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer matching contributions, allocations of the Employer's discretionary contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on years of continuous service. A participant is 20% vested after two years of credited service and continues to vest in increments of 20% until 100% vested after six years of credited service. Upon termination of the Plan (Note 8), all participants became 100% vested.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan bears interest at a reasonable rate determined by reviewing the interest rates of similar types of loans by other lenders. Loan repayments of principal and interest must be in level payments not less than quarterly. Terms range up to five years or greater for the purchase of a primary residence. During 2024, interest rates on notes receivable from participants ranged from 4.25% to 9.50%.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump sum equal to the value of the participant's vested interest in his or her account. If a terminated participant's vested balance is less than or equal to \$7,000, the amount may be automatically distributed in the form of lump sum cash payment or IRA (Individual Retirement Account), depending on the balance. In addition, the Plan allows for hardship distributions if certain criteria are met.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$0 and \$5,000, respectively. During 2024, Employer contributions were reduced by approximately \$5,000 from forfeited nonvested accounts, in accordance with plan provisions.

2. Summary of Accounting Policies

Basis of Accounting

As a result of the resolution to terminate the Plan effective February 28, 2024 (Note 8), the Plan considers liquidation to be imminent and, therefore, the financial statements of the Plan as of and for the year ended December 31, 2024 are presented on the liquidation basis of accounting.

The financial statement of the Plan as of December 31, 2023 is presented on the ongoing accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and Trustee, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Due to Plan Sponsor

Amounts payable to the plan sponsor for mistake in fact contributions are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Recent Regulatory Updates

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

Subsequent Events

Subsequent events were evaluated through August 21, 2025, the date the financial statements were available to be issued.

As of June 9, 2025, all participant accounts were distributed to participants in the Plan termination.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Interest-bearing cash: Valued at cost, which approximates fair value.

Investments measured at net asset value: The Putnam Stable Value Fund (Putnam) is a common collective trust which invests primarily in security-backed investment contracts (SBICs), including separate accounts of insurance companies, and GICs. The Plan's investment in Putnam is not an investment in a fully benefit-responsive investment contract and is therefore measured and reported at fair value. The NAV reported by the Putnam is used by the Plan as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the Putnam will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of Putnam, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Insurance contracts: Policies which are recorded at their cash surrender value which approximates fair value.

4. Concentrations

As of December 31, 2024 and 2023, the Plan had investments of \$531,698 and \$14,110,794, respectively, that were concentrated in five and three funds, respectively.

5. Life Insurance Policies

Certain participants in the Plan have life insurance policies. The Plan is the owner of the policies which are held on behalf of participants. Any premiums on life insurance policies are paid from the participants' plan assets. The life insurance policies must be distributed to the participant or converted to cash upon the latter of the participant's annuity starting date, as defined, or termination of employment. It has been determined that these insurance policies do not meet the definition of allocated contracts and therefore must be included in plan assets.

6. Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Matrix Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 (in Liquidation) and 2023 (Ongoing), and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets in Liquidation for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

7. Related-Party and Party in Interest Transactions

Certain Plan investments are managed by Matrix Trust Company, the Trustee, and therefore, these transactions qualify as party in interest transactions. OneAmerica Retirement Services LLC is the recordkeeper and provides other general services to the Plan. The Plan receives rebates in the form of fee credits from certain mutual funds held. During the year ended December 31, 2024, the Employer paid certain administrative expenses of the Plan.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan.

8. Plan Termination

As previously disclosed in Note 1, on February 28, 2024, the Board of Directors approved the termination of the Plan effective the same date, with the Plan's assets to be distributed as soon as administratively feasible. As a result of the termination, all participants became 100% vested in Employer contributions. The liquidation of the Plan was completed as of June 9, 2025 under applicable requirements of ERISA and in accordance with the provisions of the plan document.

9. Tax Status

The Plan adopted a volume submitter plan offered by OneAmerica Financial Partners, Inc. The volume submitter plan received an IRS Determination Letter dated August 19, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Determination Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits as of December 31, 2024 (in Liquidation) and 2023 (Ongoing).

11. Delinquent Participant Contributions

In connection with one payroll during the year ended December 31, 2024, and fifteen payrolls during the year ended December 31, 2023, the Employer failed to transmit participant contributions and loan repayments to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Late payments result in a prohibited transaction inasmuch as late remittance is deemed to create a loan to the Employer. The untimely remittances identified on the Schedule H, Line 4(a) - Schedule of Delinquent Participant Contributions, totaled \$405,235. During 2024, the Employer made a contribution to the Plan for lost earnings resulting from late remittances. The amount of lost earnings was \$11,263.
