We have performed audits of the financial statements of Headway Technologies, Inc. 401(k) Savings and Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## Notes to Financial Statements

---

### NOTE 1 – DESCRIPTION OF PLAN

The following description of the Headway Technologies, Inc. 401(k) Savings and Retirement Plan (the Plan), provides only general information. Participants should refer to the Plan Agreement for a more complete description of plan provisions.

**General** – The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all employees of Headway Technologies, Inc. (the Company), and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan’s sponsor and serves as Plan administrator.

**Eligibility** – Employees of the Company are eligible to participate in the Plan upon reaching age 21.

#### **Contributions**

*Participant contributions* – Each year, participants may contribute up to 60% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Effective November 2023, participants may also elect to make Roth contributions utilizing after-tax contributions

*Employer safe harbor matching contributions* – The Company elects to make safe harbor matching contributions equal to 100% of employee contributions, up to 4% of eligible compensation deferred to the Plan.

*Employer discretionary contributions* – The Company may also elect to make discretionary contributions to the Plan. A participant must have a year of service, as defined in the Plan, and be employed on the last day of the plan year to be eligible to receive any employer paid discretionary contributions. There were no such contributions for the year ended December 31, 2024.

Contributions are subject to regulatory limitations.

**Participant accounts** – Each participant’s account is credited with the participant’s contributions, employer safe harbor matching contribution, and employer discretionary contributions, if any, and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their account into various investment options offered by the Plan.

**Vesting** – Participants are vested immediately in their contributions and employer safe harbor matching contributions. Participants vest in the employer discretionary contributions over six years of credited service.

**Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed ten years. Under the terms of the Plan document, plan loans will bear a reasonable rate of interest determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans are in the range from 4.25% to 9.50%, with various maturities through January 2033.

**Payment of benefits** – On termination of service due to termination of employment, death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual or elect distribution under a systematic withdrawal plan. The Plan allows for the automatic distribution of participant vested account balances that do not exceed \$5,000.

**Forfeitures** – Forfeitures are the nonvested portion of a participant's account that is lost upon termination of employment. Forfeitures are used to reduce future company contributions or pay the Plan's administrative expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$39 and \$14,429, respectively. During 2024, \$14,416 of forfeitures were used to reduce employer matching contributions.

### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in conformity with generally accepted accounting principles requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment valuation** – The investments are reported at fair value. The Plan's trustee, Fidelity Management Trust Company (Fidelity), certifies the fair value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

**Notes receivable from participants** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan agreement.

**Payment of benefits** – Benefits are recorded when paid.

**Plan termination** – Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. In the event the Plan is terminated in the future, participants would become fully vested in their accounts.

**Expenses** – Several of the investment fund options are subject to investment and administrative fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance; thus, they are not separately disclosed in the accompanying financial statements.

Participants are assessed separate fees for the administration of loans and repayments thereof, as well as investment advisory services, and such fees are separately disclosed in the financial statements, net of any revenue sharing credits earned and received by the Plan (see Note 7).

All other administrative expenses related to the Plan are paid by the Plan sponsor.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits, but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through August 14, 2025, which is the date the financial statements were available to be issued.

### NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

**Level 2** –Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** –Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Registered investment companies (mutual funds)* – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

*Self-directed brokerage accounts* – Accounts primarily consist of mutual funds, exchange-traded funds, and interest-bearing cash. Exchange-traded funds – Valued at the closing price reported on the active market on which the exchange-traded funds are traded.

*Common/collective trust* – The Plan invests in Fidelity's Managed Income Portfolio II, which is composed primarily of fully benefit-responsive investment contracts. This trust strives to maintain a stable NAV of \$1 per unit price, as such, it is valued using the NAV practical expedient, an estimate of fair value. This NAV practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments, redemption frequency restrictions, redemption notice periods, or any redemption restrictions, except restrictions that may be imposed by the issuer of the stable value fund in unusual market conditions. If the Plan initiates a full redemption, the issuer of the stable value fund reserves the right to temporarily delay withdrawal in order to ensure that securities liquidations will be carried out in an orderly business manner.

### NOTE 4 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.

### NOTE 5 – TAX STATUS

The Plan has adopted a pre-approved plan document that received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, which stated that the plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 6 – CERTIFIED INVESTMENT INFORMATION**

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity (see Note 2), a qualified institution:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends, and interest, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024.

#### **NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS**

The Plan paid expenses related to plan operations and investment management to various service providers. Certain plan investments are managed by companies affiliated with Fidelity, the trustee of the Plan and, therefore, transactions with these entities qualify as exempt party-in-interest transactions.

The Plan has a revenue sharing agreement with Fidelity Management and Research Company, the recordkeeper of the Plan. Such agreement, intended to reduce administrative costs, requires recordkeeper to share revenue it receives from certain fund companies attributable to the Plan's investments based on a specified formula. During 2024, the Plan received \$125,874 under such agreement, which was recorded as a reduction to the Plan's administrative expenses on the statement of changes in net assets available for benefits. The Plan's revenue sharing credit account has a balance of \$49,054 and \$27,163 at December 31, 2024 and 2023, respectively.
