Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Buchanan Hauling 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1. Plan Description

Overview

The Buchanan Hauling 401(k) Plan (the "Plan") is a defined contribution plan covering employees of Buchanan Hauling & Rigging, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The provisions of the Plan are included in the official Plan document which legally governs the operation of the Plan and is available for more detailed information.

Subsequent to the year ended December 31, 2024, the Plan changed its custodian from Reliance Trust Company to Principal Trust Company. The Plan also changed its recordkeeper from ADP LLC to Principal Life Insurance Company. As a result of this recordkeeper change, the Plan adopted a new Plan document. There were no significant changes with the adoption of the new Plan document other than described in the notes receivable from participants paragraph below.

Eligibility

All employees are eligible to participate in the Plan following two months of service. Employees may enter the Plan on the first day of the month following the completion of the eligibility requirement.

Contributions

Participants may make voluntary pre-tax or Roth contributions up to 90% of eligible compensation up to the statutory dollar limit established by the Internal Revenue Code. The Company provides a safe harbor matching contribution equal to 100% of the first 3% of compensation, then 50% of the next 2% of compensation. The Company may also elect to make a discretionary contribution. The Company did not elect to provide a discretionary contribution for the Plan year ending December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's voluntary contribution, Company contributions, Plan earnings, and charged with any direct administrative expenses related to specific participant transactions. Allocations of Plan earnings are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and Company contributions in whole percentages into various mutual funds offered by Reliance Trust Company. All amounts in participant accounts are participant-directed, and allocations can be changed daily. These funds differ in potential investment return and risk, and may be changed by the Company.

Note 1. Plan Description (Continued)

Vesting

Participants are immediately vested in their voluntary contributions, safe harbor employer matching contributions, plus actual earnings thereon. An amendment was passed effective January 1, 2022, making participants fully vested in the Company's matching contributions from before January 1, 2018. Vesting in the Company's discretionary contributions (if any) plus earnings thereon is based on years of continuous service. A participant becomes 20% vested after two years of service and increases 20% each year until fully vested after six years of credited service.

Forfeitures

Participants who terminate employment prior to becoming fully vested must forfeit a percentage of the Company contributions. Forfeitures are used to reduce future Company contributions or pay Plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaling approximately \$460 and \$520, respectively, were available to offset future Company contributions and cover Plan expenses. There were no forfeitures used to offset Company contributions during the year ended December 31, 2024.

Notes Receivable From Participants

The Plan allows participants to borrow from their accounts a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are issued for a minimum of \$500. The maximum number of loans outstanding at any one time is one per participant. Loans must be repaid within five years unless the loan is for a primary residence, in which case the term cannot exceed thirty years. The loans are secured by the balance in the participant's account and bear interest at a fixed rate set at the prime rate plus 1% at the time of issuance. The interest rates for loans outstanding as of December 31, 2024 range from 4.25% to 9.50%. Loans outstanding at December 31, 2024 mature through 2029. Subsequent to the end of the year, the Plan was restated and will allow a participant to have two loans outstanding at any one time.

Benefit Payments

Benefits under the Plan are payable when a participant retires, dies, or otherwise ceases to be an employee and are payable as a single lump-sum payment, installments, or direct rollovers. In-service distributions from vested amounts may be made to a participant provided he or she has attained age 59 1/2.

Hardship Withdrawal

The Plan allows participants to withdraw from their accounts a maximum equal to 100% of their elective deferrals, excluding earnings, as well as vested matching contributions for financial hardship. The participant must first obtain the maximum available loan under the Plan to the extent that repaying the loan would not increase the amount of the hardship. The withdrawal amount for financial hardship cannot exceed the amount required to meet the immediate financial need created by the hardship.

Termination of the Plan

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time, subject to the provisions set forth in ERISA. Upon termination of the Plan, participants will become fully vested in their total account balance.

Note 2. Significant Accounting Policies

Basis of Financial Statements

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Direct investment related expenses are included in administrative expenses. Indirect investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Management of the Plan has evaluated events and transactions for possible recognition or disclosure through August 19, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by Reliance Trust Company

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Reliance Trust Company, and was not subjected to any auditing procedures performed by the independent public accountants.

- a. Total investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits.
- b. Net investment income, as shown in the accompanying statement of changes in net assets available for benefits, including dividends, interest, net realized and unrealized appreciation in fair value of investments and interest income on notes receivable from participants.
- c. Schedule of assets (held at end of year).

Note 4. Fair Value Measurements

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

- Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

The asset's or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 4. Fair Value Measurements (Continued)

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at quoted market prices which represent the net asset value (NAV) of shares held by the Plan at year end.

Cash, interest bearing: Valued at carrying amount, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Income Tax Status

The Plan, which is a prototype plan, obtained an opinion letter on October 6, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC) and therefore is not subject to tax. Therefore, no provision for income taxes has been included in the Plan's financial statements. Although the prototype was amended to the Plan sponsor's specifications, the Plan Administrator believes the changes were minor and that the Plan is being operated in compliance with the applicable requirements of the IRC.

Note 5. Income Tax Status (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 6. Transactions with Parties-In-Interest

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Company provides certain accounting, recordkeeping, and administrative services for the Plan for which it receives no compensation. Administrative expenses for legal, accounting, and other services are rendered by parties-in-interest and are paid by the Company. Notes receivable from participant transactions are also party-in-interest transactions.

Note 7. Risks and Uncertainties

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
