### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

## **NOTES TO FINANCIAL STATEMENTS**

### **DESCRIPTION OF PLAN**

The following description of the Tiger Fuel Company Employees Flexible Compensation Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering all eligible employees of Tiger Fuel Company and Tiger Solar Company (Companies), who have one year of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### ***Contributions***

Each year, participants may contribute up to 60% of pre-tax annual compensation as defined in the Plan. Participants may also elect to designate their salary deferrals as after-tax Roth deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an auto-enrollment provision, whereby all newly-eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically-enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The deferral rate is increased 1% annually, not to exceed 10%. The Companies contribute a safe harbor company match of 100% of the first 3%, and 50% of between 3% and 5% of base compensation that a participant contributes to the Plan. The Companies may also make discretionary profit sharing contributions at the end of the Plan year. No discretionary profit sharing contributions were made during the years ended December 31, 2024 and 2023. Participants direct the investment of all contributions into various investment options offered by the Plan. Participants may change their investment options periodically. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Contributions from participants and the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and the Companies' safe harbor matching contributions, as well as allocations of the Companies' discretionary profit sharing contributions and Plan earnings. Participants' accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## **NOTES TO FINANCIAL STATEMENTS**

### ***Vesting***

Participants are vested immediately in their contributions and the Companies' safe harbor matching contribution as described above, plus actual earnings thereon. An employee will be 100% vested in the Companies' discretionary profit sharing contribution after three years of credited service. Years of credited service are based upon the elapsed-time method, as defined in the Plan document. The Plan's prior vesting schedule, in which a participant was 100% vested in this portion of their account at seven years of credited service, based on years of continuous service, applies to certain account balances.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made, or 50% of their vested account balance reduced by any outstanding loan balance. The loans are secured by the balance in the participant's account. The loans bear interest at a rate commensurate with local prevailing rates as determined by the Loan (Plan) Administrator. At December 31, 2024 and 2023, all loans bear interest rates between 4.25% and 9.50% per annum. Principal and interest is paid ratably through bi-weekly payroll deductions.

### ***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a specified period. For termination of services for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

### ***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,244 and \$2,973, respectively. These accounts may be used to reduce future employer contributions. During 2024, no forfeited nonvested accounts were used to reduce future employer contributions.

## **SUMMARY OF ACCOUNTING POLICIES**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

## NOTES TO FINANCIAL STATEMENTS

### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See the **FAIR VALUE MEASUREMENTS** note for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Notes receivable from participants on the statements of net assets available for benefits is net of an allowance for credit losses of \$47,280 and \$52,562 as of December 31, 2024 and 2023, respectively. The allowance represents notes receivable from participants in default, which were treated as deemed distributions to the participants, according to income tax regulations. However, these loans are still considered Plan assets of active participants until a distributable event occurs based upon terms of the Plan document.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

### *Subsequent Events*

The Plan has evaluated subsequent events through August 26, 2025, the date the financial statements were available to be issued.

### INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Fidelity Management Trust Company, the Plan's trustee, and was not subjected to any auditing procedures performed:

1. Total investments, as shown in the accompanying statements of net assets available for benefits, of \$16,632,866 as of December 31, 2024 and \$13,775,679 as of December 31, 2023.
2. Net notes receivable from participants, as shown in the accompanying statements of net assets available for benefits, of \$235,926 as of December 31, 2024 and \$310,368 as of December 31, 2023.
3. Net investment income and interest income on notes receivable from participants, as shown in the accompanying statement of changes in net assets available for benefits, of \$1,835,398 and \$19,940, respectively, for the year ended December 31, 2024.
4. All investment-related information in the accompanying supplementary schedule, schedule of assets (held at end of year), as of December 31, 2024.

### FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

## NOTES TO FINANCIAL STATEMENTS

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in the mutual funds and the money market fund are stated at fair value as reported by Fidelity Management Trust Company (the Plan's trustee), and are based on the fair value of the underlying securities. The fair value of the underlying securities is based on quotations from national exchanges.

The Plan's interest in the self-directed brokerage account is provided by Fidelity Management Trust Company (the Plan's trustee). Valuation of the underlying investments will vary depending on the nature of the investment. All investments under the brokerage account were determined to have a readily-determinable fair market value and are based upon quotations from national exchanges.

### **RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

The Companies' contributions to the Plan or benefits accrued or paid by the Plan for participants are not considered party in interest transactions.

The Plan allows for transactions with certain parties who may perform services for or have fiduciary responsibilities to the Plan, including the Companies. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan for the investment management and recordkeeping services amounted to \$4,593 for the year ended December 31, 2024.

### **PLAN TERMINATION**

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

### **TAX STATUS OF THE PLAN**

The Plan is a non-standardized prototype Plan and has not requested a determination letter on the adoption agreement but rather has relied upon the Internal Revenue Service opinion letter, dated June 30, 2020, issued on the prototype Plan. Although the Plan has been amended since this issuance, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
