Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Conagra Brands Retirement Income Savings Plan for Union Employees (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter – Supplementary Information Required by ERISA

The supplementary information as of and for the year ended December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplementary information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplementary information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplementary information, we evaluated whether the supplementary information, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplementary information, other than the information in the supplementary information that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplementary information related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Plan Description

The following brief description of the Conagra Brands Retirement Income Savings Plan for Union Employees (the CRISP Union Plan or Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The CRISP Union Plan is a defined contribution plan sponsored by Conagra Brands, Inc. (the Company). The CRISP Union Plan was established to provide retirement benefits for certain union employees of the Company. The CRISP Union Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Conagra Brands Employee Benefits Administrative Committee (the Committee) manages the operation and administration of the Plan as the Plan Administrator, as defined in Section 3(16) of ERISA.

Participation in the CRISP Union Plan by union employees is governed by their respective collective bargaining agreement (CBA) of the participating locations. The CRISP Union Plan established separate plan supplements to document the various CBA's within the CRISP Union Plan. Employees are eligible to participate in the CRISP Union Plan once they have met the eligibility requirements under the applicable plan supplement.

Trust assets of the CRISP Union Plan are commingled with those of the Conagra Brands Retirement Income Savings Plan (the CRISP Plan), within the Conagra Brands Retirement Income Savings Master Trust (see Note 3).

Certain plan participants transferred between the CRISP Union Plan and the CRISP Plan due to a change in status. Net Master Trust transfers out of the Plan totaled \$196,316 and \$1,220,056 for the years ended December 31, 2024 and 2023, respectively.

Participants may direct their investment into one or more of the following investment options within the Plan:

- Extended Market Index Fund (Vanguard Extended Market Index Fund)
- International Equity Growth Fund (Vanguard International Growth Fund)
- Large-Cap Growth Stock Fund (Vanguard Russell 1,000 Growth Index Fund)
- International Stock Market Index Trust (Vanguard Institutional Total International Stock Market Index Trust)
- One of 12 Target Date Retirement Funds (Vanguard Retirement Income Trust; 2020—2070 Target Date Trusts)
- Inflation Protection Securities Fund (Vanguard Inflation Protected Securities Fund)
- International Value Fund (Vanguard International Value Fund)
- Large-Cap Value Fund (Vanguard Equity Income Fund)
- Equity Index Fund (Vanguard Institutional 500 Index Fund)
- Investment Allocation Funds (Fidelity Managed Income Portfolio II Fund)
- Longer-Term Fixed Income Fund (Vanguard Total Bond Market Index Fund)
- Shorter-Term Fixed Income Fund (Prudential Core Plus Bond Fund)

- Small-Cap Core Fund (BlackRock Advantage Small Cap Core Fund)
- Government Money Market Fund (BlackRock Liquidity Fund)

In addition, certain participants hold investments in the Company's stock fund. Dividends associated with the Company's stock in this fund are distributed either in cash or re-invested at the discretion of the respective participants. Other than dividend re-investment, deferrals into this stock fund are not currently allowed.

Contributions

Depending on the plan supplement, contributions of 1% to 50% of eligible compensation may be made on a pre-tax, Roth after-tax, or additional after-tax basis. Part-time employees may be eligible upon completion of 1,000 hours worked over three consecutive years (500 hours worked over two consecutive years effective January 1, 2025). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions as set forth in the Internal Revenue Code. Participants of certain plan supplements who meet eligibility requirements are automatically enrolled with an initial 2% to 6% pre-tax salary deferral contribution. At any time, a participant can elect not to contribute or may change their deferral as allowed under the applicable plan supplement. Participants may also contribute amounts representing distributions from other qualified plans.

The Company makes matching contributions to the Plan based on the applicable plan supplement in which they participate. The various matching contributions range from 10% to 100% of the participant's elective deferral, not to exceed 3% to 8% of eligible compensation, depending on the plan supplement. Contributions are subject to certain limitations.

Vesting

Participants are vested immediately in their contributions plus earnings thereon. The Company's contributions and earnings thereon generally vest 20% per year of continuous service for with full vesting occurring after five years. As defined in the plan supplements, certain union groups within the Plan have negotiated accelerated vesting provisions within their respective CBA's.

Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contribution and allocations of the Company's matching contributions and plan earnings or losses. The Participant's account is also charged with an allocation of administrative expenses that are paid by the Plan.

The Company's matching contributions are allocated among participants based upon each eligible participant's elected salary deferral. Plan earnings or losses and administrative expenses are allocated on the basis of actual results of the investments selected by each participant. Investments are maintained in individual member accounts managed by Trustee, Bank of America, N.A. (Bank of America). In December 2024, Bank of America moved all of the Plan's investments into a money market fund in preparation for a change in trustee (See Note 9).

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates. Principal and interest payments must be made through payroll deductions within five years, unless the note proceeds are used to purchase a primary residence, in which case the note may be repaid within 10 years.

Payment of Benefits

Upon termination, retirement, disability, or death the participant or beneficiary may elect to receive either lump sum, or in certain cases, partial withdrawal or installment payments equal to the value of the vested funds allocated to the participant's account. The Plan requires mandatory distribution of balances between \$1,000 and \$7,000 (\$5,000 prior to January 1, 2024) be directly rolled over to an individual retirement account designated by the Plan Administrator if the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. The Plan allows for hardship withdrawals of pre-tax account balances.

Forfeitures

Upon a participant's termination of employment before normal retirement or death, the portion of their Company's matching contributions not then vested shall be forfeited. The forfeited portion of any participant's account may be used to reduce the Company's future matching contributions or plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$46,706 and \$20,747, respectively. During the years ended December 31, 2024 and 2023, \$245,217 and \$225,138, respectively, of forfeited amounts were used to reduce matching contributions and plan expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as benefits paid to participants based upon the terms of the Plan document.

Administrative Expenses

Fees, brokerage commissions, and expenses that are incurred directly in the interest of the Plan are charged to the Plan.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events are events or transaction that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through August 19, 2025. See "Contributions" section in Note 1 and Note 9 for descriptions of subsequent events.

3. Interest in Master Trust

Substantially all of the Plan’s investment assets are held in a trust account at Bank of America, the Trustee, and consist of an interest in an investment account of the Conagra Brands Retirement Income Savings Master Trust (the Master Trust), which is a master trust established by the Company and administered by the Trustee (see Note 9). Use of the Master Trust permits the commingling of trust assets of the CRISP Plan and the CRISP Union Plan Savings Plan for Union Employees (collectively “the Plans”) for investment and administrative purposes. Although assets of the Plans are commingled in the Master Trust, Bank of America maintains supporting records for the purpose of allocating the net gain or loss of the investment account to the participating Plans.

While the Plan participates in the Master Trust, each participant’s account is allocated earnings/losses consistent with the performance of the funds in which the participant has elected to invest in. Therefore, the Master Trust’s investments and investment income may not be allocated evenly among the Plans participating in the Master Trust.

5. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023, nor have there been any transfers between levels for the years ended December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Mutual funds are valued at quoted market prices, which represent the net asset values of securities held in such funds.

Money Market Funds: Money market funds are valued at cost, which approximates fair value.

Common Investment Trusts: Common investment trusts are valued at the net asset value (NAV) as provided by the Trustee. FASB ASC 820, Fair Value Measurement, allows NAV per unit to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan’s assessment that these trusts meet those requirements. The participants can redeem at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2023. There were no common investment trust investments at December 31, 2024 (see Note 9).

Common Investment Trust – Managed Income Portfolio: The Managed Income Portfolio (MIP) is a common investment trust valued at NAV as provided by the Trustee. The MIP invests in fully benefit-responsive investment contracts, fixed income securities, and money market funds. The NAV of the MIP is based on the fair value of the underlying securities plus the contract value of the benefit-responsive wrapper contract and other investment contracts. FASB ASC 820, Fair Value Measurement, allows NAV per unit to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan’s assessment that the MIP meets those requirements. The participants can redeem at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2023. There were no common investment trust investments at December 31, 2024 (see Note 9).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Tax Status

The Internal Revenue Service (the IRS) has determined and has informed the Company by a letter to the Plan dated October 12, 2023, that the respective Plan was designed in accordance with the applicable regulations of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that at December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for the years prior to 2021.

7. Plan Termination

The term of the Plan is indefinite, but may be amended, modified or terminated at any time by the Company. Regardless of such actions, the principal and income of the Plan remain for the exclusive benefit of the Plan's participants and beneficiaries. In the event the Plan is terminated, each participant's Company contribution becomes fully vested. The Company may direct the Trustee either to distribute the Plan's assets to the participants or to continue the trust and distribute benefits as though the Plan had not been terminated.

8. Related-Party Transactions

Certain Plan investments in the Master Trust are assets managed by Bank of America. Bank of America is the current trustee (see Note 9) as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions.

9. Change in Trustee and Record-keeper

Effective January 1, 2025, Empower Retirement, LLC (Empower) was appointed as the new trustee and record-keeper of the Plans. The Plan's net assets transferred to Empower remained in the same funds as those offered by Bank of America. The conversion initiated a "Black Out" period beginning December 27, 2024 and continued through January 12, 2025. During this period, employee contributions continued to be made through payroll deductions and the contributions were wired to Empower and invested according to participant investment choices.
