### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of QualTek Services Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of November 30, 2024 (in liquidation) and December 31, 2023 (ongoing), and the related statement of changes in net assets available for benefits for the eleven-month period ended November 30, 2024 (in liquidation) and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of QualTek Services Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 30, 2024 and December 31, 2023, and for the eleven-month period ended November 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of QualTek Services Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about QualTek Services Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting***

As described in Note 1 to the financial statements, the governing body of QualTek Services Retirement Plan approved a plan of liquidation on September 30, 2024, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

### Note 1: Description of Plan

The following description of the QualTek Services Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan, sponsored by QualTek, LLC (the "Company"), is a defined contribution profit sharing plan covering substantially all employees of the Company. There is no service or age requirement for participation in the Plan. Employees who are covered under a collective bargaining agreement and nonresident aliens are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Plan Termination

On January 11, 2024, QualTek Services LLC's Wireline Fiber and Fulfillment business units, entered into an acquisition agreement by FiOptix Inc. and InfraServices Group Resources LLC. As a result, the QualTek Services Retirement Plan has been terminated effective September 30, 2024, at which time all employee and employer contributions into the plan were ceased. Upon termination of the Plan, all participants became 100% vested in their account balances. Plan assets remained in the Plan until November 30, 2024, at which date the Plan was completely liquidated and final distributions were made to participants in accordance with participant's directives on November 30, 2024.

#### Contributions

Participants may have elected to contribute up to 100% of their compensation to the Plan up to the maximum dollar amount permissible under the Internal Revenue Code. Participants who had attained the age of 50 before the end of the Plan year were eligible to make catch-up contributions. Participants were also able to contribute amounts representing distributions from other qualified plans. Participants directed the investment of their accounts into various investment options offered by the Plan. The Company, at its discretion and determined on a yearly basis, may have chosen to make a matching or profit sharing contributions to the Plan. Effective May 1, 2022, the employer instituted a matching contribution of up to 3% of eligible wages. Matching contributions totaled \$933,009 for the eleven-month period ended November 30, 2024. The employer did not make a discretionary profit sharing contribution for the eleven-month period ended November 30, 2024.

#### Participant Accounts

Each participant's account was credited with the participant's contributions, Company matching contributions, and allocations of (a) the Company's profit sharing contribution, if applicable, (b) plan earnings (losses), and (c) administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

### **Note 1: Description of Plan** (Continued)

#### **Vesting**

Upon the resolution to terminate the Plan, all participants became 100% vested in all contributions plus actual earning thereon.

#### **Forfeitures**

Under the Plan, forfeited nonvested contributions could be used to reduce future Company contributions. For the eleven-month period ended November 30, 2024, Company matching contributions were reduced by \$68,740 of forfeited nonvested contributions. At November 30, 2024, and December 31, 2023, the forfeited nonvested accounts available to offset future Company contributions were \$- and \$104,662, respectively.

#### **Notes Receivable From Participants**

Prior to termination, participants were able to borrow from their vested accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their account balance. The notes were secured by the balance in the participant's account. Principal and interest were paid ratably through payroll deductions.

#### **Payment of Benefits**

Participants' benefits under the Plan were payable to participants, their beneficiaries or their estates upon the termination of employment, normal retirement (the attainment of age 65), early retirement (the attainment of age 55 and completing at least 20 years of service), death, disability, hardship or upon the attainment of age 59-1/2. Benefits were payable in the form of lump sum distributions. Participant and spousal consent was required for all distributions over \$5,000.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting and Use of Estimates**

As discussed in Note 1, the Plan was terminated effective September 30, 2024. In accordance with GAAP, the Plan changed its basis of accounting used to value the plan assets from the ongoing basis used in the presenting of the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. The basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable and the net realizable value of asset are reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realizable cash value, which equals fair value for investments. There were no material changes to the 2024 financial statement as a result of the change under the liquidation basis of accounting.

### **Note 2: Summary of Significant Accounting Policies** (Continued)

#### **Investment Valuation and Income Recognition**

The Plan's investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Net realized and unrealized gains and losses are reported in the statement of changes in net assets available for benefits, as net appreciation/depreciation in fair value of investments. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest and dividends were recorded when earned, based on the terms of the investments and the periods during which the investments were owned.

#### **Notes Receivable From Participants**

Prior to liquidation, loans to participants were reported at their unpaid principal balances plus any accrued but unpaid interest. No allowance for credit loss was recorded as of December 31, 2023. Delinquent participant loans were reclassified as distributions based upon the terms of the plan document. Interest income was recorded on an accrual basis.

#### **Payment of Benefits**

Benefits were recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan were paid by Company. Expenses that were paid by the Company were excluded from these financial statements. Fees assessed against individual participant's accounts were charged directly to the participant's account and were included in administrative expenses. Investment-related expenses were allocated proportionately to plan participants based on their respective account balances and were included in net investment income.

#### **Subsequent Events**

The Plan has evaluated subsequent events through August 19, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no investment assets as of November 30, 2024. There were no changes in the methodology used as of December 31, 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust funds:* Valued at the NAV of units of a bank collective trust. The NAV, determined by the trustee, is based on the fair values of the underlying investments held by the fund less liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate full redemption of the common trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note 4: Information Prepared and Certified by the Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements, including investments and notes receivable from participants held at November 30, 2024 and December 31, 2023, and net appreciation/depreciation in fair value of investments, interest and dividends for the eleven-month period ended November 30, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, the Custodian of the Plan.

### Note 5: Party-in-Interest Transactions

Certain plan investments were managed by Reliance Trust Company. Reliance Trust Company was the Custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

ADP provided record keeping services to the Plan and, therefore, fees paid to ADP also qualify as party-in-interest transactions. Fees paid directly by the Plan to ADP for record keeping services amounted to \$97,076 for the eleven-month period ended November 30, 2024.

### **Note 5: Party-in-Interest Transactions** (Continued)

Certain fees incurred by the Plan for investment-related and record keeping services were included in net appreciation/depreciation in fair value of investments, as they were paid to the various service providers through revenue sharing rather than a direct payment.

Notes receivable from participants also qualified as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### **Note 6: Tax Status**

The Company adopted a nonstandard prototype document with an IRS notification letter which stated the prototype plan document was in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan was amended since receiving the determination letter; however, the plan administrator believes the Plan was designed and was operated in compliance with the applicable requirements of the IRC and had no income subject to unrelated business income tax. Therefore, no provision for income taxes was included in the Plan's financial statements.
