***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We were engaged to perform audits of the financial statements of Profile Plan LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

***Disclaimer of Opinion***

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

***Basis for Disclaimer of Opinion***

The Plan does not have sufficient accounting records and source documents relating to certain contributions withheld from payroll and remitted to the Plan and distributions to participants from the Plan. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditor's Responsibilities for the Audit of the Financial Statements***

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

***Other Matter - Supplemental Schedules Required by ERISA***

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Profile Plan LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan was established effective May 1, 2022, for the benefit of the employees of Profile Plan LLC (the “Company”). The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan covers all employees of the Company, except those who are temporary or part time. Eligible employees who have attained the age of 18 may enter the Plan on the first day of meeting the eligibility requirements. The Plan is participant directed and participants may change their contribution rates at the beginning of each payroll period and investment options at any time.

**Contributions**

Participants may elect to make pre-tax and/or Roth salary deferral contributions to the Plan up to 50% of eligible compensation. If a newly eligible employee does not make an affirmative election to make a salary deferral contribution or not to participate in the Plan, the employee’s eligible compensation will be automatically reduced by a pre-tax salary deferral contribution of 3%. The pre-tax salary deferral will automatically increase by 1% on the participant’s anniversary of employment until the pre-tax salary deferral reaches 6% unless the participant opts out. Effective January 1, 2024, the Plan was amended to remove both the automatic enrollment of eligible employees with a 3% pre-tax salary deferral contribution who do not make an affirmative election to make a salary deferral contribution, and remove the automatic 1% increase of those same pre-tax salary deferral contributions on the participant’s anniversary of employment. Participants who have attained the age of 50 before the end of the plan year may make additional catch-up contributions. The Plan allows for eligible employees or participants that were in a former employer’s qualified plan to contribute direct rollovers to the Plan in accordance with the terms of the Plan. Participants may also make in-plan Roth rollover contributions.

The Company has elected to make a safe harbor matching contribution of 100% of the participant’s elective deferral contributions up to 4% plus 50% of the participant’s elective deferral contributions between 4% and 6%. Effective January 1, 2024, the safe harbor matching contribution was changed to 100% of the participant’s elective deferral contributions up to 3% plus 50% of the participant’s elective deferral contributions between 3% and 5%. Safe harbor matching contributions are determined each payroll period. The Company may also make additional discretionary contributions in accordance with the terms of the Plan. Effective January 1, 2024, the Plan was amended to eliminate additional discretionary employer contributions.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and Plan earnings. In addition, participants are charged with any applicable administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are at all times fully vested in their participant and rollover contribution accounts and the appreciation or depreciation thereon. Vesting in the Company's safe harbor matching and discretionary contributions plus earnings thereon is based on years of service without regards to the hours of service. Participants vest 100% after two years of service. Effective January 1, 2024, the Plan was amended so that participants are 100% vested in employer safe harbor matching contributions at all times. A participant is immediately vested upon death, retirement, or total and permanent disability.

**Payment of Benefits**

Normal retirement age under the Plan is 65. The Plan does not allow for early retirement. Upon a participant's termination, retirement, death, or total and permanent disability, the vested funds in the participant's account are available to be distributed in lump-sum payment, equal installments, or partial withdrawals. The Plan also allows in-service withdrawals upon attaining the age 59½ and hardship withdrawals, subject to conditions as set forth in the Plan document.

**Forfeitures**

Forfeitures of nonvested employer contributions may be used to pay Plan administrative expenses or to reduce employer contributions. The forfeiture balance was \$26,178 and \$99,816 at December 31, 2024 and 2023, respectively. During 2024, \$124,939 of forfeitures were used to reduce the Company's safe harbor matching contribution and \$23,722 of forfeitures were used to pay Plan administrative expenses.

**Plan Termination**

Although it has not expressed any intent to do so, the Company may reduce, suspend, or discontinue contributions or terminate the Plan at any time, subject to the provisions of ERISA. In the event the Plan is terminated, participants will become 100% vested in all accounts and the amount allocated to each participant's account will become payable in accordance with Internal Revenue Service (IRS) regulations in accordance with the provisions of the Plan.

During 2024, the Company engaged in a number of reductions in force, which constituted a partial plan termination. Affected participants became 100% vested in all employer contributions at the time of the partial plan termination.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to recordkeeping, withdrawals, and certain investment transaction fees are charged directly to the participant's account and are included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

**Investments**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of investments are reflected on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants and the Company safe harbor matching are recorded in the plan year in which the participant contributions are withheld from compensation.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

**NOTE 3 - INFORMATION CERTIFIED**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company ("Principal"), the trustee of the Plan, has certified to the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Level 2* - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

*Level 3* - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

*Collective Investment Trust Funds:* Valued at NAV, based on the market value of the underlying investments held by the funds less liabilities. The NAV, as provided by the funds trustee, is used as a practical expedient to estimate fair value. The funds allow for daily liquidity with no additional days' notice required for redemption for participant directed-transactions. Were the Plan to initiate a full redemption of the funds, the trustee of the funds reserves the right to temporarily delay withdrawal from the funds in order to ensure that securities liquidations will be carried out in a timely manner. The Plan has no unfunded commitments or further obligations to invest in the funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used at December 31, 2024 or 2023.

**NOTE 5 - TAX STATUS**

The Plan has adopted a pre-approved defined contribution plan document, which obtained its latest opinion letter dated June 30, 2020, in which the IRS stated that the pre-approved document satisfies the applicable provisions of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, contributions to the Plan and earnings from its assets are not currently taxable to the Plan or its participants.

**NOTE 5 - TAX STATUS (CONTINUED)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - RISKS AND UNCERTAINTIES**

The Plan provides for investments in various investment securities. In general, such investments are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risks. Due to the risks associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes may materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

The Plan invests in a collective investment trust fund managed by Principal Global Investors Trust Company ("Principal Global"). Principal Global is an affiliate of Principal and, therefore, qualifies as a party in interest as defined under ERISA guidelines. These transactions are covered by an exemption from the prohibited transaction rules.

**NOTE 8 - OPERATIONAL ERRORS**

During 2023 and 2022, there were delays by the Company in submitting participant contributions in the amount of \$124,494. The Company plans to compensate the affected participants for all lost earnings resulting from the delay in remitting these contributions.

**NOTE 9 - SUBSEQUENT EVENTS**

Effective January 1, 2025, the name of the Company was changed to HMR Program, Inc. and the name of the Plan was changed to HMR Program, Inc. 401(k) Plan.

Management has evaluated subsequent events through August 13, 2025, the date the financial statements were available to be issued.
