## INDEPENDENT AUDITORS' REPORT

The Plan Administrator

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Houghton University Defined Contribution Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

### Basis for Opinion

**Notes to Financial Statements**

---

**1. Description of Plan:**

The following brief description of Houghton University Defined Contribution Plan (the Plan) is provided for general information purposes only. For more complete information, participants should refer to the text of the Plan document.

**General:**

The Plan is a defined contribution 403(b) plan covering substantially all full-time employees of Houghton University (the University). An employee, except for student employees, can immediately make salary reduction contributions to the Plan. Participants who attain age 21 and complete twelve months of service with a minimum of 83½ hours per month, as defined in the Plan, are eligible to receive employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:**

Participants may elect to contribute up to 100% of pretax annual compensation, as defined in the Plan, provided total additions to the account of participating employees for any plan year shall not exceed the amount permitted by Internal Revenue Service (IRS) regulations. The University provides a contribution of 3% provided the Participant's elective deferrals equal or exceed 3% of the Participant's compensation.

**Participant Accounts:**

Each participant's account is credited with the participant's contribution, the University's contribution, and an allocation of Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:**

Participants are immediately vested in their contribution, the University's contributions, and actual earnings thereon.

**Investment Options:**

Participants may direct contributions into a variety of registered investment company shares, a pooled separate account and fixed annuity contracts offered by TIAA-CREF, some of which are proprietary in nature. Participants are able to change their investment options at any time.

**Participant Loans:**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loan terms may not exceed 5 years. Loans for purposes of purchasing a primary residence may be repaid over a reasonable period greater than 5 years as determined when the loan is initiated. Loans are secured by the vested balance in the participant's account and bear interest at an adjustable rate as determined by TIAA-CREF. The Plan requires repayments on at least a quarterly basis; however, repayment terms are designated in the loan agreement. Participants may have up to two loans concurrently outstanding from the Plan.

Beginning in 2020, participant loans are issued from, and are assets of the Plan. Before 2020, pursuant to the Plan's arrangement with TIAA-CREF, certain participant loans were issued from TIAA-CREF owned assets, and secured by participant account balances. At December 31, 2024 and 2023, these plan loan balances totaled \$11,100 and \$39,605.

**Payment of Benefits:**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount, annual installments or an annuity equal to the participant's vested account balance. When a participant's vested balance is converted to a lifetime annuity, the present value of the stream of payments is equal to the vested balance, and the entire amount is recorded as a payment to the insurance company to purchase annuities excluded from plan assets in the statement of changes in net assets available for benefits. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

## 2. Significant Accounting Policies:

### Basis of Accounting:

The financial statements of the Plan are prepared under the accrual method of accounting.

### Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### Investment Valuation:

The Plan's investments are stated at fair value, except for the fully benefit responsive fixed annuity contract which is reported at contract value (See Note 4). Inputs to the valuation methodology of registered investment company shares are unadjusted quoted prices for identical assets in active markets. The pooled separate account is valued based on the net asset value (NAV) per share without further adjustment, as a practical expedient to determine fair value. Net asset value is based on the aggregate fair values of the underlying investments. Participants may redeem shares at net asset value daily, without restriction. The non-benefit responsive fixed annuity contract is valued based on discounted cash flows and theoretical transfer methods (fair value approximates contract value).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Payment of Benefits:

Benefits are recorded when paid.

### Administrative Expenses:

Certain administrative expenses of the Plan are borne by the University. Investment fees paid to TIAA-CREF are netted with investment income.

## Subsequent Events:

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through July 10, 2025 (the date the financial statements were available to be issued).

## 3. Investments and Fair Value Measurements (Unaudited):

Accounting guidance established a three-level fair value hierarchy that prioritizes the inputs used to measure assets at fair value. Inputs refer broadly to the assumptions that market participants would use in pricing the asset, including assumptions about risk. Inputs may be observable or unobservable. Observable inputs are inputs that reflect the assumptions market participants would use in pricing the asset and are based on market data obtained from sources independent of the reporting entity. Unobservable inputs are inputs that reflect the reporting entity's own perceptions about the assumptions market participants would use in pricing the asset and are based on the best information available.

The three levels of fair value hierarchy are as follows:

Level 1 – Quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access on the reporting date.

Level 2 – Inputs other than quoted market prices included in Level 1 that are observable for the asset or liability, either directly or indirectly. If the asset or liability has a specific (contractual) term, a Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs that are unobservable for the asset or liability.

The fair value hierarchy gives the highest priority to Level 1 inputs and the lowest priority to Level 3 inputs.

The Plan uses NAV per share (or its equivalent) as a practical expedient to determine the fair value of investments that (i) do not have a readily determinable fair value predicated upon quoted prices in active markets, and (ii) have the attributes of an investment company or prepare their financial statements consistent with the measurement principles of an investment company.

The fair values of investment assets valued at fair value are determined as follows as of December 31, 2024 and 2023:

Level 3 investment purchases for 2024 totaled \$297,285.

#### 4. Fully Benefit Responsive Investment Contract:

The Plan maintains a fully benefit responsive investment contract with TIAA-CREF. TIAA-CREF maintains the contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the investment contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported to the Plan by TIAA-CREF, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than three percent. Such interest rates are reviewed on a monthly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the Plan, (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The fixed annuity contract does not permit the insurance company to terminate the agreement before the scheduled maturity date.

#### 5. Financial Information Certified by TIAA-CREF:

In accordance with Department of Labor Regulation 2520.103-8, the Plan Administrator has obtained certified "Statements of Account" from TIAA-CREF as of December 31, 2024 and 2023 and for the year ended December 31, 2024, that the information summarized below is complete and accurate:

- Statements of Net Assets Available for Benefits – Investments and notes receivable from participants.
- Statement of Changes in Net Assets Available for Benefits – Investment income and interest income on notes receivable from participants.
- Supplemental Schedule of Assets (Held at End of Year) – all items and amounts.

#### 6. Income Taxes:

The IRS has issued a favorable opinion letter regarding the tax-exempt status of the Plan. Accordingly, no provision has been made for income taxes.

#### 7. Plan Termination:

Although it has not expressed any intent to do so, the University has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

## **8. Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
