Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about DeCook Companies 401(k) Retirement Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. NOTES TO FINANCIAL STATEMENTS

1. Plan Description and Summary of Significant Accounting Policies

The following description of the DeCook Companies 401(k) Retirement Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General Information

The Plan was established on January 1, 2019 and was last amended and restated January 1, 2022. The Plan is a defined contribution plan covering all employees, excluding union employees, nonresident aliens, leased, part-time, temporary and seasonal employees of DeCook Excavating, Inc., Olmsted Aggregate, Inc., DeCook Drainage, Inc., DeCook Contracting, Inc., and DeCook Landscaping, LLC (collectively, the Company) who had completed 90 days of service and are 18 years of age. Newly eligible employees were automatically enrolled in the Plan with a 3 percent deferral percentage unless they elect otherwise. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In January 2024, the Plan merged with The Standard Pooled Employer Plan. Effective January 16, 2024, the Company terminated the Plan. Upon termination, the benefits held under the Plan were transferred to The Standard as the new recordkeeper, pursuant to the terms of the Plan.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Administration

The Plan was administered by DeCook Excavating, Inc. and advised by a committee whose members were appointed by the Board of Directors of DeCook Excavating, Inc. The Custodian of the Plan's assets was T. Rowe Price (the Custodian). The Custodian executed transactions based upon direction from the Plan's administrator and the Plan's participants.

Contributions

Each year, participants were allowed to contribute from 1% to 100% of pretax compensation (or post-tax compensation for the Roth portion of the 401(k) plan) not to exceed the limits of the Internal Revenue Code (IRC), as defined in the Plan document. Participants who had attained the age of 50 before the end of the Plan year were also eligible to make catch-up contributions in any amount up to the limits prescribed by law. Participants could also contribute amounts representing distributions from other qualified plans. Participants directed the investment of their contributions into various investment options offered by the Plan.

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Contributions (Continued)

The Company contributed an employer matching contribution equal to 100% percent of the employee elective deferral contributions which were not more than 3% of pay. The Company could contribute to the Plan discretionary non-elective contributions. The Company's non-elective contribution, if any, was allocated using an integrated formula to eligible employees who were employed as of the last day of the plan year.

Participant Accounts

Each participant's account was credited with the participant elective deferrals, matching contributions, non-elective profit sharing contributions and an allocation of Plan earnings, and was charged with administrative expenses for certain transactions as defined by the Plan document. Allocations were based on participant earnings or account balances, as defined by the Plan document. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

Notes Receivable from Participants

Participants were allowed to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms were up to five years for general purpose loans with longer terms allowed related to the purchase of a primary residence. The loans were secured by the balance in the participant's account. The interest rate on loans outstanding as of December 31, 2023 was 4.25%. Principal and interest was paid ratably through payroll deductions.

Vesting and Forfeitures

Participants were immediately vested in their salary deferrals and in any amounts rolled over from other qualified plans. Vesting in Company contributions was based upon years of service. Participants were also vested on death, disability and retirement. A participant was zero percent vested after one and two years of service and was 100% vested after three years of credited service.

Any forfeitures during the plan year were used to reduce employer contributions. As of January 16, 2024 and December 31, 2023 forfeited nonvested accounts totaled \$0 and \$38,005, respectively. During 2024 and 2023, forfeitures totaled \$0 and \$24,852, respectively. Forfeitures in the amount of \$38,243 were transferred to the new Plan during 2024. No forfeitures were used to reduce employer contributions during 2023.

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Payment of Benefits

As soon as administratively feasible, a participant who had terminated service could receive the vested portion of his or her account, payable in the form of a lump sum. In-service distributions, including hardship distributions and distributions when a participant reaches 59 1/2, were allowed.

Benefits payments were recorded upon distribution to participants.

Investment Valuation and Income Recognition

Investments were reported at fair value, which was the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 2 for discussion on fair value measurements.

All purchases and sales of securities were recorded on a trade-date basis. Income was recorded as earned. The increase or decrease in the fair value of investments represents the net difference between the current value of securities held at the beginning of the period or cost of securities purchased during the period and the current value of securities held at the end of the period.

Administrative Expenses

The plan sponsor paid most costs and expenses incurred in connection with the operation of the Plan. Administrative expenses paid by the Plan during the period from January 1, 2024 to January 16, 2024 and 2023 were for management of certain Plan investments. These expenses are included on the statement of changes in net assets available for benefits.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent Events

In preparing these financial statements, the Plan's management has evaluated events and transactions for potential recognition or disclosure through July 30, 2025, the date the financial statements were available to be issued.

2. Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Observable market-based inputs or unobservable inputs that are corroborated by market data. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at January 16, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

2. Fair Value Measurements (Continued)

Common Collective Trust Funds: The collective trust funds are valued at the net asset value of units of a bank collective trust. The net asset value, as provided by the Trustee, is published as the fund's fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. The common collective trust funds held by the Plan are deemed to be actively traded.

The methods described above and on the previous page may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

3. Plan Termination

As noted in footnote 1, the Plan was merged into another qualified retirement plan in 2024. All participants retained their rights and vesting from this plan upon the merger with The Standard Pooled Employer Plan.

4. Plan Tax Status

The Plan had adopted a prototype plan document, which received an opinion letter from the Internal Revenue Service stating that the plan document and related trust were designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan was amended since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan was currently designed and being operated in compliance with the applicable requirements of the IRC during the period of its operation.

Plan management evaluated all significant tax positions as required by generally accepted accounting principles in the United States of America. As of January 16, 2024 and December 31, 2023, management does not believe the Plan had taken any tax positions that would require the recording of any additional tax liability, nor does management believe there were any unrealized tax benefits that would either increase or decrease within the next twelve months. The Plan's tax returns are subject to examination by the appropriate regulatory authorities as of January 16, 2024 and generally remain open for three years.

5. Risks and Uncertainties

The Plan's assets were invested in a variety of exchange traded funds and mutual fund investments with registered investment companies, and cash and money market accounts with various asset custodians. In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. Party-in-Interest Transactions

Fees for professional services rendered to the Plan could be paid for by the Company at its discretion. The Plan invested in certain mutual funds, a money market fund, and a common/collective fund that were managed by the Plan custodian. The Plan allowed participants to take out loans against their account balances and those activities were deemed party-in-interest transactions. These transactions were not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations. Certain employees of the Company provided certain accounting and administrative services to the Plan for which no fees were charged. These services were also not considered prohibited transactions.
