Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTE 1 DESCRIPTION OF PLAN

The following description of the Advanced Payroll Solutions, Inc. 401(k) Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that was adopted by Advanced Payroll Solutions, Inc. (the Company), effective March 1, 2000, most recently amended effective October 1, 2022. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code of 1986 (IRC), as amended. The purpose of the Plan is to provide retirement benefits for substantially all employees who are age 18 or older. There is no service requirement. The Administrative Committee is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Contributions

Participants are automatically enrolled in the Plan but can choose to opt out at any time. Participants may elect to contribute up to 75% of their pre-tax annual compensation not to exceed the maximum deferral limitation, as defined in the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other tax-qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes matching contributions of 100% of the first 3% of the participant's compensation contributed.

Participant Accounts

Each participant's account is credited with the participant's contribution, the corresponding Employer matching contribution, and an allocation of Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings, contributions, or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is vested at the rate of 20% each year after two years of service and is considered to be 100% vested after six years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Notes Receivable from Participants

Participants may borrow against their Plan account balance within Plan guidelines. Loan terms are at the discretion of the borrower but generally cannot exceed five years. The note amount can be a minimum of \$1,000 but cannot exceed the lesser of (a) one-half of the participant's nonforfeitable interest under the Plan or (b) \$50,000. Interest is charged on the outstanding balance at rates determined by the Plan administrator based on prevailing interest rates. Principal and interest are paid ratably through payroll deductions. The notes are secured by the vested balance in the participant's account, and a participant can have a maximum of two outstanding loans at any time.

Benefit Payments

Upon termination of service due to death, disability, or retirement, the participant will receive a lump sum distribution if the vested portion of the participant's account is \$1,000 or less. If the vested portion is between \$1,000 and \$7,000, the participant may elect either a lump sum distribution or transfer to an individual retirement account. If the vested portion of the participant's account is more than \$7,000, the participant may elect either a lump sum distribution or installment payments, as defined in the Plan document. Additionally, upon reaching retirement age, participants are allowed to withdraw their funds from the Plan.

Forfeitures

Upon termination of a participant, the nonvested portion of the Company's contributions is forfeited and is used to reduce Employer matching contributions. At December 31, 2024 and 2023, forfeited amounts yet to be allocated totaled \$68,280 and \$66,204, respectively. During 2024, forfeited amounts used to reduce Employer matching contributions totaled \$36,348, and forfeited amounts utilized to pay Plan expenses totaled \$64,817.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). References to the ASC hereafter refer to the Accounting Standards Codification established by the Financial Accounting Standards Board (FASB) as the source of authoritative US GAAP.

Investment Valuation and Income Recognition

The Plan's investments in mutual funds and common/collective trusts are stated at fair value at December 31, 2024 and 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 10 for a discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

The Plan's investment in the group annuity contract is stated at contract value at December 31, 2024, as more fully described in Note 8.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gains and/or losses are reported the day after the trade date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes are reclassified as distributions based upon terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The process of preparing financial statements in accordance with U.S. GAAP requires the use of estimates and assumptions regarding certain types of assets and liabilities, revenues and gains, and expenses and losses. Such estimates primarily relate to unsettled transactions and events as of the date of the financial statements. Accordingly, upon settlement, actual results may differ from estimated amounts.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. A portion of the administrative expenses incurred by the Plan are absorbed by the Company, while remaining fees, including recordkeeping fees and investment advisory fees, are paid by the Plan. Fees related to the administration of participant loans and other transactional fees are deducted from the applicable participant's account. Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of earnings (losses) on investments.

Subsequent Events

The Plan has evaluated subsequent events through August 25, 2025, the date the financial statements were available to be issued.

NOTE 3 CONCENTRATIONS, RISKS, AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 4 INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation on investments, other income, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company dba: Principal Trust Company (Principal).

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all participants would become fully vested in their account balances.

NOTE 6 TAX STATUS

The Plan is based on the Prototype Non-Standardized Profit Sharing Plan under a cash or deferred arrangement with American Funds Distributors, Inc. (American Funds) (a subsidiary of Capital Bank and Trust Prototype Non-Standardized Profit Sharing Plan under a cash or deferred arrangement offered by Principal (the trustee of the Plan), which received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the prototype plan was designed in accordance with the provisions of the IRC. The Plan has assets under both trustees. The Plan has not filed for its own opinion letter from the IRS; however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The related trust, therefore, is not subject to tax under present income tax law. U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 NONEXEMPT TRANSACTIONS

In 2023, the Company failed to remit employee 401(k) deferral contributions for certain payroll periods within the time frame prescribed by the Department of Labor. This is deemed a prohibited transaction in accordance with ERISA and the IRC. The Company corrected the prohibited transaction in the 2024 Plan year by depositing the lost earnings, filing the required Form 5330 with the IRS and paying the appropriate excise tax.

NOTE 8 INVESTMENT AT CONTRACT VALUE

The Plan invests in the Principal Guaranteed Option (the Contract), which is a benefit-responsive group annuity contract issued by the Principal Life Insurance Company (PLIC). The Contract is a traditional investment contract that meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. Contract value does not fluctuate with the stock and bond markets. A rate of interest contractually guaranteed by PLIC is credited to participant account balances.

Changes in future interest crediting rates will not affect the amount reported as an adjustment from fair value to contract value on the statements of net assets available for benefits for the portion of net assets attributable to fully benefit-responsive investment contracts.

Participant-initiated, benefit-responsive Plan withdrawals from the contract and transfers between investment options are allowed under the specific terms of the Plan. By definition, the Contract is an insurance contract. As a result, the Plan may transact according to the terms defined in the Contract at any time. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Termination of the Plan's interest in the Contract will be made pursuant to the Plan Sponsor's request; however, it may be subject to surrender charges. The issuer has the right to no longer receive deposits if it has announced that it will no longer establish new guaranteed interest balances. However, the circumstances for termination of the Contract may still be subject to the surrender charges.

NOTE 9 PARTIES IN INTEREST

Certain investments are managed by Principal, and therefore, these investments are party-in-interest transactions. Notes receivable from participants represent loans to employees and therefore, also qualify as party-in-interest transactions. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

NOTE 10 FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures* provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 10 FAIR VALUE MEASUREMENTS (CONTINUED)

There has been no change in the methodology used at December 31, 2024 and 2023. The following is a description of the valuation methodology used for assets measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trusts: Each unit in a common/collective trust invest directly in a unit of a mutual fund. Unit values are calculated base on the observable net asset value (NAV) of the underlying investment in the mutual fund. Most of the security prices are obtained from a pricing service. The NAV is not publicly quoted, but is available to current investors via Principal's website, and the investments are deemed to have a readily determinable fair value.
