## INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Administrator  
Irwin R. Rose & Company, LLC 401(k) Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Irwin R. Rose & Company, LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

## 1. DESCRIPTION OF THE PLAN:

The following description of the Irwin R. Rose & Company, LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan sponsored by Irwin R. Rose & Company, LLC and includes participation of certain other employers (collectively, the Company or Employer) for the benefit of eligible employees who have three months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Management and the Plan Administrator are responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to management and the Plan Administrator.

### Contributions

The Plan permits participants, through a salary deferral election, to make pre-tax or Roth contributions of up to 80% of eligible compensation, subject to the maximum annual amount permitted under Section 402(g) of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect another deferral election. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company makes a nonelective safe-harbor contribution to the Plan equal to 3% of each participant's eligible compensation. A participant must have one year of service and continually complete 1,000 service hours, per Plan year, in order to be eligible for the contribution. The Company made nonelective safe-harbor contributions of \$270,739 for 2024.

The Company may also elect to make discretionary matching contributions to the Plan. A participant must have one year of service and be an active employee on the last day of the Plan year in order to be eligible for the contribution. The Company made discretionary matching contributions of \$55,629 for 2024.

The Company may also elect to make discretionary regular or special profit-sharing contributions to the Plan. Regular profit-sharing contributions are allocated to participants based on eligible compensation with additional allocation based on the taxable Social Security wage base. Special profit-sharing contributions are allocated based on 1% of the total compensation paid to eligible participants. Eligible participants are those individuals who are not "highly compensated" employees, and who, by the end of the Plan year, have either: (1) attained the age of 55 and have completed ten years of service, or (2) completed fifteen years of service. The Company made regular and special profit-sharing contributions of \$300,366 for 2024.

Participants direct the investment of their contributions as well as the Company's contributions into various investment options offered by the Plan. Contributions are subject to certain limitations as defined by the Internal Revenue Service (IRS).

**Participant accounts**

Each participant's account is credited with the participant's contributions, Company nonelective safe-harbor contributions, Company discretionary matching contributions, as well as allocations of the Company's regular and special profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions and the nonelective safe-harbor contributions plus earnings thereon. Vesting in the Company's discretionary matching, regular and special profit-sharing contributions portion of their account is based on years of service and is defined as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 2	0%
More than 2 but less than 3	20%
More than 3 but less than 4	40%
More than 4 but less than 5	60%
More than 5 but less than 6	80%
6 or more	100%

**Payment of benefits**

Upon termination of service due to death, disability, retirement, or any other type of termination, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. All distributions are subject to the applicable provisions of the Plan Agreement and limitations of the IRC.

**Forfeited accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$12,599 and \$13,764, respectively. These accounts may be used to reduce future Company contributions and administrative expenses. During 2024, Plan expenses were reduced by \$16,603 and employer matching contributions were reduced by \$12,245 from forfeited nonvested accounts.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

**Basis of accounting**

The financial statements are prepared on the accrual basis of accounting.

**Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the

reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of benefits**

Benefit payments to participants are recorded when paid.

**Administrative expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent events**

The Plan has evaluated subsequent events through August 26, 2025, the date the financial statements were available to be issued.

**3. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE:**

Plan management has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**4. FAIR VALUE MEASUREMENTS:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;

- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual and money market funds:* Valued at the daily closing price as reported by the fund. These funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. These funds held by the Plan are deemed to be actively traded.

*Collective trust fund:* Valued at the unit price reported by the sponsoring trust company. The underlying investments owned by the fund can include money market funds, stable value funds, fixed-income securities, registered investment companies, common stocks, corporate bonds, U.S. Government securities, other collective trust funds, or guaranteed investment contracts priced by the sponsoring insurance company using applicable interest rates and contract provisions. The unit price is based on the fair value of these underlying investments owned, less any accrual of fees and expenses borne by the fund and divided by the number of units outstanding. The unit price is readily determinable and quoted on the active private market on which participants can transact daily with no redemption restrictions on these investments.

**5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:**

Certain Plan investments are managed by Fidelity Investments. Fidelity Investments is an affiliate of Fidelity Management Trust Company, the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

**6. PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their nonelective Employer contributions.

**7. TAX STATUS:**

The Company adopted a non-standardized pre-approved profit sharing plan which received a favorable opinion letter from the IRS dated June 30, 2020. The IRS stated in the letter that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has since been amended. While the Company has not obtained its own determination letter on the Plan, management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**8. RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
