For information included in the supplemental schedule that agreed to or are derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of Plan

The following description of the Procon Consulting, LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. More complete information regarding the Plan’s provisions may be found in the Plan document.

General

The Plan is a defined contribution plan covering all employees of Procon Consulting, LLC, (the “Employer” or the “Plan Sponsor”), who are at least 18 years of age and have completed three months of service, except union employees and non-resident aliens, (“Participants”). Employees may enter the Plan on the first day of the calendar month following the satisfaction of eligibility requirements.

Reliance Trust Company (“Reliance”) provides trustee and custodial services for the Plan. The Plan Sponsor has contracted T. Rowe Price (“TRP”) to provide certain recordkeeping and administrative services to the Plan pursuant to a Retirement Plan Recordkeeping Service Agreement (“RSA”). TRP has retained Reliance as a subcontractor to provide the services under the RSA on behalf of TRP. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). All investments are Participant directed.

Plan Administration

The Employer is the plan administrator and has the authority to appoint person(s) or entities to carry out the operation of the Plan. Individual participant accounts may be charged directly with an allocation of administrative expenses, if not paid by the Employer.

Subsequent Events

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date the financial statements were available to be issued, which is August 4, 2025.

Participant Contributions

Each year, Participants may defer a portion of their eligible compensation, as defined by the Plan, not to exceed a dollar limit established under the Internal Revenue Code (the “IRC”). Participants may make pre-tax or Roth contributions to their accounts. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“Rollovers”).

Employer Safe Harbor Matching Contributions

All participants who have made elective contributions during the Plan year are eligible for safe harbor matching contributions. For the year ended December 31, 2024, the Employer safe harbor match was equal to 100% of the Participants’ contributions up to 4% of the Participants’ eligible compensation.

Employer Non-Elective Contributions

The Employer, at its discretion, may make a non-elective contribution to the Plan. Any non-elective contributions are allocated to Participants based upon an amount to be designated by the Employer to be allocated to groups. Each Participant is considered one group, as defined in the Plan document. For the year ended December 31, 2024, the Employer elected not to make a non-elective contribution to the Plan.

Participant Accounts

Each Participant's account is credited with the Participant's deferral contributions, the respective Employer contributions, an allocation of the Plan's investment earnings or losses, and is charged with an allocation of certain administrative expenses. Allocations are based on participant compensation, groups, or account balance, as defined in the Plan document. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account balance.

Vesting

Participants are immediately vested in deferral contributions, Employer contributions, and the investment earnings thereon.

Notes Receivable from Participants

Subject to approval by the plan administrator, Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. A Participant may only have one loan outstanding at a time. Loan terms extend up to five years (or longer for the purchase of a primary residence). Loans are secured by the vested balance in the Participant's account and bear interest at a rate deemed reasonable by the Plan Sponsor. Principal and interest are paid ratably through payroll deductions. The interest rates on loans outstanding at December 31, 2024 and 2023 ranged from 4.25% to 10.50%. Loans outstanding at December 31, 2024 and 2023 mature through June 2, 2037.

If a Participant ceases to make loan repayments, the plan administrator can deem the loan to be in default. When a distributable event occurs, the Participant's loan balance is reduced, and a benefit payment is made in accordance with the Plan document. Loans to Participants are reported as notes receivable from Participants at the unpaid principal balance plus any accrued but unpaid interest.

Payment of Benefits

Upon termination of service due to death, disability, termination, or retirement, a Participant (or beneficiary) may elect to receive a lump sum distribution in an amount equal to the value of the Participant's vested interest in his or her account. If a terminated Participant's vested account balance is less than \$7,000, and the Participant does not elect to have the distribution paid directly to an eligible retirement plan or receive the distribution as a lump-sum, then the plan administrator may distribute the account balance to an individual retirement arrangement designated by the plan administrator. If a Participant's account balance is less than \$1,000, the Plan administrator may distribute the account balance to the Participant in a lump-sum payment.

In-service withdrawals from the Participant's vested account balance is permitted upon reaching age 59 ½, normal retirement age 65, at any time from a Participants' rollover account, or upon a deemed severance from employment, as defined in the Plan document. In-service withdrawals are also permitted due to financial hardship, as defined in the Plan document. Hardship withdrawals may be taken from the Participant's deferral contribution accounts, Employer non-elective contribution accounts, and rollover accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires plan management to make estimates and assumptions that affect the reported amounts if assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Fair Value Measurements

The Plan follows GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered by the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and classified as Level 1 within the fair value hierarchy.

Fair Value Measurements (continued)

Money Market Funds: Valued at daily closing price reported on the active market on which the individual securities are traded and classified as Level 1 within the fair value hierarchy.

Investments, Investment Valuation, and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is reported on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought, sold, and held during the year.

Notes Receivable from Participants

Interest income on notes receivable from Participants is recognized on the accrual basis of accounting. Related fees are recorded as administrative expenses and expensed when incurred.

Payment of Benefits

Benefit payments to Participants are recorded during the period in which the Participant is paid.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4(i), Schedule of Assets (Held at End of Year), including investments, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend and interest income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance.

4. Risks and Uncertainties

The Plan invests in investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect Participants' account balances and the amounts reported in the statements of net assets available for benefits.

4. Risks and Uncertainties (*continued*)

The global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.

5. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time or to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, any unallocated assets of the Plan will be allocated to participant accounts and distributed in such a manner as the Employer may determine.

6. Tax Status

The underlying prototype non-standardized profit-sharing plan received an opinion letter on June 30, 2020 from the Internal Revenue Service ("IRS"), stating that the form of the plan is qualified under Section 401(a) of the IRC. Any employer adopting this format of the Plan will be considered to have a plan qualified under Section 401(a) of the IRC. The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS and that the Plan is qualified as of the date of this report.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Part-In-Interest Transaction

Plan investments include mutual funds that are managed by T. Rowe Price. Accordingly, these transactions qualify as exempt party-in-interest transactions. The Plan paid administrative expenses of \$7,748 to T. Rowe Price. during the year ended December 31, 2024. Notes receivable from Participants also qualify as exempt party-in-interest transactions as defined by ERISA.
