Hello,

The purpose of this letter is to address a late filing notice that I received from the Internal Revenue Service (Form 5558). I received this letter (see attached) dated August 15th, 2025, and I received this letter on August 18th, 2025. If the 2024 Form 5500 was returned I was never informed by ADP.

This 401K account was officially terminated on 08/30/2024 assets reflecting a zero balance. I never received any notifications regarding the need for an extension. This letter caught me completely off guard. I was under the understanding this account had been closed and terminated, so I have not idea as to the need for any extension not to mention the first of any notification I have received regarding this matter.

If ADP filed for an extension of time, they used the wrong Form which should have been Form 8868 not a Form 5558. Again, I was never informed as to why this was being done until I received the previously mentioned IRS letter.

Please let me know if there is anything else you may need to bring closure to this matter. I will be working with the ADP Retirement Compliance Department to bring this to closure.
