Note 1 – Plan Description

The following brief description of the Transport Refrigeration, Inc. 401(k) Profit Sharing Plan (Plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

General

The Plan is a defined contribution pension plan covering substantially all employees of Transport Refrigeration, Inc. (Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The administrative committee is responsible for oversight of the Plan and for determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Employees become eligible to participate in the Plan after completing 60 days of service and having attained age 18. Eligible employees may begin participating in the Plan on the first day of the of the month coinciding with or following the date the eligibility requirements are met.

Contributions

Employee contributions are limited to thresholds set by the Internal Revenue Code. Participants may elect to contribute pretax or after tax amounts from their compensation. Participants who have obtained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation.

Employees become eligible for matching and discretionary Company contributions after completing twelve months of service with at least 1,000 hours and having attained age 18. Annually, the Company's discretionary contribution amount is determined based on the profitability of the Company. Participants must be employed as of the last day of the year to be eligible for the discretionary Company contribution. There were no discretionary contributions for 2024. For the year ended December 31, 2024, the matching contribution was 50% of participant deferrals up to 5%. The matching contribution is remitted periodically throughout the year along with employee contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, an allocation of the Company's discretionary contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions, rollover contributions, and actual earnings on these contributions. Vesting in matching and discretionary contributions and related earnings is based on years of continuous service. A participant is 100% vested after six years of credited service.

Forfeited Accounts

The Plan provides that upon a participant's termination, the participant's non-vested interest in his or her account is forfeited when the participant receives a distribution of the entire vested interest and that forfeitures will be used to reduce the Company's matching contribution. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,101 and \$281, respectively. During the year ended December 31, 2024, forfeitures of \$14,578 were used to reduce employer contributions. During the year ended December 31, 2024, forfeitures of \$4,862 were used to reduce plan expenses.

Note 1 – Plan Description (Continued)

Payment of Benefits

Prior to termination of employment, participants may elect to receive an in-service distribution from their accounts which are 100% vested and are subject to possible administrative limitations and other restrictions. In addition, hardship distributions are also available from pre-tax deferral and Roth deferral accounts, if certain conditions are satisfied.

On termination of service due to death, disability or retirement, a participant (or beneficiary) may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or in installment payments over a period not to extend beyond the participant's (or beneficiary's) life expectancy. For termination of service for other reasons, a participant may receive the value of their vested interest as a lump sum distribution.

Note 2 – Summary of Significant Accounting Policies

The Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments in mutual funds and the common trust fund are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Subsequent events were evaluated through August 19, 2025, which is the date the financial statements were available to be issued.

Note 3 – Tax Status of Plan

The Plan adopted a Prototype Non-standardized Profit Sharing Plan with a cash or deferral arrangement. The prototype plan received a favorable determination letter from the Internal Revenue Service (IRS) dated June 30, 2020. As such, the Plan qualifies under Section 401(a) of the Internal Revenue Code (IRC) and, therefore, is not subject to tax under present income tax laws. Although the prototype plan has been amended since 2020, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 4 – Party-In-Interest Transactions

Certain Plan investments are managed by JP Morgan. Empower Trust Company is the custodian as defined by the Plan. Transactions with Empower Trust Company and JP Morgan qualify as party-in-interest transactions. Fees paid by the Plan for the investment recordkeeping services to JP Morgan amounted to \$16,985 for the year ended December 31, 2024.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 6 – Information Certified by Plan’s Custodian

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year then ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company (the custodian of the Plan).

Note 7 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (level 1 inputs).

Common Trust Fund: Valued at the net asset value (NAV) of units held by the trust at the end of the day of valuation based upon the market value of the underlying investments. The NAV readily determinable fair value was used, since it was determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Thus, the Plan values these as level 2 investments. The Plan has the ability to redeem its underlying investments at the NAV at the valuation date.
