### **Opinion**

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Bank of Commerce Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of The Bank of Commerce profit sharing plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about The Bank of Commerce profit sharing plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.


## Supplemental Schedules Required By ERISA

**1. Description of Plan**

The following description of The Bank of Commerce (“the Bank”) Profit Sharing Plan (“Plan”) provides only general information. Participants and other financial statement users should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all employees of the Bank who are 18 years of age and who have completed two years of service with a minimum of 1,000 hours per year. Once eligible, an employee receives his or her portion of the employer's contribution for each year in which the employee works a minimum of 1,000 hours. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Participant contributions are not allowed under the Plan, with the exception that rollover contributions from other retirement plans and certain IRAs are allowed at the discretion of the Plan Sponsor, effective November 1, 2014. The Bank contributes a discretionary portion of its net profits to the Plan as determined annually by the directors of the Bank.

**Participant Accounts**

Each participant's account is credited with allocations of (a) the Bank's contribution and (b) Plan earnings. Participants receive an allocation of the Bank's contribution if they have worked a minimum of 1,000 hours in the year of contribution and are employed at the end of the year. Participants who retire, become disabled, or die during the year are also eligible to receive a portion of the Bank’s contribution. Allocations are based on participant wages, as defined by the plan.

Occasionally, the Bank will reimburse the Plan for administrative expenses. These reimbursement contributions are allocated based on account balances of participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in all contributions plus actual earnings thereon through the end of the previous calendar year. Participants are also vested immediately in any rollover contributions.

**Notes Receivable from Participants**

The Plan administrator has not adopted a loan policy for the Plan.

**1. Description of Plan (continued)**

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum or partial distribution up to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant will automatically receive the value of the vested interest in his or her account as a lump-sum distribution if \$1,000 or less; otherwise, the Plan will distribute the vested balance as directed by the participant. Participants with account balances of less than \$5,000 may only receive distributions in a single lump-sum payment. Participants with vested balances of more than \$5,000 may elect to receive distributions either in a single lump-sum payment or partial withdrawals of at least \$1,000. Effective November 1, 2014, the Plan was amended to allow distributions of vested amounts from the Plan prior to the participant's termination of employment provided the participant is at least 59 ½ years of age. The Plan was also amended to allow in-kind distributions of life insurance policies regardless of the age of the participant.

**Forfeitures**

As participants are vested immediately, there were no forfeited nonvested accounts at December 31, 2024 or 2023.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**2. Summary of Significant Accounting Policies (continued)**

**Investment Valuation**

The Plan's investments are stated at fair value, unless otherwise stated. Amortized cost or original cost plus accrued interest are used to value certificates of deposit classified as investments. Shares of registered investment companies are valued at quoted market prices which represent the fair value of shares held by the Plan at year-end. Life insurance policies are valued at their cash value as reported by the issuer of the contract, which represents the fair value at year-end.

Net appreciation (depreciation) caused by fluctuations in the market value of investments is reflected in the Statement of Changes in Net Assets Available for Benefits. Amounts invested earn interest and dividends, which in turn are reinvested.

Purchases and sales of securities are recorded on a trade-date basis. Income from interest and dividends is recorded on the accrual basis. Capital gain distributions are included in dividend income.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

According to uniform rules, the Plan Administrator may charge expenses to a particular investment fund or to participants' accounts if the Plan Administrator determines that such allocation of expense is desirable for the equitable administration of the Plan. The Plan pays for the majority of administrative expenses which include accounting and consulting fees, as well as investment fees.

**Subsequent Events**

In preparing these financial statements, the Bank has evaluated events and transactions for potential recognition or disclosure through July 17, 2025, the date on which the financial statements were available to be issued.

**3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

All investments of the Plan are valued using a market approach.

The Plan's Level 1 assets are made up of investments in mutual funds and short term investments with quoted prices for identical assets in active markets.

The Plan's Level 2 investments are made up of Certificates of Deposit with readily available face values.

The Plan had no Level 3 assets as of December 31, 2024 and 2023.

**4. Related Party Transactions and Party-In-Interest Transactions**

Plan assets include certificates of deposit held with The Bank of Commerce Trust Department totaling \$3,519,614 and \$5,910,492 as of December 31, 2024, and 2023, respectively. During 2024, gross proceeds from sales of certificates of deposit held with The Bank of Commerce totaled \$8,613,319 and purchases of certificates of deposit totaled \$6,222,442. The Bank is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

**5. Plan Termination**

Although it has not expressed any intent to do so, the Bank has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**6. Income Tax Status**

The Internal Revenue Service has determined and informed the Bank by letter dated March 31, 2008, that the Plan was designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax years in progress. The Plan Administrator believes it is no longer subject to examinations for years prior to 2021.

**7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefit.
