**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Heimark Distributing, LLC 401(k) Plan (the "Plan") provides only general information about the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all eligible employees of Heimark Distributing, LLC (the "Plan Sponsor") and Triangle Distributing Co., a participating employer (collectively, the "Company"). The Plan, which commenced on March 1, 1967, is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and is qualified under Section 401(a) of the Internal Revenue Code (the "IRC").

The Plan is administered by Heimark Distributing, LLC. T. Rowe Price Trust Company ("T. Rowe") is the Plan's trustee.

Eligibility: At the date of hire, employees are eligible to make participant contributions and may enter this part of the Plan. Plan participants are eligible for Company discretionary contributions upon meeting the service requirement of one year of service. Upon completion of the service requirement, the participant will enter this portion of the Plan on January 1<sup>st</sup> or July 1<sup>st</sup> that coincides with the next entry period following the completion of the service requirement.

Participation in the Company discretionary contributions commences in the year following the date the participant has entered the Plan provided they have completed 1,000 hours of service in that Plan year and are employed as of the end of the Plan year.

Contributions: Each participant may elect to contribute on a pre-tax basis, or on an after-tax basis as Roth 401(k) contributions, up to 75% of his or her eligible compensation to the Plan subject to certain IRC limitations, up to a maximum amount of \$23,000 for the 2024 plan year. Participants may also rollover amounts representing distributions from other qualified plans. Participants that are 50 years of age or older who have met the annual IRC deferral limit or the specified Plan limits for deferral, may contribute a catch-up deferral of up to \$7,500 for 2024.

The Plan provides for an auto-enrollment feature whereby a participant is automatically enrolled in the Plan to make contributions at 5% of eligible compensation unless the participant affirmatively opts out. In addition, the Plan provides for an automatic election escalator feature whereby participants, including participants that made an election to contribute at a rate less than the default contribution rate of 5%, will have their deferral rate increased each year by 1% until their deferral rate reaches 5%, unless the participant elects out of this treatment as prescribed by the Plan document.

Effective February 3, 2025, the default contribution percentage for the auto-enrollment feature was increased to 6%.

Employer contributions to the Plan are discretionary and are made by the Company in amounts determined by its Board of Directors. Discretionary contributions are allocated to eligible participants on a pro-rata basis, based on the percentage that each participant's compensation bears to total compensation for the plan year, as defined in the Plan. During the years ended December 31, 2024 and 2023, Company discretionary contributions were \$630,000 and \$590,000, respectively.

**NOTE 1 - DESCRIPTION OF PLAN** (Continued)

Vesting: Participants are immediately vested in their elective contributions plus actual earnings thereon. Company contributions and related earnings thereon vest over a six-year period as follows: 10% for years one and two, and 20% for each of years three through six. However, Company contributions and related earnings become fully vested if the participant reaches age 65, becomes permanently disabled or dies.

Participant Accounts: Each participant's account is credited with his or her elective contributions and the allocable portion of the Company's contributions and Plan earnings. Company contributions and forfeitures are allocated to participants' accounts proportionately based on annual compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Contributions made on behalf of the participants are invested in various funds according to participant elections. Participants' contributions must be allocated among the available funds in whole percentages. Participants may change investment elections at any time via telephone or via internet access with the Custodian.

Forfeited Accounts: If a participant's employment is terminated before full vesting of Company contributions and related earnings, the amount not vested is allocated to the remaining participants. During the years ended December 31, 2024 and 2023, forfeitures of \$47,646 and \$11,943, respectively, were allocated to participants. At December 31, 2024 and 2023, there were unallocated forfeitures of \$29,927 and \$47,646, respectively, held by the Plan.

Payment of Benefits: Upon termination of service due to death, disability, retirement or other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account. These payments may be paid in a lump sum payment.

Any withdrawals made prior to the participant attaining age 59½ for any reasons other than for death or disability is subject to a 20% federal excise tax.

Hardship Withdrawals: A withdrawal from a participant's account may be permitted if the participant has a financial hardship for certain specific reasons as defined in the Plan document. There were no hardship withdrawals during the years ended December 31, 2024 and 2023.

Notes Receivable from Participants: Participants may borrow from their accounts up to 50% of their vested account balance up to a maximum of \$50,000. Participant loan withdrawals can only be redeemed from their elective deferral and rollover sources of their balance. The loans are secured by the balance in the participant's account and must be repaid at a fixed interest rate, which is commensurate with local prevailing rates. Loans must be repaid within five years, unless the loan was for the purchase of a personal residence. In this case, the repayment period may be extended. Participants may only have one loan outstanding at a time.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates: The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could materially differ from those estimates.

Investment Valuation and Income Recognition: Investments are stated at fair value (see Note 4). Net appreciation or depreciation for the period is reflected in the accompanying statements of changes in net assets available for benefits. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is treated as a deemed distribution to the participant on the date of default; however, the participant loan balance continues to be included in notes receivable from participants until the account balances of the defaulted borrower are distributed from the Plan.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of promissory notes from participants are charged directly to the participant's account and are included in loan fees. Investment-related expenses are included in net appreciation in fair value of investments.

Other income: T. Rowe Price Retirement Plan Services, Inc. ("TRP RPS") provides fee credits to the Plan in recognition of the amounts TRP RPS receives from Plan investment options. The pricing credits are allocated to the Plan accounts of participants in proportion to their account balances invested in those investment option. To the extent the pricing credits received into the Plan exceed the Plan's administrative expenses, the excess is allocated on an annual basis to participants in March of the following year based upon the participant account balances as of December 31 of the plan year. The fee credits are included in net appreciation in fair value of investments.

Payment of Benefits: Benefits are recorded when paid. Participants terminating employment are entitled to a distribution of their vested portion of accrued benefits.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks, such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of those investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through August 20, 2025, which is the date the financial statements were available to be issued.

### **NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by T. Rowe Price Trust Company (the trustee of the plan).

### **NOTE 4 - FAIR VALUE MEASUREMENTS**

Accounting guidance defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal, or in the absence of a principal market, the most advantageous market for the asset or liability, in an orderly transaction between market participants on the measurement date. A fair value hierarchy was established that requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The guidance describes three levels of inputs that may be used to measure fair value:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The following is a description of the valuation methodologies used for the investments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Investments in Mutual Funds: The fair value of the Plan's investments in mutual funds is determined based on quoted prices in active markets, which represent the net asset value ("NAV") of the shares held and are classified as Level 1 investments.

**NOTE 5 - TAX STATUS**

The Company has adopted a T. Rowe Price Trust Company prototype plan. The Internal Revenue Service ("IRS") issued an opinion letter dated August 19, 2020, stating that the prototype plan was designed in accordance with applicable IRC requirements as of that date. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the prototype plan and with the applicable requirements of the IRC. Accordingly, no provision for income taxes is reflected in the accompanying financial statements. Continued qualification is dependent on the Plan's future operations.

**NOTE 5 - TAX STATUS** (Continued)

In accordance with U.S. GAAP, the plan administrator is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain income tax position that is more-likely-than not to be sustained upon audit by the IRS. An uncertain income tax position will not be recognized if it has less than a 50% likelihood of being sustained. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require the recognition of a liability (or asset) or disclosure in the financial statements. The plan administrator does not foresee material changes to the gross uncertain income tax position liability (or asset) of the Plan within the next twelve months.

The Plan is subject to routine audits by the IRS, however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

**NOTE 6 – RIGHTS UPON PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balances.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain Plan investments are in investments managed by the Trustee. In addition, the Plan has loans with its participants. Both the Trustee and the participants are considered parties-in-interest under ERISA. TRP RPS, an affiliate of the Trustee, serves as the recordkeeper to maintain the individual accounts of each Plan participant. Fees paid by the Plan to TRP RPS amounted to \$41,295 and \$35,615 for the years ended December 31, 2024 and 2023, respectively. These transactions are considered exempt party-in-interest transactions under ERISA.
