Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Tricoci University of Beauty Culture 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

NOTE A - DESCRIPTION OF PLAN

The following description of Tricoci University of Beauty Culture 401(k) Profit Sharing Plan and Trust (Plan) only provides general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Management has evaluated subsequent events through August 19, 2025, the date the financial statements were available to be issued and has no material subsequent events to report.

General

The Plan is a defined contribution plan covering substantially all eligible employees of Tricoci University of Beauty Culture, LLC (Company, Employer or Sponsor). The Plan is qualified under the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). For salary deferrals, eligible employees must be at least 18 years of age. There is no service requirement to be eligible to participate in employee deferral, employer matching, or profit-sharing portions of the Plan.

Contributions

Participants may make pre-tax contributions and Roth contributions between 1% and 90% of annual compensation to the Plan up to the maximum percentage allowable by the IRC. Plan limits are indexed to follow changes in the federal limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a collective trust as investment options for participants.

The Employer may elect to make matching contribution equal to 50% of an eligible participant's elective deferral contribution. Elective deferrals greater than 3% of eligible compensation will not be matched. Catch-up contributions will also be matched. The Employer did not elect to make any matching contributions for the year ended December 31, 2024.

The Employer may also elect to make a discretionary profit sharing contribution. Profit sharing contributions, if any, are determined annually by the Employer. The participant's share of the profit sharing contribution is based on the proportion of the participant's compensation to the total compensation for all eligible participants. The Employer did not declare a profit-sharing contribution for the year ended December 31, 2024.

Participant Accounts

Each participant account is credited with the participant's contribution and (a) the Employer's matching contribution, (b) an allocation of the Employer's profit sharing contribution, if any, (c) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are immediately vested in their contributions and associated earnings thereon. Vesting in the Employer contribution portion of their accounts is based on years of continuous service. Participants become 100% vested in Employer contributions after five years of service, earned in successive annual increments of 25% beginning after the second year.

Notes Receivable from Participants

Participants can borrow from their account a minimum of \$500, up to a maximum of \$50,000, or 50% of their vested account balance, whichever is less. Notes receivable terms range from one to five years except when the use of proceeds is for the purchase of a primary residence in which the term length shall not exceed 30 years. The notes receivable are secured by the balance in the participant's account and bear interest at the prime rate in effect at the loan's inception plus 2%. The loans outstanding at December 31, 2024 have interest rates of 5.25% to 10.50%. Repayments are made through payroll withholdings in accordance with terms of the applicable promissory notes. A \$125 application fee is charged by the Plan to each loan recipient.

Payment of Benefits

Participants receive benefit payments based on the vested portion of their account balance upon death, retirement, disability, or termination of employment. Benefit payments in amounts defined by law as "required minimum distributions" must commence by age 73, unless the participant is an active employee. All benefits other than "required minimum distributions" may be paid in the form of a lump sum, or in installment payments over a period not to exceed the participant's and beneficiary's expected life expectancies.

Participants may request a distribution of a portion of their contributions in the event of a documented financial hardship. The distribution is limited to the amount of the hardship, which must arise from certain events prescribed by law.

Forfeited Accounts

Forfeited accounts may be used to pay Plan administrative expenses or to reduce any Employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$31,256 and \$20,393 respectively. During the year ended December 31, 2024, no forfeitures were used to pay Plan administrative expenses or were used to reduce Employer contributions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Valuation of Investments and Investment Income

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Gains and losses are determined on the basis of specific identified cost. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Participant loans are presented at their unpaid principal balance plus accrued interest. Interest income is recognized monthly on the accrual basis. Loans are considered to be in default and are deemed distributions to participants if a participant fails to make a scheduled payment by the end of the calendar quarter following the calendar quarter in which the missed payment was due.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

The Plan trustee and third-party administrator charge various administrative fees relating to recordkeeping services performed under contract to the Plan. Under no circumstances will compensation be paid by the Plan to the Employer for services rendered as administrator. The Employer paid \$24,182 in operating expenses on behalf of the Plan during the period ended December 31, 2024.

NOTE C - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820 - *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1 - Inputs in the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

Quoted prices for similar assets in active markets.

Quoted prices for identical or similar assets in inactive markets.

Inputs other than quoted prices that are observable for the asset.

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan at year end.

Common collective trust: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Accordingly, Reliance Trust Company, a qualified institution, has certified that the following information included in the accompanying financial statements and the ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Interest (including interest on notes receivable from participants), dividends and net appreciation of investments as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets (held at end of the year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of management, the Plan's independent auditor did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statement and ERISA-required supplemental schedule.

NOTE E - RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

NOTE F - PLAN TERMINATION

Although it has not expressed any intention to do so, the Employer may discontinue its contributions to the Plan at any time, and terminate the Plan subject to regulations under ERISA. In the event of a Plan termination, participants will become 100% vested in their entire account balance.

NOTE G - COMMITMENT

The Plan's investments include \$618,068 allocated to participants who have withdrawn from the Plan as of December 31, 2024, but have not yet been paid. These participants may elect to withdraw their vested balances at any time.

NOTES TO FINANCIAL STATEMENTS

NOTE H - TAX STATUS

The Internal Revenue Service has determined and informed the Plan by letter dated October 6, 2020, that the Plan is designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.
