## Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed audits of the accompanying financial statements of Taj Hotels Retirement Savings Program (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## **Notes to Financial Statements**

*(All amounts are in United States Dollars unless otherwise stated)*

### **NOTE 1: DESCRIPTION OF PLAN**

The following description of the Taj Hotels Retirement Savings Program (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan covering substantially all full-time, non-union employees of United Overseas Holdings, Inc. (the “Plan Sponsor/ Plan Administrator”), International Hotel Management Services, Inc. (“IHMS”), IHMS, LLC (“Pierre Hotel”), and IHMS (SF) LLC (“Taj SF”) (collectively, the “Adopting Employers”). The Plan is a qualified salary deferral plan under the provisions of the Internal Revenue Code (“IRC”) sections 401(a) and 401(k). The Plan is subject to the applicable regulations of the Employee Retirement Income Security Act of 1974 (ERISA) and the IRC.

#### *Eligibility*

All full-time, non-union employees of the Adopting Employers are eligible for Plan participation and may enter the Plan upon fulfilment of 3 months of employment.

An employee who has satisfied the eligibility requirements may enter the Plan on the first day of the month, coinciding with or following the date on which he or she meets such requirements.

#### *Investment options*

Upon enrolment in the Plan, a participant may direct contributions to any of the investment options offered by the Plan. No limit exists to how often a participant may change their investment options.

Participants should refer to each fund's prospectus for a more complete description of the risks associated with each fund.

#### *Contributions*

Participants may elect to have a percentage or specified dollar amount deducted from their eligible compensation as defined by the Plan on a pre-tax basis. Eligible compensation for elective deferrals is defined as an employee’s W-2 compensation (including deferrals). Bonuses are excludable compensation as defined by the Plan. A participant can contribute up to 50% of pre-tax annual compensation, as defined by the Plan, up to the annual limit as determined by the IRC. A participant may elect to increase, decrease, or suspend deductions according to procedures established by the Adopting Employers. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Adopting Employers contribute an employer match contribution equal to 100% of an employee’s elective deferrals, not to exceed 3% of the employee’s eligible salary. Catch-up contributions are not matched by the Adopting Employers.

Rollover contributions are comprised of distributions made to the participants from their account balances with their former employers’ qualified plans and transferred to the Plan.

### *Participant accounts*

A separate account is maintained for each participant, which is credited with the participant's contribution and allocations of (a) the Adopting Employers' contributions and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

### *Vesting*

Upon entrance into the Plan, participants are 100 percent vested in their voluntary contributions. The matching contributions provided by the Adopting Employers vest 50 percent after one year of service and 100 percent after two years of service.

### *Forfeitures*

Forfeitures of terminated participants' non-vested accounts serve to reduce the Adopting Employers' employer contributions or Plan expenses. Forfeitures of terminated employees' non-vested accounts totalled \$17,032 during the year ended December 31, 2024, and \$4,030 during the year ended December 31, 2023. As of December 31, 2024, and December 31, 2023, unvested forfeited accounts totalled \$3,683 and \$3,556, respectively. During the years ended December 31, 2024, and December 31, 2023, \$17,112 and \$4,032, respectively, were utilized to reduce employer contributions.

### *Payment of benefits*

Benefits are paid upon retirement (age 65), death, disability, or termination of employment. Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. A participant may apply to the Plan administrator for a hardship withdrawal at any time. This withdrawal must be for an immediate financial need for which funds are not reasonably available from other resources. Hardships include post-secondary educational expenses for the participant or their dependents, medical expenses to the extent not otherwise reimbursed under the Adopting Employers' medical programs, expenses for the purchase of a principal residence or material alterations thereto, payments to prevent eviction from or foreclosure on a principal residence and burial or funeral expenses for the participant's parent, spouse, children, or dependents. At December 31, 2024 and December 31, 2023, there were no amounts allocated to participants who had elected to withdraw from the Plan but had not yet been paid.

### *Plan termination*

Although it has not expressed any intent to do so, the Sponsor and the Adopting Employers have the right under the Plan to discontinue their contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested with the Adopting Employers' contributions.

### *Notes receivable from participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. These loans are secured by the balance in the participant's account and bear interest as determined at the time of the loan origination. Principal and interest are paid ratably through monthly payroll deductions over a period not to exceed five years. If the proceeds are used to construct or rehabilitate a participant's principal residence, the Plan Administrator may permit a longer repayment term. Principal and interest repaid are reinvested based on the participant's present investment allocation selection. The interest rate for all outstanding loans ranged from 4.25% to 9.50% on December 31, 2024, and December 31, 2023.

### NOTE 2: SUMMARY OF ACCOUNTING POLICIES

#### *Basis of accounting*

The Plan prepares its financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”), using the accrual basis of accounting, which recognizes revenue when it is earned and expenses as they are incurred.

#### *Use of estimates*

The preparation of financial statements in conformity with GAAP requires the Plan’s management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities, and the reported amounts of additions and deductions to net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### *Receivable from participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

#### *Payment of benefits*

Benefits are recorded when paid.

#### *Fair value measurements*

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standard are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- 

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

An asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024, and December 31, 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trusts:* Units held in common/collective trusts (CCT) are valued using the NAV practical expedient of the CCT as reported by the issuer of the CCT. The NAV practical expedient is based on the fair value of the underlying assets owned by the CCT, minus its liabilities, and then divided by the number of units outstanding. The CCT may be redeemed at NAV daily without restrictions. As of December 31, 2024, and December 31, 2023, the Plan had no unfunded commitments related to its investments in common/collective trusts, and redemptions are permitted daily at NAV with no advance notice requirement, lock-ups, gates, or other redemption restrictions.

Pursuant to GAAP guidance, alternative investments where fair value is measured using NAV per share as a practical expedient are not categorized within the fair value hierarchy.

#### *Investment valuation and income recognition*

Investments in mutual funds and common/collective trusts are valued at fair value, as provided by the trustees. The mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily NAV and to transact at that price. The common/collective trusts are valued at the NAV of units held by the Plan. The NAV, as provided by the trustees, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Certain investment expenses (e.g., investment management fees and fund operating expenses) are reflected in the net asset value of the underlying funds and are not separately presented as expenses in these financial statements; accordingly, such amounts are included within net appreciation (depreciation) in fair value of investments and, as applicable, interest and dividend income.

#### *Plan expenses*

With the exception of the Plan’s record-keeping fees and expenses related to the notes receivable from participants (loan setup and loan maintenance fees), which are charged to the individual participant’s account, all other administrative expenses incurred by the Plan are paid by the Adopting Employers.

### NOTE 7: TAX STATUS

For the year ended December 31, 2024, and December 31, 2023, the Plan Sponsor entered into a non-standardized arrangement with ADP, LLC, *Non-Standardized Pre-Approved Profit-Sharing Plan* (“CODA”). ADP, LLC has received an opinion letter from the IRS dated October 06, 2020, which stated that the form of the non-standardized pre-approved profit-sharing plan and related trust was designed in accordance with applicable sections of the IRC. It is the opinion of the Plan trustee and the Plan’s attorney that the Plan is in compliance with all applicable laws and regulations.

US GAAP requires plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, and December 31, 2023, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions.

### **NOTE 8: PARTY-IN-INTEREST TRANSACTIONS**

The Plan investments are managed by the trustee. Reliance Trust Company is defined as the trustee, and ADP Retirement Services is the recordkeeper; therefore, these transactions qualify as exempt party-in-interest transactions under ERISA. The Plan's management approves investment options. ERISA considers the recordkeeping fees and participant loan expenses paid to ADP Retirement Services to be party-in-interest transactions.

Participants who are active employees may borrow from their accounts, and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Adopting Employers, who may be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

### **NOTE 9: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. The Plan's exposure to credit losses in the event of non-performance of investments is limited to the carrying value of such investments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits, participant account balances and the statement of changes in net assets available for benefits.

### **NOTE 10: SUBSEQUENT EVENTS**

The Plan evaluated all events and transactions that occurred after December 31, 2024, through the date the financial statements were available to be issued. Based on the evaluation, the Plan states that effective January 01, 2025, the Plan has appointed ADP Retirement Trust Services, LLC ("ADP Trust") as the Plan's Trustee upon the resignation of Reliance Trust Company on December 31, 2024.
