INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Northtown Automotive Companies, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Northtown Automotive Companies, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for reporting and Disclosure under ERISA. Opinion

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTES TO FINANCIAL STATEMENTS FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

1. PLAN DESCRIPTION

The following is a brief description of the Northtown Automotive Companies, Inc. 401(k) Plan, (the “Plan”), provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General Information – The Plan, established in 1971, is a defined contribution plan as permitted under Section 401(k) of the Internal Revenue Code (“IRC”). The Plan is funded by participant and employer contributions and covers all employees of Northtown Automotive Companies, Inc. and Subsidiaries (the “Company” or “Plan Sponsor”) who have attained 21 years of age and achieved at least six months of continuous credited service, as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Principal Life Insurance Company (“Principal”) is the trustee of the Plan’s investments (the “Trustee”). Effective March 27, 2020, the Plan adopted certain provisions of the Coronavirus Aid, Relief, and Economic Security Act (“CARES Act”) which provided economic relief to plan sponsors and participants of employee benefit plans. The Plan has not been formally amended for the adoption of these provisions, however, under the CARES Act, the Plan must be formally amended by December 31, 2025.

Contributions – Contributions to the Plan are made by the participants through salary deferrals and by the Company through matching and additional discretionary contributions. Participants may authorize an elective deferred contribution rate up to the maximum annual limitations as provided by the IRC. The employer contribution is based on one-half of 1% of the first 4% of participants’ contributions. The Company may also elect to make an additional matching contribution and an additional discretionary contribution. No additional matching contributions or discretionary contributions were made during the years ended December 31, 2024 or 2023.

Contributions received from participants for 2024 and 2023 are net of payments of \$202,540 and \$210,560, made in January 2025 and January 2024, respectively, to certain active participants to return excess contributions to satisfy the relevant nondiscrimination provisions of the Plan. These amounts are also included in the statements of net assets available for benefits as excess contributions payable as of December 31, 2024 and 2023.

Vesting – Participants are immediately fully vested in their contributions and the employer matching contributions. Participants become fully vested in any discretionary employer contributions after seven years of service. Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Forfeitures – Forfeitures of nonvested employer discretionary contributions because of participant terminations are allocated to the remaining participants. No forfeitures occurred during the years ended December 31, 2024 or 2023.

1. PLAN DESCRIPTION (continued)

Participant Accounts – Each participant’s account is credited with the participant’s contribution and an allocation of the employer contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations of earnings are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000 up to (a) the lesser of \$50,000 reduced by their highest outstanding note receivable balance during the one year period ending on the day before the date of such note or (b) 50% of their vested account balance.

The notes are secured by the participant’s account and bear interest ranging from 5.25% to 10.50% and mature through January 2030. Principal and interest are paid ratably through payroll deductions. Note terms range from one to five years, unless the loan is for the purchase of the participant’s principal residence.

Payment of Benefits – Participants are eligible for retirement benefits upon reaching age 65. Benefits are determined by the final value of the participant’s account at the time of termination, retirement or death. Early retirement is permitted at age 55. Various payment options are available upon retirement including life income, lump sum cash, and periodic payments.

Administrative Expenses – A significant portion of the costs of administering the Plan are borne by the Plan Sponsor. Fees related to the administration of notes received from participants are charged directly to the participant’s account and are included in administrative expenses.

Benefits Due to Terminated Participants – Net assets available for benefits include benefits of approximately \$7,339,000 and \$8,165,000 due to participants who have terminated employment with the Plan Sponsor as of December 31, 2024 and 2023, respectively.

Withdrawals and Distributions – Unless a participant elects otherwise, distributions will be made as soon as practical after a participant’s normal retirement date or actual retirement date. Participants may receive their accumulated vested benefits held by the Plan’s trustee upon termination of employment, or elect to keep their vested balance in the Plan until the earlier of normal retirement age, death or disability if their account balance is in excess of \$5,000. If the participant elects to keep their vested interest in the Plan, a participant’s account will continue to receive its share of earnings and losses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The Plan prepares its financial statements using the accrual basis of accounting.

Investment Valuation and Income Recognition – The Plan has established standards for determining the fair value of assets and liabilities which are subject to reporting at fair value in accordance with accounting principles generally accepted in the United States of America. These standards establish a hierarchy for the determination of fair value, as well as disclosure requirements relative to those assets and liabilities. The hierarchy identifies three levels of input. Level 1 inputs are generally quoted market prices for identical assets or liabilities, which are actively traded on an exchange. Level 2 inputs generally consist of market prices for identical assets which are not actively traded or market prices of similar assets or liabilities which are actively traded, on an exchange. Level 3 inputs are referred to as unobservable inputs and consist primarily of information derived by management where Level 1 and Level 2 inputs are not available.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

An investment's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value at December 31, 2024 and 2023:

Pooled separate investment accounts: Measured at fair value based on the net asset values ("NAV") of units held by the Plan at year end using the NAV practical expedient.

Mutual funds: Valued based on the quoted market price available on an active market, which represents NAV of shares held by the Plan at year end.

Stable value fund: The stable value fund is fully benefit responsive, and is valued based on the NAV of the underlying investments in the fund using NAV contract value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation in fair value of investments, which includes unrealized and realized gains and losses on investments that were held or sold during the year.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividend income is recognized on the ex-dividend date.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Subsequent Events – Management of the Plan has evaluated the effects of all subsequent events through July 21, 2025, the date which the financial statements were available to be issued, to determine if events or transactions occurring through that date require potential adjustment or disclosure in the financial statements.

3. FAIR VALUE MEASUREMENTS

The Plan uses fair value measurements to record fair value adjustments to certain assets and to determine fair value disclosures (as discussed in Note 2). The following table sets forth, by level within the fair value hierarchy, the Plan's assets that are measured at fair value as of December 31, 2024 and 2023, with the exception of the pooled separate investment accounts and stable value fund, which are measured using the NAV practical expedient. The value for the pooled separate investment accounts and stable value fund are provided below to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

4. INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Plan Sponsor by a letter dated June 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

5. LIFE INSURANCE

The Plan pays the cost of premiums to provide life insurance to participants. The cash value of these policies in addition to Plan assets are used to provide retirement benefits. Since these represent allocated contracts, the cash value is excluded from Plan assets. Premiums paid on life insurance policies amounted to \$5,893 and \$6,875 for the years ended December 31, 2024 and 2023, respectively.

6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. PARTY IN INTEREST TRANSACTIONS

Certain investments of the Plan, including units of pooled separate investment accounts and stable value fund, are managed by Principal. As Principal Life Insurance Company is the Plan trustee, as defined in the Plan document, these transactions qualify as party in interest transactions.

8. CERTIFIED INVESTMENT INFORMATION

The following is a summary of unaudited information regarding the Plan, included in the Plan's financial statements and supplemental schedule. The information was prepared by Principal Life Insurance Company and furnished to the Plan Sponsor. Principal Life Insurance Company has certified that the information is complete and accurate.
