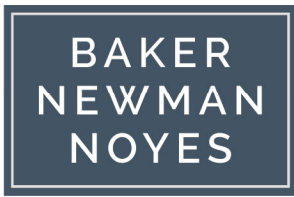

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Lucas Tree 401(k) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of Plan

The following description of the Lucas Tree 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) profit sharing plan. All employees of John Lucas Tree Expert Co. (the Company) are eligible for participation in the Plan upon completion of one year of service and attainment of age 18. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Contributions

Each participant may elect to defer pretax compensation, as defined in the Plan, up to the maximum amounts allowed by the Internal Revenue Service (IRS). The Company's matching contribution is 100% of the first 3% and 50% of the next 2% of compensation that a participant defers. The matching contribution formula complies with the Safe Harbor provisions of the Internal Revenue Code (the Code). The Company may also elect to make a discretionary contribution in any plan year. Any discretionary contribution will be allocated to eligible employees in proportion to their respective amount of compensation to total compensation of eligible participants as defined in the Plan agreement. No discretionary contributions were made for 2024 or 2023.

Forfeitures are used to offset administrative expenses of the Plan. The forfeiture balances at December 31, 2024 and 2023 were \$2,245 and \$5,989, respectively.

At the participant's option, employee and matching contributions may be invested in certain funds offered by the Plan. Participants should refer to each fund's prospectus for further details on the funds' objectives.

Distributions

Participants are entitled to a distribution of their vested benefits at normal retirement age (age 65) or upon separation from service. The Plan also allows for certain in-service withdrawals. The Plan provides for the automatic cash-out of separated employees with account balances up to \$1,000. Effective January 1, 2024, the automatic cash-out provision for separated employees was increased to \$7,000.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. **Description of Plan (Continued)**

Vesting

Participants are immediately vested in their contributions and safe harbor employer matching contributions. Vesting in discretionary employer contributions is based on years of continuous service. The vesting schedule that applies to the discretionary contributions is a 4 year graded schedule with 100% vesting after 4 years of service.

Notes Receivable From Participants

The amount of any note shall be at least \$1,000 and shall not exceed the lesser of \$50,000 or 50% of the vested balance in the participant's account. All notes are repaid according to a fixed repayment schedule not to exceed 5 years, unless it is a note taken exclusively to purchase the participant's primary residence. The notes are secured by the balance of the participant's account. Principal and interest are paid ratably through payroll deduction. Interest rates are based on the prime rate at the time the note is established.

Administrative Expenses

All administrative expenses are paid by the Plan. Certain fees incurred by the Plan for investment management and administrative services are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits as they are paid through revenue sharing rather than direct payment.

2. **Summary of Significant Accounting Policies**

The following are the significant accounting policies of the Plan:

Method of Accounting

The accrual basis of accounting is utilized for reporting purposes.

Contributions

Contributions from employees are recorded during the period in which the Company makes payroll deductions. Employer matching contributions are recorded in the same period as the corresponding employee contributions. Other employer contributions are recorded when the Company commits to making the contribution.

Payment of Benefits

Benefits are recorded when paid.

2. Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

The Plan's investments, other than the group annuity contract, are stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See note 3 for a discussion of fair value measurements. The group annuity contract is carried at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized and unrealized gains and losses related to investments are reported as net appreciation in fair value of investments.

Notes Receivable From Participants

Participant notes receivable are valued at their unpaid principal balance plus any accrued and unpaid interest. No allowance for credit losses has been recorded at December 31, 2024 or 2023. If a participant ceases to make loan payments, the Plan Administrator may deem the participant loan to be a distribution, whereby the loan balance is reduced and a benefit payment is recorded.

Management Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options which in turn invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemics or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent Events

For the purpose of recognition and disclosure in these financial statements, management of the Plan has evaluated subsequent events through August 20, 2025, which is the date these financial statements were available to be issued.

3. **Information Certified and Fair Value Measurements**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the Plan's custodians, except for comparing such information certified by the custodians to information included in the Plan's financial statements and supplemental schedule. The Plan Administrator has determined that the custodians meet the requirements of qualified institutions as defined by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

The Plan's investments, notes receivable from participants, investment income, interest income on notes receivable from participants, and investment and notes receivable transactions as of and for the years ended December 31, 2024 and 2023 were certified as complete and accurate.

Group Annuity Contract

The Plan has a group annuity contract with Empower Annuity Insurance Company of America that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The Key Guaranteed Portfolio Fund is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value represents contributions made under each contract, plus earnings based on the crediting rate, less participant withdrawals, and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting. The average yield earned by the Plan for the Key Guaranteed Portfolio fund for the years ended December 31, 2024 and 2023 was 1.20% and 1.10%, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following:

- (a) Certain amendments to the Plan document (including complete or partial Plan termination or merger with another plan);
- (b) Bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan; or
- (c) The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Fair Value Measurements

The Plan has adopted a framework for measuring fair value under generally accepted accounting principles for all financial instruments that are being measured and reported on a fair value basis.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In determining fair value, the Plan uses various methods including market, income and cost approaches. Based on these approaches, the Plan often utilizes certain assumptions that market participants would use in pricing the asset or liability, including assumptions about risk and or the risks inherent in the inputs to the valuation technique. These inputs can be readily observable, market corroborated, or generally unobservable inputs. The Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. Based on the observability of the inputs used in the valuation techniques the Plan is required to provide the following information according to the fair value hierarchy. The fair value hierarchy ranks the quality and reliability of the information used to determine fair values. Financial assets and liabilities carried at fair value will be classified and disclosed in one of the following three categories:

Level 1 – Valuations based on quoted prices in active markets for identical assets or liabilities. Valuations are obtained from readily available pricing sources for market transactions.

Level 2 – Valuations for assets and liabilities traded in less active dealer or broker markets. Valuation methodologies include: quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Valuations for assets and liabilities that are derived from other valuation methodologies, including option pricing models, discounted cash flow models and similar techniques, and not based on market exchange, dealer, or broker traded transactions. Level 3 valuations incorporate certain assumptions and projections in determining the fair value assigned to such assets or liabilities.

In determining the appropriate levels, the Plan performs an analysis of the assets and liabilities that are subject to fair value measurements. At each reporting period, all assets and liabilities for which the fair value measurement is based on significant unobservable inputs are classified as Level 3.

The mutual funds are valued at the closing price reported in the active market in which the security is traded. There have been no changes in methodology during 2024 or 2023.

4. **Tax Status**

A qualifying plan is one for which the employer may currently deduct contributions on its income tax return, the employee is not currently taxed on the contribution, and the plan income is not taxable. Effective July 1, 2021, the Company has adopted a non-standardized pre-approved 401(k) profit sharing plan sponsored by HUB International Limited. The IRS issued an opinion letter dated June 30, 2020 stating that the pre-approved plan satisfies Section 401(a) of the Code as of the date of the opinion letter. The Plan has subsequently been amended. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by a plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. Management evaluated the Plan's tax positions and concluded that the Plan has maintained its tax exempt status and has taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. **Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. **Related Party Transactions**

Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians, manage several investment funds available to the Plan. Empower Retirement, LLC, an affiliated entity of the custodians, also provides recordkeeping services which are paid by the Plan. In addition, the Plan pays fees to the Plan's independent auditors, Baker Newman & Noyes LLC and the Plan's broker, Commonwealth Financial Network. Transactions with these entities qualify as party-in-interest. Total fees paid by the Plan to these entities for the years ended December 31, 2024 and 2023 aggregated \$33,174 and \$30,180, respectively.
