Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Third Way 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Third Way 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Third Way 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Third Way 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with auditing standards generally accepted in the United States of America will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Third Way 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Third Way 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. 

NOTE A - DESCRIPTION OF PLAN

Third Way 401(k) Plan (the "Plan") is a defined contribution profit sharing plan established on January 1, 2005. Third Way ("TW") is the Plan Sponsor and administrator. Ascensus is the Trustee of the Plan and Vanguard is the recordkeeper of the Plan.

Effective May 15, 2023, the Plan was amended and restated to bring the Plan into compliance with legislative and regulatory changes. There were no other changes in the Plan's provisions.

The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Eligibility

There are no age or service requirements and all employees, except interns, are immediately eligible to join the Plan. Unless the election not to participate is made, eligible employees are automatically enrolled into the plan on the first of the month, subsequent to their date of hire. Automatically-enrolled participants will automatically contribute 3% of compensation into the appropriate target-date fund based on birth year.

Participant Contributions

Eligible participants may elect to defer a percentage of their aggregate compensation, up to the maximum allowable limit of pre-tax or after-tax (Roth) contributions under the Internal Revenue Code ("IRC"). Participants who are at least age 50 can make additional contributions as defined under the IRC.

Employer Contributions

For all participants, TW makes nonelective safe harbor contributions equal to 3% of the participant's compensation. TW also makes discretionary profit-sharing contributions, which are determined each year. For the year ended December 31, 2024, profit-sharing contributions were equal to 1% of the participant's compensation.

Rollover Contributions

Participants are allowed to rollover their former employer's qualified retirement plan funds, subject to the Plan provisions.

Vesting

Participants are immediately vested in their salary deferral, safe harbor, and profit-sharing contributions, and related earnings thereon.

Investment Options

The Plan provides for participant-directed investment programs; whereby, the Plan Sponsor determines which investment options are available and the participants may choose among the available options. Participants may change their investment options at any time by reallocating contributions among different investment alternatives. Participants may also transfer contributions into and out of investments provided under the Plan, subject to possible restrictions.

Participant Accounts

The Plan qualifies as a participant-directed plan under Section 401(c) of the IRC. Each participant's account is self-directed and is credited with an allocation of the participant's elective contribution and an allocation of TW's safe harbor and profit-sharing contributions and Plan earnings. Participant accounts are reduced by any withdrawals or distributions, investment losses, decreases in values of investments, and share of fees and expenses, as applicable. Allocations are pursuant to the Plan provisions. Participants are entitled to their vested account balance.

Loans Receivable from Participants

The Plan allows active participants to borrow from their vested account balances, excluding the portion of their balance attributable to Roth contributions and related earnings. The minimum loan is \$1,000. Participant loans are limited to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made. Loans are secured by the balance in the participant's vested account, and bear interest as computed using the prime rate (as specified in the Wall Street Journal) plus 1%. The interest rate shall remain fixed throughout the duration of the loan. Principal and interest are paid ratably through bi-weekly payroll deductions, and the repayment period is five years unless the loan is to buy a principal residence. A participant may have no more than one loan outstanding at a time.

Payment of Benefits

Benefits may be paid from participant accounts at retirement age of 65; age 59 ½ and still working; or upon death, disability, or termination of employment. A minimum distribution is required for participants who have reached age 72. Eligible participants may request an in-service hardship distribution of all or any part of their vested account resulting from elective deferrals, safe harbor contributions, or profit-sharing contributions, subject to the Plan's provisions. Distributions may be made in the form of lump sum payments or non-recurring partial payments. If upon termination, the participant's vested balance is less than or equal to \$5,000, the participant must take it out of the Plan in the form of a lump sum payment or rollover to a separate Individual Retirement Arrangement (IRA).

Forfeited Accounts

When a participant terminates employment, any forfeited non-vested funds are held until the earlier of the participant's withdrawal of vested funds from the Plan or five years from the participant's termination of employment. Funds that are no longer on hold are credited to the current year forfeiture account and are available to pay plan administrative expenses or reduce employer contributions. As of December 31, 2024 and 2023, there were no forfeited non-vested accounts.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with generally accepted accounting principles in the United State of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Benefit Payments

Benefit payments to participants are recorded when such expenses are incurred.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements.

Net asset value is the relevant fair value measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to common collective trust investment contracts, because net asset value is the amount participants would receive, if they were to initiate permitted transactions under the terms of the Plan.

Interest is recorded as earned and dividend income is accrued as of the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Loans Receivable from Participants

Loans receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Administrative and Operating Expenses

Certain administrative expenses and professional services are paid by the Plan. Fees related to the administration of participant loans are charged directly to the participant's account and are included in administrative expenses. TW pays all remaining administrative expenses.

NOTE C - INFORMATION CERTIFIED BY TRUSTEE

The Plan administrator has elected the alternative method of compliance permitted by ERISA Section 103 (a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, information certified by Ascensus (the "Trustee" of the Plan), as of December 31, 2024 and 2023, and for the year ended December 31, 2024, was not audited, except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

NOTE D - FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification (“ASC”) Topic 820, *Fair Value Measurement*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

- Level 1* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

- Level 2* Inputs to the valuation methodology include a) quoted prices for similar assets or liabilities in active markets; b) quoted prices for identical or similar assets or liabilities in inactive markets; c) inputs other than quoted prices that are observable for the asset or liability; and d) inputs that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023. The fair value of mutual funds is determined by using the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Plan invests in stable value common collective trusts, for which the quoted prices are not available in active markets. Investments in common collective trusts are measured by using the net assets value (“NAV”) per share, or its equivalent, as a practical expedient, as determined by Great Gray Trust. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with FASB ASC 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

The Plan’s investments in stable value common collective trusts, having no unfunded commitments, allow a daily redemption frequency. There are no participant redemption restrictions for these investments; and the redemption notice period is applicable only to the Plan.

NOTE E - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST

Certain Plan investments are managed by affiliates of the Plan’s Trustee, and therefore, the transactions qualify as party-in-interest transactions. Loans receivable from participants also qualify as party-in-interest transactions. Personnel and facilities of TW have been used to perform administrative functions for the Plan at no charge to the Plan. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA. For the year ended December 31, 2024, fees paid by the Plan for contract administrator services and investment advisory and management services totaled \$38,167.

NOTE F - PRIORITIES UPON PLAN TERMINATION

Although it has not expressed any intent to do so, TW has the right under the Plan to amend the Plan, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA and the Plan document. Upon the Plan’s termination, participants will continue to be 100% vested in their accounts.

NOTE G - TAX STATUS

The Plan has adopted a prototype non-standardized profit sharing plan sponsored by Ascensus. The Internal Revenue Service (“IRS”) has informed Ascensus by an opinion dated June 30, 2020, that an employer who adopts the prototype plan will be considered to have a plan qualified under Section 401(a) of the Internal Revenue Code provided all terms of the Plan are followed and the eligibility requirement and the contribution or benefit provisions are not more favorable for highly compensated employees than for other employees.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require the recognition of a liability or (asset) or disclosure in the financial statements. The Plan's Form 5500 is subject to examination by the IRS for a period of three years from the date it was filed, except under certain circumstances. The Plan's Form 5500 for the years 2021 through 2023 are subject to tax examination by the IRS, although no request has been made as of the date of these financial statements.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
