**NOTE A -- Description of the plan and significant accounting policies**

The following description of the Premier Real Estate Management, LLC Salary Savings Plan (the “plan”) provides only general information. Participants should refer to the plan document for a more complete description of the plan’s provisions. The original effective date of the plan was January 1, 1998. The employer, as defined below, subsequently amended and restated the plan by adopting the Sikich LLP Non-Standardized Defined Contribution Plan effective January 1, 2021.

**General**

The plan is a defined contribution plan covering all eligible employees of Premier Real Estate Management, LLC (the “employer”), who have 500 hours of service in a six month period or the completion of one year of service and are age 21 or older. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees oversee governance of the plan, determine the appropriateness of the plan’s investment offerings and monitor investment performance.

The plan’s federal identification number is 39-1872177 and the plan’s number is 001.

**Contributions**

Each year, participants may contribute up to the maximum amount allowed by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the plan. The employer contributes 50% of the first 5% of base compensation that a participant contributes to the plan as a discretionary matching contribution. The employer also has the right to make additional contributions to be allocated to participants pro rata based on compensation. No additional discretionary contributions were made in 2024. Annual contributions from all sources are subject to certain limitations defined by the Internal Revenue Service (IRS).

**Participant accounts and “rollovers”**

Each participant’s account is credited with the participant’s contribution and allocations of (a) the employer’s matching and discretionary contribution, (b) plan earnings and (c) charged with an allocation of administrative expenses. Allocations of plan earnings are based on participant account balances, as defined in the plan, and allocation of employer contributions are based on participant compensation, as defined in the plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. The plan permits the rollover of funds from other qualified plans to a participant’s account.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer’s contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service. Participants who leave the plan because of death or disability, as defined by the plan, are considered 100% vested in all amounts.

**Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a fixed rate that is determined as 1% over the Prime Rate (8.50% at December 31, 2024) set by the Wall Street Journal on the first business day of the month the loan is originated. Principal and interest is paid ratably through monthly payroll deductions.

**Benefits**

On termination of service due to death, disability, retirement (age 65), or other reasons, a participant with an account balance less than \$5,000 will receive the value of the vested interest in his or her account as a lump-sum distribution. For accounts exceeding \$5,000, the participant may elect to receive a lump sum distribution, partial distributions, installments for required minimum distributions or may elect to defer such distribution to any valuation date subsequent to his/her termination but no later than the valuation date of his/her normal retirement date; or the participant may elect to rollover the distribution to another qualified plan. The plan permits hardship distributions if certain criteria are met. The plan permits in-service distribution at age 59 ½.

**Forfeited accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$10, respectively. These accounts would be used to reduce employer contributions. In 2024, employer contributions were reduced by \$1,200 from forfeited nonvested accounts.

A summary of significant accounting policies follows:

**Basis of accounting**

The financial statements of the plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits or a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the plan.

**Use of estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **NOTE A -- Description of the plan and significant accounting policies (Continued)**

#### **Investments valuation and income recognition**

The plan's investments (except for fully benefit-responsive investment contracts, which are reported at contract value) are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan's Investment Committee determines the plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of benefits**

Benefits are recorded when paid.

#### **Administrative expenses**

Certain expenses of maintaining the plan are paid directly by the employer and are excluded from these financial statements. Major administrative expenses are professional and investment management fees. The employer pays some of the administrative expenses of the Plan which are excluded from these financial statements.

#### **Notes receivable from participants**

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

#### **Subsequent events**

These financial statements have not been updated for subsequent events occurring after August 12, 2025, which is the date these financial statements were available to be issued. The plan has no responsibility to update these financial statements for events and circumstances occurring after this date.

### NOTE B -- Information certified by the asset custodians

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and interest and dividends, net appreciation, other income and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (Empower) the asset custodians of the Plan..

### NOTE C -- Fair value measurements

The plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value) in the accompanying Statements of Net Assets Available for Benefits.

U.S. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

**NOTE C -- Fair value measurements (Continued)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Registered investment companies. Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Gains and losses (realized and unrealized) included in the Statements of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, are reported in net appreciation in fair value of investments. Unrealized gains (losses) from the guaranteed investment contract are not reported in the Statements of Changes in Net Assets Available for Benefits as the contract is recorded at contract value for presentation in the Statements of Net Assets Available for Benefits.

**NOTE D -- Guaranteed investment contract with insurance companies**

The plan entered into a traditional fully benefit-responsive investment contract with Empower. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$146,141 and \$95,993, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

There are no events that allow the issuer to terminate the contract and which require the plan sponsor to settle at an amount different than contract value paid either within 60 days or over time. There are also no events that could limit the ability of the plan to transact at contract value paid within 60 days or contract value paid over time.

The plan may terminate the contract with advance notice to the other party. The contract termination would be the 60th day after the date notice is received, unless otherwise agreed upon.

**NOTE E -- Party-in-interest transactions**

Empower is the asset custodian of the plan as of and for the years ended December 31, 2024 and 2023, and is therefore designated as a fiduciary and party-in-interest. Related party-in-interest transactions occur in the course of ordinary business and are exempt transactions.

Fees were also paid by the plan during the year for advisory services rendered by RBC Capital Markets, LLC and Empower Advisory Group, LLC, assurance services provided by SVA Certified Public Accountants, S.C. and for administrative services provided by Sikich, LLP. These transactions also qualify as party-in-interest transactions.

Empower provides certain administrative and advisory services to the plan pursuant to a Plan Service Agreement (PSA) between the employer and Empower. Empower receives revenue from mutual fund service providers for services provided to the funds. This revenue is used to offset certain amounts owed to Empower for its administrative services to the employer.

If the revenue received by Empower from such mutual fund service providers exceeds the amount owed, Empower remits the excess to the plan's trust on a quarterly basis. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of the participants. During 2024, \$34,020 was applied to pay plan administrative expenses and is included as other income on the Statements of Changes in Net Assets Available for Benefits. The plan or plan sponsor may make a payment to Empower for administrative expenses not covered by revenue sharing.

**NOTE F -- Plan termination**

Although it has not expressed any intent to do so, the employer has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their allocated employer contributions.

**NOTE G -- Tax status**

The Sikich LLP Non-Standardized Defined Contribution Plan that the plan has adopted effective January 1, 2021 obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the prototype plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The plan has been amended since the date of the opinion letter. However, the plan administrator and the plan's tax counsel believe that the plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the plan was qualified and the related trust was tax-exempt as of the financial statement date.

**NOTE H -- Concentration of market risk**

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.
