Notes to Financial Statements

Note 1: Description of Plan

The following description of the First Business Financial Services 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of First Business Financial Services, Inc. and related employers First Business Bank and First Business Specialty Finance (collectively, the "Employer") who are age 21 or older and completed 30 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants may contribute up to 100% of pretax or after-tax annual compensation, as defined in the Plan, subject to limits as prescribed by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute funds from another qualified plan (rollovers) subject to certain requirements. Participants direct the investment of contributions into various investment options and brokerage accounts offered by the Plan.

Participants who have completed 500 hours in the first six months of service are eligible to receive Employer matching contributions. The Employer makes matching contributions in an amount to be determined from year to year. For the year ended December 31, 2024, the Employer matched 100% of the first 3% of participant contributions. Additional discretionary Employer contributions may be made at the discretion of the Employer to participants who have completed one year of service, defined as 1,000 hours, and are employed at the end of the plan year. For the year ended December 31, 2024, the Employer made discretionary contributions equal to \$1,774,996 and matching contributions of \$1,297,874.

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer matching and discretionary contributions, and allocations of (a) plan earnings (losses) and (b) forfeitures of terminated participant's nonvested accounts. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1: Description of Plan (Continued)

Vesting

Participants are immediately vested in their voluntary contributions and the Employer matching contributions, plus actual earnings thereon. Vesting in the Employer's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants vest at a rate of 20% per year beginning with the second year of service. Participants become fully vested after six years of service. A participant is credited with a year of service for each Plan year upon completion of 1,000 hours of service.

Notes Receivable From Participants

Participants may borrow from their Plan accounts. The minimum permitted loan is \$1,000 and the maximum permitted loan is the lesser of \$50,000 or one-half of the current value of the participant's vested interest in the Plan. Participants are allowed two loans outstanding from the Plan at a time. Loans are secured by participant balances and bear interest at 1% above the prime rate, as defined, determined at the time of borrowing. Interest rates ranged from 4.25% to 9.50% on loans outstanding as of December 31, 2024. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits

Upon termination of service for any reason or attaining normal retirement age (65), a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or in installments. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows in-service distributions upon attaining age 59 1/2.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$71,669 and \$113,089. These accounts are allocated to all participants eligible to share in the allocations of the Employer's discretionary contributions, in accordance with the plan document. During the year ended December 31, 2024, \$113,089 of forfeitures were allocated to participants.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Note 2: Summary of Significant Accounting Policies (Continued)

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through August 22, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market: Valued at the closing price reported on the active market on which the fund is traded.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds, exchange traded funds, and common stocks that are valued on the basis of readily determinable market prices.

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

Note 4: Information Prepared and Certified by the Trustee and Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by First Business Bank, the Trustee of the Plan, and Charles Schwab Trust Bank, the Custodian of the Plan.

Note 5: Related-Party Transactions and Party-in-Interest Transactions

Fees incurred and paid by the Plan for investment management services are offset against net appreciation in fair value of investments. Fees incurred and paid by the Plan related to benefit payment processing and notes receivable from participants are included in administrative expenses. Fees paid to First Business Bank were \$24,462 for the year ended December 31, 2024.

Certain Plan investments held in the self-directed brokerage accounts are shares of First Business Financial Services, Inc. common stock. First Business Financial Services, Inc. is a participating Employer of the Plan. At December 31, 2024 and 2023, the fair value of the common stock held in the Plan's self-directed brokerage accounts was \$842,108 and \$723,323, which consisted of 18,192 and 18,038 shares for 2024 and 2023, respectively.

The Plan's Trustee, First Business Bank, is a wholly owned subsidiary of the Employer.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in Employer discretionary contributions.

Note 7: Tax Status

The Employer adopted a nonstandard pre-approved plan document with an Internal Revenue Service (IRS) notification letter, which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
