Opinion

NOTE 1 — DESCRIPTION OF ORGANIZATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Healthcare Association of New York State Group Insurance Trust (the Trust) was established in 1968. The Trust, utilizing group purchasing leverage, provides reduced rate group insurance for life, accidental death and dismemberment and short-term and long-term disability for the benefit of employees of the participating employers who are members of the Healthcare Association of New York State, Inc. (the Association) or members of state associations that have a formal endorsement pertaining to the Trust. The Trust is administered by a Board of Trustees, who are appointed by the Association and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

(a) Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

(b) Participant Contributions and Insurance Premiums

Participant contributions represent contributions made to the Trust to be used for payment of premiums. Participant contributions are paid on a fee per member basis.

Insurance premiums represent premium expense on the underlying insurance policies. Premiums due insurance companies represent liabilities of the Trust for premiums not yet collected from the members of the Trust, but due as of the period end.

(c) Income Taxes

The Trust is a grantor trust and, accordingly, is not taxed.

(d) Use of Estimates

The preparation of the Trust's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make significant estimates and assumptions that affect the reported amounts of net assets available for participant benefits at the date of the financial statements, and the changes in net assets available for participant benefits during the reporting period. Actual results could differ from those estimates.

(e) Subsequent Events

For purposes of preparing the financial statements, the Trust considered events through August 20, 2025, the date the financial statements were available for issuance.

NOTE 2 — RELATED PARTY TRANSACTIONS

The Board of Trustees of the Trust has appointed Group Insurance Agency, Inc. (GIA), a subsidiary of the Association, to provide daily administrative and recordkeeping services to the Trust.

GIA is an insurance broker licensed in New York State to provide health and welfare insurance products. GIA has been appointed the broker to the Trust by the Trustees. GIA earned broker commissions and bonuses from insurance companies in the amount of approximately \$192,500 and \$300,900 for the years ended December 31, 2024 and 2023, respectively.

The Lincoln Financial Group, the insurance carrier for the Trust, performs the administrative function of billing and collecting premium payments from members of the Trust.
