- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other matter - supplemental schedule required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such supplementary information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from

the certified investment information, we compared such information to the related certified investment information.

**NOTE A - DESCRIPTION OF PLAN**

The following description of The Adler Planetarium Defined Contribution Retirement Income Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering substantially all employees, established by The Adler Planetarium (the "Plan Sponsor") under the provisions of Section 403(b) of the Internal Revenue Code. Employees are eligible to participate (elective deferrals only) in the Plan on the first day of employment. Employees who are nonresident aliens and are eligible participants accruing benefits in the Adler Planetarium Retirement Income Plan are excluded from participating in the Plan. To be eligible to receive employer contributions, an employee must be 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Empower Trust Company, LLC is the trustee of the Plan and Empower Retirement, LLC is the recordkeeper.

***Contributions***

Eligible employees may contribute up to 100 percent of their gross compensation up to the Internal Revenue Service (IRS) annual contribution limits. Each eligible active participant over the age of 50 may elect to contribute catch-up deferrals up to the IRS annual deferral limits. Participants can change their deferral rate at any time during the year. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

All or a portion of elective deferral contributions can be Roth (post-tax) rather than pretax if desired by the individual participant.

The Plan Sponsor is required to make safe harbor matching contributions of 100 percent of each eligible active participant's elective deferrals not exceeding 3 percent of the participant's eligible compensation, plus 50 percent of the next 2 percent of a participant's elective deferrals.

The Plan Sponsor may make additional discretionary contributions limited to 6 percent of the participant's elective deferrals or 4 percent of the employee's eligible compensation. There were no such contributions made by the Plan Sponsor during 2024.

***Participant Accounts***

Each participant's account is credited or charged with the allocation of (a) employee pretax deferrals, (b) employee Roth (post-tax) deferrals, (c) safe harbor matching contributions, (d) discretionary contributions, (e) plan earnings and losses, and (f) fund expense ratios. The benefit to which the participant is entitled is the benefit that can be provided from the participant's account.

***Vesting***

Participants are immediately 100 percent vested in their own contributions, rollover, and employer safe harbor matching contributions and any income or loss thereon. Participants vest in employer discretionary contributions at 20 percent after two years of service, an additional 20 percent per year thereafter until they become fully vested after six years of service.

***Benefit Payments***

Upon termination of service, including due to death, disability, or retirement, a participant may receive 100 percent of the value of the participant's account. Distributions may be in the form of a lump-sum payment or installment payments.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the Plan agreement.

***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their account balances, not to exceed \$50,000. A participant may not have more than one loan outstanding at any time. Loan terms cannot exceed five years, except if the loan is used for the purchase of a primary residence in which case the repayment period may exceed five years. The loans are secured by the balance in the participant's account and bear interest at the rate commensurate with the local prevailing rate, as determined by the Plan administrator at the time the loan is issued. Principal and interest is paid ratably through monthly payroll deductions.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future plan contributions or to pay administrative expenses of the Plan. After administrative expenses have been paid, remaining forfeitures are used to reduce safe harbor matching contributions. At December 31, 2024 and 2023, forfeited nonvested accounts total \$2. During 2024, no administrative expenses were paid from forfeited nonvested accounts, and employer contributions were not reduced by any amount from forfeited nonvested accounts.

***Plan Termination***

While it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The Plan's financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

**December 31, 2024 and 2023**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Benefit Payments***

Benefit payments are recorded when paid.

***Notes Receivable from Participants***

Participant loans receivable are recorded at their unpaid principal balances plus any accrued interest. Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent loans are reclassified as distributions based on the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

***Administrative Expenses***

Reasonable expenses relating to the administration of the Plan are paid using Plan assets. Such expenses include, but are not limited to, Plan management, loan, distribution and consulting fees. Unless otherwise paid by the Plan, certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements.

**NOTE C - FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The valuation inputs for the three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**December 31, 2024 and 2023**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

However, the determination of what constitutes observable requires judgment by the Plan's management. Plan management considers observable data to be market data that is readily available, regularly distributed or updated, reliable and verifiable, not proprietary, and provided by multiple independent sources that are actively involved in the relevant market. The categorization of an investment within the fair value hierarchy is based on the transparency of the investment and does not necessarily correspond to Plan management's perceived risk of that investment.

Mutual funds are valued at the daily quoted net asset value (NAV) of shares held by the Plan at year end as reported on an active market. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**NOTE D - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Empower Trust Company, LLC is the trustee of the Plan; therefore, transactions with the trustee qualify as party-in-interest transactions. Fees paid by the Plan to Empower Trust Company, LLC totaled \$29,325 for the year ended December 31, 2024. These related party and party-in-interest transactions are exempt from the prohibited transactions rules of ERISA. Notes receivable from participants also qualify as party-in-interest transactions.

**NOTE E - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE F - TAX STATUS**

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the IRS. The volume submitter plan has received a favorable opinion letter from the IRS dated March 31, 2017. The Plan administrator believes that the Plan is currently designed and being operated in compliance in all material respects with the applicable requirements of the IRC; therefore, the Plan administrator believes that the Plan was qualified and that the related trust was tax-exempt as of the financial statement dates.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements as of December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE G - INFORMATION PROVIDED BY THE TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC has certified that the following information included in the financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

**NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE I - SUBSEQUENT EVENTS**

Plan management evaluated the Plan's December 31, 2024 financial statements for subsequent events through August 26, 2025, the date the financial statements were available to be issued. There are no subsequent events that require recognition or additional disclosure in these financial statements.

CURRENT VALUE: The value of all assets in each investment option as of the last day of the plan year
