INDEPENDENT AUDITORS' REPORT

To the Board of Directors
Piantedosi Baking Company Inc. Employees' Savings Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Piantedosi Baking Company, Inc. Employees' Savings Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Piantedosi Baking Company, Inc. Employees' Savings Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTES TO FINANCIAL STATEMENTS**

1. DESCRIPTION OF PLAN

The following description of the Piantedosi Baking Company Inc. Employees' Savings Retirement Plan (the Plan) of Piantedosi Baking Company Inc. (the Company) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General –

The Plan is a defined contribution plan covering substantially all employees of the Company who have completed 60 days of service and who are at least age 21. The Plan is subject to the provisions of the Internal Revenue Code of 1986, as amended (the Code) and the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Directors.

Contributions –

Each year, participants may contribute to the Plan a percentage of their eligible compensation, on a pre-tax or after-tax Roth basis, up to the maximum amount allowed by the Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. With the approval of the plan administrator, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company matching contribution is determined each year by the Company on a discretionary basis. Employees become eligible to receive Company matching contributions after 60 days of service and who are at least age 21, with eligible entry dates on the first day of each calendar month. For the years ended December 31, 2024 and 2023, the Company matched 100% of the first 3% deferred by participants totaling \$362,515 and \$317,822, respectively.

In addition to matching contributions, the Company may make discretionary profit sharing contributions with the approval of the Board of Directors. Employees become eligible to receive Company discretionary profit sharing contributions after 1 year of service in which they work at least 1,000 hours. Employees must also be employed on the last day of the Plan year to be eligible for a Company discretionary profit sharing contribution. Discretionary profit sharing contributions are allocated based on participants' compensation using a formula that is integrated with social security. For the years ended December 31, 2024 and 2023, there were no discretionary profit sharing contributions made. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts –

Each participant's account is credited with the participant's contribution, the Company's matching contribution, an allocation of the Company's discretionary profit sharing contribution and actual earnings thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (Continued)

Vesting –

Participants are vested immediately in their contributions, the Company's matching contributions, and the Company's discretionary profit sharing contribution, plus actual earnings thereon.

Notes Receivable from Participants –

The Plan does not provide for loans to participants.

Payment of Benefits –

Upon termination of service, retirement, disability or death, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in their account either as a distribution or a rollover. If a participant's account balance is greater than \$1,000 but equal to or less than \$7,000 (increased from \$5,000 effective January 1, 2024 under the SECURE 2.0 Act), the plan administrator can automatically rollover the entire vested account balance into a traditional individual retirement account (IRA). If a participant's account balance is less than \$1,000, the plan administrator can distribute the entire balance in a lump sum amount.

Hardship withdrawals are available from the participant's rollover account and elective deferral account to meet a participant's immediate and heavy financial need, as defined in the Plan document.

Forfeitures –

Since participants are immediately vested in all contributions, forfeitures generally result only from excess Company matching contributions forfeited from participants' accounts upon identification. Forfeitures are used to restore participant accounts, reduce or reallocate Company matching contributions to the Plan or pay reasonable Plan expenses. At December 31, 2024 and 2023, the Plan had available forfeitures totaling \$0 and \$3,982, respectively. For the year ended December 31, 2024, \$3,982 of forfeitures were allocated to plan participants. No forfeitures were used to reduce Company matching contributions to the Plan for the year ended December 31, 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting –

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates –

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition –

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits –

Benefits are recorded when paid.

Administrative Expenses –

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. The Plan has a zero-revenue investment cost structure whereby expenses are collected as part of the contract's annualized asset charge and reported separately as Plan administrative expenses.

Under the terms of the revenue sharing agreement, the Plan has a Plan Expense Reduction Account (PERA) whereby any excess revenues that exceed the administrative expenses for the plan year may be applied to pay future administrative expenses of the Plan or allocated to the accounts of participants on a pro rata basis. During the years ended December 31, 2024 and 2023, excess amounts totaling \$0 and \$23,174 were allocated back to the accounts of participants, respectively.

Date of Management's Review –

The Plan has evaluated subsequent events through August 5, 2025, the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The 3 levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Guaranteed interest accounts:

Valued at estimated fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer. The guaranteed interest accounts promise contract value for a benefit event (termination, death, disability and retirement); however, there is a possible market value adjustment when funds are withdrawn prior to maturity. Therefore, the guaranteed interest accounts are not considered benefit-responsive and are valued at estimated fair value, which approximates contract value, as determined by John Hancock Life Insurance Company. Crediting interest rates are established on the first day of each calendar month and apply to any regular ongoing contributions made to the guaranteed account in that month.

For the year ended December 31, 2024, the crediting interest rate was 3.30% for the 3 year guaranteed account and 3.45% for the 10 year guaranteed account. For the year ended December 31, 2024, the average yield for the guaranteed accounts ranged from 0.80% to 3.55% for the 3 year guaranteed account and from 0.80% to 3.37% for the 10 year guaranteed account. For the year ended December 31, 2023, the crediting interest rate was 3.05% for the 3 year guaranteed account and 2.85% for the 10 year guaranteed account. For the year ended December 31, 2023, the average yield for the guaranteed accounts ranged from 0.70% to 2.06% for the 3 year guaranteed account and from 0.75% to 2.41% for the 10 year guaranteed account.

Mutual funds:

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. INFORMATION PREPARED AND CERTIFIED BY PLAN'S TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company, the trustee of the Plan.

5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

6. TAX STATUS

The Plan has adopted a prototype non-standardized profit-sharing plan and relies on the prototype plan's opinion letter from the IRS dated June 30, 2020, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter. However, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

8. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by affiliates of John Hancock Life Insurance Company, the trustee of the Plan, which qualify as party-in-interest transactions. The Plan has a revenue sharing agreement with the Plan's recordkeeper, as discussed in Note 2. These transactions also qualify as party-in-interest transactions.



