### Note A – Description of Plan

The following description of the Pilot Pen 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution safe harbor plan covering employees of Pilot Corporation of America (the “Company” or the “Employer”) as of January 1, 2006. The Plan was formed and adopted effective January 1, 2006, and was last amended and restated effective February 1, 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective August 8, 2024, the Plan was amended to permit the withdrawal of a participant’s vested account in the event of a federally declared disaster. Federally declared disaster withdrawals cannot exceed \$22,000. To qualify, participants must have their principal place of residence in the disaster area with the distribution made within 179 days of the applicable disaster date.

The Plan covers the Company’s employees who have completed at least 1 month of service. There is no minimum age requirement. Employees hired before January 1, 2006, leased and expatriate employees are excluded from participating in the Plan.

#### Administration

The Plan’s assets for the year were maintained and administered by Fidelity Management Trust Company and Principal Trust Company (the “Custodians”). The Company changed custodians on February 1, 2024 from Fidelity Management Trust Company to Principal Trust Company. The Plan Committee is responsible for the oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance. MAI Capital Management is the Plan's consulting partner to help administrate the Plan.

#### Contributions

The Plan allows participants to contribute up to 60 percent of their eligible compensation, as defined in the Plan document, subject to limits imposed by the Internal Revenue Code (“IRC”). Effective February 1, 2024, the Plan was amended and restated to allow participants to contribute up to 90 percent. The maximum participant deferral for the year ended December 31, 2024, was \$23,000. A participant who has attained the age of 50 may also make catch up contributions, subject to Internal Revenue Service (“IRS”) limitations of \$7,500 for the year ended December 31, 2024. Participants may also contribute amounts representing pre-tax distributions from other qualified plans. The plan includes an Enhanced Safe Harbor Match of 6 percent and to allow Roth contributions. Once an employee completes one month of service, they are automatically enrolled at a 3 percent with an automatic yearly escalation of 1 percent up to 6 percent. Effective February 1, 2024, the plan was amended and restated to increase the maximum automatic escalation rate from 6 percent to 8 percent.

#### Participant Accounts

Each participant’s account is credited with the participant’s contributions and employer safe harbor contributions. Additionally, participant’s accounts are credited with the corresponding allocation of Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### Vesting

Participants are vested immediately in their contributions, the Company's safe harbor contributions, and actual earnings thereon.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. A participant may only have one loan outstanding at any given time. Prior to the Plan restatement described above, a participant was only allowed one loan outstanding at any given time. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate of interest, which is commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Loan terms may not exceed five years unless the loan is used for the purchase of a primary residence in which case the loan repayment period may not extend beyond 10 years from the date of the loan. Principal and interest are paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are treated as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### Payment of Benefits

On termination of service for any reason including death or disability, a participant (or beneficiary) may elect to receive his or her account balance as a lump-sum distribution, installments, or a direct rollover distribution. Participants may request in-service distributions using the elective deferral portions of their accounts upon attaining age 59 ½ years or in the event of financial hardship under specific circumstances.

The Plan was voluntarily amended effective February 1, 2024, which increased the force-out amount from \$5,000 to \$7,000.

#### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. All appropriate accounting provisions of the Plan will continue to apply until the accounts of all participants have been distributed.

### Note B – Summary of Significant Accounting Policies

#### Basis of Presentation

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

#### Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements, as well as the reported amounts of changes in net assets during the reporting period. Such estimates include those regarding fair value. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. If available, quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value (“NAV”) of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year, net of investment management fees.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in the net appreciation of the fair value of investments.

#### Fair Value Measurements

The Financial Accounting Standards Board has established a framework for measuring fair value in ASC 820, *Fair Value Measurements*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1*            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2*            Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
  
- Level 3*            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued at the NAV provided by the Custodians. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments to purchase investments at December 31, 2024 and 2023. Participant-directed redemptions have no restrictions and are recorded at the end of every business day.

#### Fair Value Measurements (continued)

*Common/collective trusts:* Valued at NAV provided by the Custodians. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments to purchase investments at December 31, 2024 and 2023. Participant-directed redemptions have no restrictions and are recorded at the end of every business day.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note C – Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company to Principal Trust Company, qualified institutions. As of December 31, 2024 and 2023, and for the year end December 31, 2024, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by Fidelity Management Trust Company to Principal Trust Company, except for comparing such information to the related information included in the financial statements, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note D – Party-In-Interest Transactions

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Certain Plan investments and the related transactions were in investment funds managed by the Custodians; therefore, these investments and transactions qualify as party-in-interest transactions. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid to parties-in-interest by the Plan for services amounted to approximately \$28,000 during the year ended December 31, 2024.

### Note E – Income Tax Status

The IRS has informed Principal by an opinion letter dated June 30, 2020, that the prototype plan adopted by the Plan, as then designed, was in accordance with applicable sections of the IRC. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustments to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

### Note F – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

### Note G – Subsequent Events

Effective January 1, 2025, the Plan was amended and restated to increase auto enrollment from 3 percent to 6 percent up to a maximum of 10 percent of compensation.

Subsequent events have been evaluated through August 5, 2025, which is the date the financial statements were available to be issued. No material recognizable subsequent events were noted.
