### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Jonah Energy 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### 1. Summary Description of the Plan

The following description of the Jonah Energy 401(k) Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description and Plan document for a more complete description of the Plan's provisions.

#### *Nature of Operations*

The Plan became effective on June 1, 2014 and is a defined contribution profit-sharing plan covering all eligible employees of Jonah Energy LLC (the Company or Employer). The Plan was restated effective January 1, 2024 and there were no significant changes to the provisions of the Plan as a result of the restatement.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Benefits under the Plan are not guaranteed by the Pension Benefit Guaranty Corporation. The Plan is intended to be a qualified plan under Internal Revenue Code (IRC) Section 401(a).

#### *Trustee and Administration of the Plan*

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Trustee or Principal) is the Trustee and provides recordkeeping and other administrative services. The administrator of the Plan is the Company. The Trustee holds all assets of the Plan in accordance with provisions of the service provider contract with the Company. All assets of the Plan are in investment accounts at Principal.

#### *Eligibility*

Employees are eligible for participation in the Plan immediately upon hiring unless the employee is: (i) represented by a bargaining unit that has bargained with the Company in good faith on the subject of retirement benefits; (ii) a nonresident alien with no U.S. income or all such income is exempt from U.S. income tax; (iii) a leased employee; (iv) an intern; (v) an individual who is considered an independent contractor or an employee of an independent contractor who is later determined by the Internal Revenue Service (IRS) to be an employee of the Company; (vi) an expatriate covered by an employer's retirement plan in the employee's country of residence; or (vii) part time, seasonal, or temporary employees scheduled to work less than 1,000 hours (however, these employees become eligible upon meeting 1,000 hours of service in a year).

#### *Contributions*

Participants are eligible to contribute on a pre-tax or Roth after-tax basis up to 75% of their annual compensation, subject to the limits of IRC Section 402(g). In addition, participants are allowed to make catch-up contributions if they will be at least age 50 by the end of that year, subject to IRC limits. Rollover contributions from other qualified plans are permitted if certain criteria are met.

The Company makes Safe Harbor matching contributions to the Plan equal to 100% of each participant's salary deferral contributions, up to a maximum matching contribution of 5% of eligible compensation.

The Company makes a nonelective employer contribution as a percentage of eligible compensation for all eligible employees, regardless of whether they are contributing to the Plan. For the year ended December 31, 2024, the Company made a nonelective employer contribution of 5% of eligible compensation.

### ***Participant Accounts***

Each participant's account is credited with participant contributions and Safe Harbor matching and nonelective contributions, as well as an allocation of earnings and losses on investments and charged with certain expenses. The investment earnings and losses are allocated to each participant's account in proportion to the balance that each participant's account bears to the total balance of all participants in each investment fund elected. The benefit to which a participant is entitled is equal to the vested balance in the participant's account.

### ***Investment Options***

Upon enrollment in the Plan, a participant may direct his or her contributions in any of the investment accounts that are offered by the Plan, which are a variety of mutual funds, pooled separate accounts, and collective investment trusts. Participants may change their investment choices and contribution percentages at any time.

### ***Vesting***

Participants are immediately vested in all employee, rollover, and employer Safe Harbor matching contributions and earnings therein. Participants vest in all other employer contributions 100% after three years of service, upon reaching the early retirement age 55, or if a participant incurs a severance of employment as a result of death or disability, as defined in the Plan document. However, the Company granted prior-service credit to all employees who were participants under the Encana (USA) Retirement Plan and Linn Energy, Inc. Plan immediately prior to employment with the Company. In the event of the termination of the Plan, participants would be fully vested and have the balance of their accounts distributed to them in a lump-sum cash payment.

### ***Payment of Benefits***

A participant's account balance may be distributed as a lump sum or in installments, in-kind, or roll over to another qualified plan when the participant terminates from service, reaches age 59½, retires (early retirement age is 55 and normal retirement age is 65), is disabled, or dies. A distribution from rollover contributions may be taken at any time. Hardship withdrawals are permitted for all or any portion of a participant's contributions, with a minimum \$1,000 withdrawal, if certain criteria are met.

### ***Notes Receivable from Participants***

Participants may borrow from the Plan in an amount greater than \$1,000 up to a maximum of the lesser of \$50,000 or 50% of the participant's vested account balance. Notes receivable must be repaid within five years (unless the note is for the purchase of a primary residence, which may be a longer duration) and bear interest at a reasonable rate that is fixed for the term of the note. Principal and interest are paid ratably through payroll deductions.

### *Forfeited Accounts*

At December 31, 2024 and 2023, there were \$60 and \$10,679, respectively, of forfeited non-vested accounts. Forfeitures can be used to pay administrative expenses or reduce employer nonelective contributions, if elected by the Company. For the year ended December 31, 2024, \$27,001 and \$917 of forfeited accounts were used to reduce employer nonelective contributions and pay administrative expenses, respectively.

## **2. Summary of Accounting Policies**

### *Basis of Accounting*

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (GAAP).

### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation*

The Plan's investments are stated at fair value. Shares of mutual funds are valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year end. Pooled separate accounts are valued at NAV per share as a practical expedient for fair value based on the fair value of the underlying investments. Collective investment trusts, including the Principal Stable Value Fund further described below, are stated at NAV per share as a practical expedient for fair value based on the fair value (or contract value of investments for the Principal Stable Value Fund) of the underlying investments.

The preceding valuation methods described may produce a fair value calculation that is simply indicative of the net realizable value and may not be reflective of actual current or actual realizable values. Furthermore, although the Plan believes its valuation methods are reasonable, appropriate, and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan invests in the Principal Stable Value Fund, offered by Principal Global Investors Trust Company, a collective investment trust fund, which invests in fully benefit-responsive contracts (guaranteed investment contracts, synthetic investment contracts, and short-term investments). Principal Global Investors Trust Company, the trustee of the Principal Stable Value Fund, is a wholly owned subsidiary of Principal Financial Group. The objective of the Principal Stable Value Fund is to provide preservation of capital, have stable returns consistent with a low-risk profile, and provide liquidity for benefit-responsive payments. The Principal Stable Value Fund seeks to achieve this objective by investing primarily in a variety of high-quality stable value investment contracts (the performance of which may be predicated on underlying fixed-income securities), as well as cash and cash equivalents. The duration of the investments within the Principal Stable Value Fund will

not exceed four years. In accordance with the Plan, net investment income, if any, and realized and unrealized gains on investments are not distributed.

Withdrawals, other than for benefit payments and participant transfers to noncompeting options, require a 12-month advance written notice. Included in this advance written notice requirement are full or partial withdrawals of assets invested in the Principal Stable Value Fund resulting from Plan sponsor-directed actions. Such actions include, but are not limited to, (i) Trustee or Plan sponsor-directed reallocation of investments, (ii) Company-sponsored layoffs/termination of groups of employees, (iii) disposing of or selling a component of the business that involves the transfer or termination of employees, (iv) terminating the Principal Stable Value Fund as an investment option of the Plan, and (v) terminating the Plan. All Plan sponsor-directed requests for full or partial withdrawals must be submitted to the Trustee in writing certifying the reason for the withdrawal request. All such requests are subject to the 12-month advance written notice requirement. The Trustee may choose to disburse withdrawals in less than the required one-year period if, in the Trustee's discretion, it determines that such a disbursement is in the best interest of the fund as a whole.

### ***Income Recognition***

Purchases and sales of investments are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date and interest income is recorded when earned. The net appreciation or depreciation is determined as the difference between beginning market value or cost if purchased during the year and year-end market value and capital gains reinvested.

### ***Contributions***

Participant contributions and related Safe Harbor matching and nonelective contributions are recorded in the period of the related payroll deduction and earnings.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance, any accrued and unpaid interest is de minimis. Related fees are recorded as administrative expenses and are expensed as incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment to the participant is recorded.

### ***Payments of Benefits***

Benefits are recorded when paid.

### ***Administrative Expenses***

During the year ended December 31, 2024, the Plan incurred total administrative expenses of \$31,039, which were paid by the Plan or participants or through revenue sharing. These administrative expenses include recordkeeping services, distribution fees, and participant note setup and maintenance fees. Certain management fees, in the form of an expense ratio charged to each investment option, are paid by the Plan and deducted from earnings or investments. All other administrative expenses of maintaining the Plan, including audit, Trustee, and participant maintenance fees, are paid directly by the Company and are excluded from these financial statements.

### *Risks and Uncertainties*

The Plan provides for various investments in pooled separate accounts, mutual funds, collective investment trusts, and a stable value fund. Investments, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Additionally, the value, liquidity, and related income of the investment securities are sensitive to changes in economic conditions in interest rates. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Concentrations*

As of December 31, 2024 and 2023, there were three and four investments, respectively, that individually accounted for 10% or more of total investments. See the supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 for further details.

### **3. Certified Investment Information**

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, a qualified institution, has certified that the following information included in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) as complete and accurate:

- Investments and notes receivable from participants as reported in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividend income, and interest earned on notes receivable from participants as reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment amounts included in the notes to financial statements.
- All investment information included in the supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule and reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP and whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 4. Fair Value Measurements

The Plan applies the provisions of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures* (ASC 820), for all financial assets and liabilities measured at fair value on a recurring basis. The topic establishes a framework for measuring fair value and requires disclosures about fair value measurements. ASC 820 defines fair value as the price that would be received to sell an asset or paid to transfer a liability, defined as an exit price, in an orderly transaction between market participants at the measurement date. ASC 820 establishes market or observable inputs as the preferred sources of values, followed by assumptions based on hypothetical transactions in the absence of market inputs. The topic also establishes a hierarchy for grouping these assets and liabilities, based on the significance level of the following inputs:

*Level 1* - This level consists of quoted prices in active markets for identical assets and liabilities.

*Level 2* - This level consists of quoted prices in active markets for similar assets and liabilities, quoted prices for identical or similar instruments in markets that are not active, and model-derived valuations whose inputs are observable or whose significant value drivers are observable.

*Level 3* - This level consists of significant inputs to the valuation model that are unobservable.

## 5. Plan Termination

Although it has not expressed any intent to do so, the Employer reserves the right to terminate the Plan at any time by written notice to the Trustee. In the event of a termination, all account balances will be fully vested and payable to the participants.

## 6. Tax Status

The Plan adopted a pre-approved profit-sharing plan document effective January 1, 2024. The sponsor of the document received an opinion letter from the IRS, dated June 30, 2020, indicating that the document is designed in accordance with the applicable sections of the IRC. The Plan administrator believes that the Plan, as amended and restated, is currently designed and operated in compliance with the applicable requirements of the IRS. No provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. There are currently no audits for any tax periods in progress.

## 7. Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds, pooled separate accounts, and collective investment trusts that are managed by Principal, which is also the Trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest. For the year ended December 31, 2024, the Plan paid \$31,039 of administrative fees to Principal. In addition, the notes receivable from participants qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules.
