

2024 Schedule SB Line 25 - Method Change

- (3) The funding target and target normal cost (without regard to any adjustments for employee contributions and plan-related expenses) as determined by the new enrolled actuary as of the valuation date for the prior plan year (using the actuarial assumptions of the prior enrolled actuary and using the data elements and valuation software of the new enrolled actuary), are both within 3% of those values determined for that prior plan year by the prior enrolled actuary;
- (4) The actuarial value of plan assets, as determined by the new enrolled actuary as of the valuation date for the prior plan year (using the actuarial assumptions of the prior enrolled actuary), is within 2% of the value for that prior plan year as determined by the prior enrolled actuary.
