Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of McElroy Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of McElroy Group 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of McElroy Group 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following description of McElroy Group 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of McElroy Truck Lines, Inc. and Sumter Management, who have 60 days of service and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each active participant may contribute from 1% to 100% of pretax annual compensation, as defined in the Plan. The employer matches employee contributions 50% of every dollar up to 6% of the employee's compensation.

Participant's Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) the plan's earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The employers may make discretionary contributions.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. A participant's rights to employee contributions to the Plan shall be nonforfeitable at all times. Employer contributions are vested at the rate of 20% after two years and 20% per year thereafter. Employees are fully vested after 6 years of accredited service.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions in various investment options with Empower Annuity Insurance Company.

Note 1. Description of the Plan (continued)

Participant Notes Receivable

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes Receivable Fund. Loan terms range from 1-5 years or up to 25 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the plan Administrator. Interest rates currently range from 4.25% to 9.50%. Principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits

On termination of service, due to death, disability, or retirement, a participant may elect to receive a lump sum cash payment or periodic installments for a period not exceed the life expectancy of the participant, or a combination of the preceding payment options.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,995 and \$2,873, respectively. These accounts will be used to reduce future employer contributions. Employer contributions were reduced by \$55,753 and \$52,407 from forfeited nonvested accounts for 2024 and 2023, respectively.

Insurance

A fidelity bond insures the Plan for \$500,000.

Note 2. Summary of Significant Accounting Policies

Date of Management's Review

Subsequent events were evaluated through August 18, 2025, which is the date the financial statements were available to be issued.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Note 2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

Investments are stated at fair value except for its fully benefit-responsive contract, which is valued at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Pooled separate accounts do not transact at prices available to retail investors nor do they publish daily share values. As such, they are not considered actively traded. Investments in pooled separate accounts are reported at fair value using net asset value (NAV) as a practical expedient. NAV is provided by the trustee and is generally calculated by using the quoted market prices for the underlying investments. See Note 3 for discussion of fair value measurements.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Some expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Note 3. Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 – Valuations are based on quoted prices in active markets for identical assets or liabilities.

Level 2 – Valuations are based on observable inputs (assumptions obtained from independent sources) for the asset or liability, either directly or indirectly.

Level 3 – Valuations are based on unobservable inputs (assumptions based on the best information available) that are significant to the fair value of the assets or liabilities.

The Plan has no investments reported at Level 1, 2 or 3 since the investments in pooled separate accounts are reported at net asset value (NAV). As such, they are excluded from the fair value hierarchy in accordance with ASU 2015-07 (see Note 5). The investment in the Talcott Fixed Account is reported at contract value and is therefore also excluded from the fair value hierarchy.

Note 4. Information Certified by the Insurance Carrier – Empower Annuity Insurance Company

The Plan's investments are held by Empower Annuity Insurance Company. The account balances certified by Empower Annuity Insurance Company at December 31, 2024 and 2023 totaled \$9,924,764 and \$8,771,614, respectively. The Plan's financial information, including investment values, investment income, and fees is included in the financial statements based on information certified by Empower as administrative services provider for Talcott Resolution Life Insurance Company as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

Effective January 1, 2013, the Plan entered into a fully benefit-responsive investment contract with Empower Annuity Insurance Company. The contributions are maintained in a general account. The account (Fixed) is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Because the contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Massachusetts Mutual Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Note 5. Investment Contract with Insurance Company

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The repayment of principal and interest credited to participants holding the investment is a financial obligation of Talcott. The fair value of the investment contract at December 31, 2024 and 2023 was \$1,187,348 and \$1,293,890, respectively. The average yield and crediting interest rates were approximately 3.00% for both the years ended 2024 and 2023. The crediting interest rate is based on an amount agreed upon with the issuer. The declared rate for both 2024 and 2023 was 3.00%.

Certain events limit the Plan's ability to transact at contract value with Empower Annuity Insurance Company. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants have a probability of occurring.

Note 6. Contributions Receivable

Contributions in transit at December 31, 2024 and 2023 totaled \$0 and \$14,950, respectively.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 8. Tax Status

The Plan obtained its latest determination letter dated January 10, 1999, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Note 8. Tax Status (continued)

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

Note 9. Rollover Contributions

Rollover contributions totaling \$84,916 and \$16,595 were received by the Plan during the years ended December 31, 2024 and 2023, respectively.

Note 10. Related Party Transactions

Certain Plan investments are pooled separate accounts managed by Empower Annuity Insurance Company. Empower is the trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$981 and \$996 for the years ended December 31, 2024 and 2023, respectively. During the years ended December 31, 2024 and 2023, the Plan sponsor paid for the Plan's annual audit to Rea, Shaw, Giffin and Stuart, LLP. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 11. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 12. Reclassifications

Certain reclassifications have been made to the prior year financial statements in order for them to be in conformity with the current year presentation.
