***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of EOA of Washington County 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of EOA of Washington County 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

***Opinion***

**1. Summary of Significant Plan Provisions**

The following description of the EOA of Washington County 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan for the benefit of the employees of the Economic Opportunity Agency of Washington County, Inc. (the “Employer”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Eligibility

Each employee, who is not a member of a collective bargaining unit, is eligible to participate in the Plan at the next entry date coinciding with or following the employee attaining age 18 and completing one year of service during which 1,000 hours or more of service is rendered. Plan entry dates are January 1 and July 1.

Contributions

Participants may contribute through payroll deductions and may make eligible rollover contributions. Participants may elect to contribute 1% to 80% of their compensation. Employer contributions are discretionary. The Employer may make non-elective contributions or a match based on a percentage of participants’ eligible employees’ salary. The Employer contributed non-elective contributions in the amount of \$178,645 during the year ended December 31, 2024. The Plan contains provisions as to the maximum annual additions that may be made to a participant’s account.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of (a) the Employer’s contributions and (b) Plan earnings/losses and is charged with applicable withdrawals and an allocation of any administrative expenses. Allocations are based on participant compensation, contributions or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions into the investment options available under the Plan. Participants may change their investment selections at any time.

Vesting Rights

Participants are, at all times, fully vested with respect to their contributions, safe harbor contributions and rollover contributions plus earnings/losses thereon. With respect to Employer contributions, the benefit attributable to a participant shall be fully vested and nonforfeitable upon death, becoming totally disabled or reaching their normal retirement age.

If a participant terminates employment for reasons other than death, disability or retirement, he is entitled to the portion of discretionary nonelective contributions made by the Employer, plus earnings/losses thereon, according to the following schedule:

Forfeitures

The portion of a participant's account to which they are not entitled as a result of being less than fully vested shall be forfeited by the participant. Forfeitures may first be used to pay any administrative expenses. Forfeitures may then be allocated to all participants eligible to share in the allocations of profit sharing contributions or in the same proportion that each participant's compensation for the Plan year bears to the compensation of all participants for such year. No forfeitures were allocated to participant accounts during the year ended December 31, 2024.

Payment of Benefits

Upon retirement, death, disability or termination, a participant may elect to receive a lump sum or partial withdrawals in amounts equal to the value of the participant's vested interest in their account. Upon termination, participant balances less than \$1,000 are automatically distributed. If a terminated participant's account balance is equal to or less than \$5,000, but more than \$1,000, and the participant did not consent to a distribution, the vested benefit will be automatically rolled over to an IRA. Participants, upon termination of employment, may also elect to defer payment on their account balance if it exceeds \$5,000. In-service withdrawals are available to participants who have met certain hardship requirements. Benefits shall be paid as soon as administratively feasible following the date on which a distribution is requested or is otherwise payable.

Termination of the Plan

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**2. Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and change therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risk. Further, due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the financial statements.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts included in the underlying investments of the guaranteed investment contracts ("GICs") in which the Plan holds an interest, which are reported at contract value. See Note 4 discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Management fees and operating expenses charged to the Plan for investments in variable deferred annuity contracts and GICs are deducted from income earned on a daily basis and, consequently, such expenses are reflected in the net appreciation (depreciation) in fair value of such investments.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

During the year ended December 31, 2024, certain administrative expenses of the plan were voluntarily paid by the Employer. Expenses paid by the Employer are excluded from these financial statements.

**3. Guaranteed Investment Contract ("GICs")**

The Plan invests in a Nationwide GIC which is a fully benefit-responsive investment contract. Nationwide is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There were no reserves against contract value for credit risk of the contract issuer at December 31, 2024. Contract value represents contributions made plus interest accrued at the contract rate, less withdrawals. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value, which may include a surrender charge. The minimum guaranteed interest rate ranged from 1.31% to 1.67% for 2024.

Certain events can limit the Plan's ability to transact at contract value with Nationwide. Examples of such events include, but are not limited to, termination of the Plan and tax disqualification of the Plan. As of December 31, 2024, the occurrence of an event that would limit the Plan's ability to transact at contract value with Nationwide is not considered to be probable.

**4. Investments**

The Plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Nationwide Life Insurance Company and Nationwide Trust Company, FSB

(“Nationwide”), the custodian of the Plan, and was not subjected to any audit procedures, except for comparing the information with the related information included in the financial statements and supplementary schedule:

- a. Total investments as shown in the accompanying statement of net assets available for benefits of \$2,525,252 and \$2,168,475 as of December 31, 2024 and 2023, respectively.
- b. Total change in fair value of investments as shown in the accompanying statement of changes in net assets available for benefits of \$227,540 for the year ended December 31, 2024.
- c. All investment transactions that occurred during the Plan years ended December 31, 2024.
- d. All information is included in the supplemental schedule.

**5. Concentration of Investments**

During the year ended December 31, 2024, two investments within the Plan represented more than 10% of the Net Assets Available for Benefits and represented approximately 29% of the Net Assets Available for Benefits.

**6. Fair Value Measurements**

Fair Value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is categorized based on a hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used

need to maximize the use of observable inputs. There have been no changes to the methodologies used at December 31, 2024.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* These instruments are valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **7. Tax Status**

The prototype plan document the Plan is utilizing received an opinion letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated the document is designed in accordance with the applicable requirements of the Internal Revenue Code ("IRC"). As permitted by the IRS, the Plan is relying on the opinion letter on the prototype plan document for its own qualification. Although the prototype plan document has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate the tax position taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process. Federal and state income tax statutes dictate that tax returns filed in any of the previous three

reporting periods remain open to examination. Currently, the Plan has no open examinations with either the Internal Revenue Service or state taxing authorities.

**8. Party-in-Interest Transactions**

Nationwide is the custodian of the Plan. During the year ended December 31, 2024, the Plan had investments of \$907,042 held by Nationwide. Nationwide holds the Plan's investment assets and executes investment transactions. Since Nationwide serves as the custodian of the Plan's assets, Nationwide is by definition a party-in-interest and, as a result, the investments and transactions pertaining to the investments are with a party-in-interest. Pension Solutions, Inc., the parent of Nationwide, is the record keeper of the Plan and is by definition a party-in-interest. All of these transactions are exempt from being prohibited transactions by ERISA.
