### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Rebel Athletic 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information described in Note 4 to the financial statements is complete and accurate.

#### **Note 1 – Plan Description**

The following description of the Rebel Athletic 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

##### ***General***

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of Rebel Athletic, Inc. (the “Company” or “Employer”). The Plan, which commenced effective April 1, 2016, and was amended and restated effective September 24, 2021, to comply with the latest rules and regulations, is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

##### ***Plan Custodian and Trustee***

Reliance Trust Company (“Reliance” or the “Custodian”) is the Custodian maintaining custody of all investments held by the Plan. Transamerica Retirement Solutions, LLC (“Transamerica,” or the “Recordkeeper”) maintains the Plan’s participant account balances and provides recordkeeping services to the Plan. Among other duties, Transamerica receives contributions, holds and invests the fund assets in accordance with the directions of participants, and makes distributions as directed by the Plan Administrator. An officer of the Company serves as Trustee of the Plan.

##### ***Eligibility and Plan Entrance***

All employees, except those under collective bargaining agreements, leased employees, residents of Puerto Rico, seasonal, and part-time employees, are eligible to participate in the Plan after the employee has reached 19 years of age and completed three months of service and 250 hours. Per the provisions of the Plan, part-time employment is defined as regularly scheduled service of less than 1,000 hours in the relevant computation period. Eligible employees are permitted to enter the Plan monthly, upon the first day of the month coincident with or next following satisfaction of the eligibility requirements.

##### ***Participant Contributions***

Participants may elect to contribute, on a pre-tax or Roth basis, up to the maximum amount allowed annually by the IRC, which was \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the maximum amount allowed annually by the IRC, which was \$7,500 for 2024.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and will have their deferral contribution rate increased by 1% each year until it reaches a maximum of 10% of eligible compensation, unless they elect otherwise. This increase occurs each year on the first day of the Plan year, beginning with the second change date period after the participant first has contributions made pursuant to a default election.

##### ***Rollover Contributions***

Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”).

##### ***Employer Contributions***

The Company may make discretionary matching contributions based on eligible compensation deferred into the Plan. For the year ended December 31, 2024, the Employer made discretionary matching contributions to the Plan on behalf of participants in an amount equal to 100% of the first 1% and 50% of the next 5% of participant's eligible compensation contributed to the Plan as employee contributions.

##### ***Participant Accounts***

Each participant account is credited with the participant's contributions, the Company's matching contributions, plus allocations of Plan earnings. Each participant account is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### ***Vesting***

Participants are always 100% vested with respect to their deferral contributions and rollover contributions, plus actual earnings thereon. Upon death or disability, participants become 100% vested in all funds. Employer matching contributions to the Plan, plus any income or loss thereon, are vested as follows.

##### ***Participant-Directed Investments***

All assets of the Plan are participant-directed investments. Participants have the option of directing their account balances to one or more investment options offered by the Plan. The Plan has selected various investment options, as more fully described in the Plan Document, to which participants may designate the allocation of their account balances. The funds vary in type of investment, rates of return, and investment risk.

##### ***Notes Receivable from Participants***

Participants may borrow a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate will be a reasonable rate of interest, by reviewing the interest rates charged for similar types of loans by other lenders. Principal and interest are paid ratably through payroll deductions at least quarterly.

#### Note 1 – Plan Description (continued)

##### *Payment of Benefits*

Upon separation of service due to death, disability, normal retirement, or termination of employment, a participant may elect to receive a lump sum payment from the vested portion of their account balance. Distributions to a terminated employee with a vested account balance equal to or less than \$5,000 are immediately distributable in a lump sum payment under the terms of the Plan, without the participant's consent, following the participant's termination of employment. For vested account balances of greater than \$5,000, the participant may elect whether to receive the distribution directly or to rollover the distribution into another retirement plan. A participant may withdraw all or a portion of their vested account balance in the event of a financial hardship, as defined by the Plan.

##### *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$849 and \$10,264, respectively. These accounts will be used to reduce future Employer contributions and pay Plan expenses. During the year ended December 31, 2024, forfeitures of \$17,649 were used to reduce Employer contributions.

#### Note 2 – Summary of Significant Accounting Policies

##### *Basis of Accounting*

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with the accounting principles generally accepted in the United States of America ("GAAP").

##### *Use of Estimates*

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold, as well as those held during the year.

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan Agreement.

##### *Payments of Benefits*

Benefit payments to participants are recorded when paid.

##### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain expenses specifically incurred by, or attributable to, a participant will be paid from that participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

##### *Subsequent Events*

The Company has evaluated subsequent events through July 10, 2025, the date the financial statements were available to be issued.

#### Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs in the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Money Market Fund** – This investment is recorded at cost, which approximates fair value and is classified within level 1 of the valuation hierarchy.
- **Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within Level 1 of the fair value hierarchy.

#### Note 3 – Fair Value Measurements (continued)

- **Common Collective Trust Fund** – The Galliard Stable Value Fund is primarily comprised of a fully benefit-responsive investment contract that is valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value; however, the practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily and there are no unfunded commitments. There are no significant restrictions on participant redemptions; however, if the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly manner.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedule.

#### Note 5 – Related Party and Party-in-Interest Transactions

Plan investments are shares of mutual funds and units of a common collective trust managed by Transamerica and therefore, these transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees, charged by each investment fund, under the Plan.

The Plan has notes receivable from participants as of December 31, 2024 and 2023. These receivables and all related transactions qualify as party-in-interest transactions and are exempt from being prohibited by ERISA.

#### Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

#### Note 7 – Tax Status

The Plan adopted a non-standardized, preapproved profit-sharing plan sponsored by Transamerica. The Internal Revenue Service ("IRS") has determined and informed Transamerica, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has not filed individually with the IRS for a letter regarding the Plan's qualified tax status; however, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and thus believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Because of the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### Note 9 – Prohibited Transactions

The Company failed to remit to the Plan's Trustee certain participant contributions totaling \$7,500 for the year ended December 31, 2024, within the period prescribed by the DOL's Rules and Regulations. Delays in remitting contributions to the Trustee were due to unintentional administrative errors. The Company is in the process of correcting contributions to the affected participant's account to compensate the participant for potential lost earnings due to the delays.
