Independent Auditor's Report

To the Plan Administrator

Opinion

We have audited the financial statements of Central Employees' Benefit Plan (VEBA) (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and plan benefit obligations as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits and changes in plan benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements referred to above present fairly, in all material respects, the net assets available for benefits and plan benefit obligations of the Plan as of December 31, 2024 and 2023 and the changes in net assets available for benefits and plan benefit obligations of the Plan for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Note 1 - Plan Description

The following description of Central Employees' Benefit Plan (VEBA) (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan was established effective April 1, 1979 to provide medical coverage; life, disability, and accident insurance; and dental, vision, and other benefits for eligible employees of Central Mutual Insurance Company and Subsidiaries (the "Company") and their dependents. The Plan also provides benefits to former employees for whom coverage is being continued pursuant to the terms of the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA), as amended. The Plan was restated effective September 25, 1998 to qualify as a voluntary employees' beneficiary association trust (VEBA trust), as described in Section 501(c)(9) of the Internal Revenue Code of 1986. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was restated effective January 1, 2022 to remove intermediate disability coverage.

Active employees become eligible for benefits under the Plan after electing coverage under the Plan and fulfilling certain requirements established by the Company. Disabled and certain retired employees are also eligible for coverage under the Plan. Specific eligibility requirements for disabled and retired participants are defined in the plan document.

Contributions

An employee's compensation is reduced by the amount required to pay the employee's share of the costs of the benefits elected. The employee's share of the cost of each benefit is determined annually by management of the Company based on the estimated costs of coverage. The employee's current share of the cost of coverage is 15 percent for life insurance and accidental death and dismemberment, 20 percent for personal medical and dental coverage, 50 percent for dependent medical and dental coverage, 50 percent for personal vision coverage, and 75 percent for dependent vision coverage. The Company pays the remaining cost not covered by the employee's share. The Company also pays the full cost of the long-term coverage.

Retirees do not make any contributions for retiree life insurance, as these premiums are paid by the Plan. Effective for participants retiring after January 1, 2012, the Plan no longer offers retiree life insurance. As such, retiree life insurance is only provided for retirees if they retired prior to January 1, 2012. For medical benefits, the retiree's share of the cost is determined by management of the Company based on the years of service and retirement date of each retiree and the estimated costs of coverage. The retiree contribution amounts for retirement dates after 1994 and before 2004 are 5 percent of the premium for the retirees and 50 percent for spouses, increasing 2.5 percent for each year of service under 30. For retirement dates after 2003 and before 2012, retiree contributions are 15 percent of the premium for the retirees and 45 percent for spouses, increasing 2.5 percent for each year of service under 30. For retirement dates after 2011, retiree contributions are 18.56 percent to 20 percent of the premium for the retirees and 49.10 percent to 50 percent for spouses, increasing 2.5 percent for each year of service under 30.

Retiree contributions totaled approximately \$741,000 and \$773,000 for the years ended December 31, 2024 and 2023, respectively. Retiree contributions covered 36 percent of total retiree claims paid for both years ended December 31, 2024 and 2023.

The Company makes, from time to time, further contributions to the Plan. The Plan's deficiency of net assets compared to plan benefit obligations relates primarily to the postretirement benefit obligations, the funding of which is not required under ERISA. It is expected that the deficiency will be funded through future contributions to the Plan by the Company and/or participants and investment income.

Note 1 - Plan Description (Continued)

All participant and employer contributions are deposited into the VEBA trust when withheld, received, or authorized. The VEBA trust assets and earnings thereon are available to pay appropriate benefits and expenses of the Plan. See Note 2 related to VEBA trust asset restrictions.

Health and Welfare Benefits

The Plan provides health benefits (medical, dental, vision, and applicable Medicare coordination coverage), long-term disability income benefits, accidental death and dismemberment benefits, life insurance coverage, an employee assistance program, and severance payments (as applicable) to full-time participants (all nontemporary employees who are regularly scheduled to work 30 hours or more each week) and to their beneficiaries and covered dependents. In addition, medical coverage, Medicare coordination coverage, and life insurance coverage are available to certain retirees, their beneficiaries, and covered dependents, as defined in the plan document.

Life insurance benefits, accidental death and dismemberment benefits, long-term disability income benefits, vision benefits, medical benefits for retirees over age 65, and Medicare coordination coverage are provided through insurance contracts. All other benefits are self-insured and paid by the Plan.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to employees and to terminate the Plan subject to the provisions set forth in ERISA. If the Company terminates or partially terminates the Plan, the net assets of the Plan will be used to pay benefit obligations of the Plan.

Note 2 - Summary of Significant Accounting Policies

Restricted Assets

Effective January 1, 2013, under the terms of the Plan, bond assets, including any proceeds from the bonds, held by the Plan are segregated and restricted for paying postretirement benefit obligations only and cannot be used for paying benefits to active employees. At December 31, 2024 and 2023, \$22,092,648 and \$22,943,081, respectively, of assets is restricted for postretirement benefit obligation purposes.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value.

The U.S. municipal securities are valued using quoted market prices and/or other market data for the same or comparable instruments and transactions in establishing the prices, discounted cash flow models, and other pricing models. These models are primarily industry-standard models that consider various assumptions, including time value and yield curve, as well as other relevant economic measures. See Note 3 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned.

Deposits

Deposits represent amounts deposited in advance for health, dental, and other benefit payments processed by independent agencies.

Claims Incurred but Not Reported

The Plan's obligations for health claims incurred but not reported (IBNR) at the valuation date are estimated by the Plan's actuary. IBNR is recorded in the accompanying statement of plan benefit obligations using estimates along with historical experience as compared to actual claims paid.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company, which qualify as party-in-interest transactions.

Postretirement Benefits

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the date of the financial statements reduced by the actuarial present value of contributions expected to be received in the future from current plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Company, participants, and existing plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The health care cost trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If assumed rates increased by 1 percentage point, this would increase the plan benefit obligation as of December 31, 2024 and 2023 by approximately \$4,300,000 and \$5,100,000, respectively. If assumed rates decreased by 1 percentage point, this would decrease the plan benefit obligation as of December 31, 2024 and 2023 by approximately \$3,600,000 and \$4,200,000, respectively.

The following were other significant assumptions used in the valuations as of December 31, 2024 and 2023:

Health care costs	6.80 percent annual rate of increase in the medical trend of covered health care benefits at December 31, 2024; the rate was assumed to increase 0.1 percent and decrease between 0.1 to 0.9 percent per year to 3.70 percent and to remain at that level thereafter. 6.50 percent annual rate of increase in the medical trend of covered health care benefits at December 31, 2023; the rate was assumed to increase between 0.1 and 0.5 percent and decrease between 0.1 to 0.6 percent per year to 3.70 percent and to remain at that level thereafter

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

Note 2 - Summary of Significant Accounting Policies (Continued)

The decrease in postretirement benefit obligations due to a change in actuarial assumptions of \$2,800,536 for the year ended December 31, 2024 relates primarily to the change in discount rate for the year ended December 31, 2024, along with updates to both the withdrawal and retirement decrements and coverage election rates for the year ended December 31, 2024.

The increase in postretirement benefit obligations due to a change in actuarial assumptions of \$768,986 for the year ended December 31, 2023 relates primarily to the change in discount rate and health care cost trend rate used for the year ended December 31, 2023.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The contributions and plan benefit obligations are reported based on certain assumptions pertaining to interest rates, health care cost trend rates, and employee and retiree demographics. Due to the changing nature of these assumptions, it is at least reasonably possible that changes in these assumptions will occur in the near term and, due to the uncertainties inherent in setting assumptions, that the effect of such changes could be material to the financial statements. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. It is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including August 26, 2025, which is the date the financial statements were available to be issued.

Note 3 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 4 - Tax Status

The trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (the "Code"), and, accordingly, the trust's net investment income is generally exempt from income taxes. The trust has obtained a favorable tax exemption letter from the Internal Revenue Service, and the plan sponsor believes that the trust continues to qualify and to operate in accordance with applicable provisions of the Code.

Note 5 - Stop-loss Program

The Plan has entered into a stop-loss insurance (reinsurance) contract to limit its exposure to large medical claims. The terms of the agreement provide that the insurance company will reimburse the Plan for medical benefits paid in excess of \$350,000 for most individual participants during the plan years ended December 31, 2024 and 2023. There are no amounts due from the insurance company at December 31, 2024 and 2023 related to medical benefits paid in excess of the stop-loss agreement.
