- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Required supplementary information

Management has omitted management's discussion and analysis that accounting principles generally accepted in the United States of America require to be presented to supplement the basic financial statements. Such missing information, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. Our report on the basic financial statements is not affected by this missing information.

NOTE 1 - DESCRIPTION OF PLAN

The following description of MLCV Non-Gaming 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established for the benefit of the nonunion employees of MLCV 2020 Holdings, LLC dba 2020 Brand Solutions, 2020 Casino Solutions, LLC, Nandookomeshlinh, LLC, Eddy's Resort, Wewinabi, Inc., and Sweetgrass Media, LLC (collectively, the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Mille Lacs Corporate Ventures' Retirement Committee is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Mille Lacs Corporate Ventures' Board of Directors.

Eligibility

Employees of the Employer who have reached 21 years of age and have completed 60 days of service, as defined by the Plan, are eligible to participate in the Plan.

Contributions

Each year, participants may make salary deferral contributions up to the maximum dollar amount permitted by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover), or make Plan-to-Plan transfers as defined in the Plan document. The Employer may, at its discretion, make a matching or profit sharing contribution to the Plan. There were no discretionary Employer contributions for the year ended December 31, 2023. Contributions are subject to certain Internal Revenue Service (IRS) limits.

Participant Accounts

Each participant's account is credited or charged with the participant's contributions, Employer contributions, if any, Plan investment results and administrative expenses that are paid by the Plan. Allocations are based on participant compensation, account balance or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants' Investment Options

Upon enrollment in the Plan, a participant may direct contributions to various investment options, as more fully described in the Plan's literature. All options vary in types of investments, rates of return and investment risk. Participants may make transfers between funds on a daily basis.

Vesting

The participants are always 100% vested in their own contributions plus actual earnings thereon. Vesting in the Employer's matching and profit sharing contributions portion of their accounts is based on years of continuous service. A participant vests at a rate of 20% for each year of service until 100% vested after five years of service, upon death or total disability during the term of employment, or upon termination of the Plan.

Forfeited Accounts

Forfeited nonvested accounts may be used to cover certain plan administrative expenses and to fund the Employer's contributions to the Plan. At December 31, 2023 and 2022, forfeited nonvested accounts totaled \$0.

Payment of Benefits

Upon termination of service, a participant can elect to receive a lump-sum amount or installments equal to the vested balance in his or her account or directly roll the vested balance over to an individual retirement account. Upon termination, participants may also elect to hold their investments in the Plan, unless the vested balance is less than \$5,000, in which case the vested balance is automatically distributed. A participant may elect to receive an in-service distribution upon attainment of age 59½ or meeting certain financial need qualifications, as defined.

Notes Receivable from Participants

Under the terms of the Plan, participants may borrow from their accounts a minimum of \$1,000 and up to the lesser of 50% of the participant's vested account balance or \$50,000. The notes are secured by the balance in the participant's account and bear interest at 5.75% as of December 31, 2022, which is commensurate with the prime rate plus 1%. There are no notes receivables from participants as of December 31, 2023. The term of the note may not exceed 10 years. Principal and interest are paid ratably through payroll deductions.

Transfers

Effective December 31, 2023, and pursuant to a Plan Amendment, the assets and liabilities of the Plan were merged into the Mille Lacs Corporate Ventures Retirement Plan. The plan merger was in accordance with regulatory requirements including Internal Revenue Code Sections 401(a)(12) and 414(l). The assets transferred totaled \$626,740.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting standards promulgated by the Governmental Accounting Standards Board (GASB). This Plan is sponsored by MLCV 2020 Holdings, LLC dba 2020 Brand Solutions, a corporate body politic and political subdivision of the Mille Lacs Band of Ojibwe Indians (the Band). These financial statements present only the Plan and are not intended to present the financial statements of the Band.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Plan investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Committee determines the Plan's valuation policies utilizing information provided by the

investment advisors, trustees and other third parties. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investment securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of Benefits

Benefit payments are recorded when paid.

Investment Policy and Risks

Investment Policy

The Plan offers a broad range of diversified investments that enable the participant to construct a portfolio with aggregate risk and return characteristics at any point within the participant's desired range. Adherence to the specific investment objectives and criteria contained therein will be evaluated over a full market cycle, which historically has been five to seven years.

Interest Rate Risk

This is the risk that changes in market interest rates will adversely affect the fair value of an investment. Investments with longer maturities have greater sensitivity to fair value changes based on market interest rates. The bond funds, balanced funds and collective trust funds are exposed to this risk.

Credit Risk

Credit risk exists when there is a possibility that the issuer or other counterparty to an investment may be unable to fulfill its payments on a security under the original term. The bond funds, balanced funds, and the collective trust fund are exposed to this risk.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included as an offset to net appreciation in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 or 2022. If a participant ceases to make loan repayments, and the Plan Administrator deems the participant's loan to be in default, the participant note balance is reduced, and a benefit payment is recorded.

Notes receivable from participants are classified as an investment for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, schedule H, line 4i - schedule of assets (held at end of year).

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability. The Plan distributed the 2022 excess contributions to the applicable participants.

NOTE 3 - INFORMATION CERTIFIED OR PROVIDED BY THE TRUSTEES

The following is a summary of the Plan's asset information as of December 31, 2023 and 2022, and for the year ended December 31, 2023, included throughout the Plan's financial statements, that was prepared by or derived from information provided by Empower Retirement LLC, the trustee of the Plan and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to information that appears throughout the financial statements related to the following assets:

The trustee also certified to the completeness and accuracy of \$89,900 of net appreciation in fair value of investments, \$24,176 of interest and dividend income related to the aforementioned investments, and \$37 of interest income on notes receivable from participants for the year ended December 31, 2023.

NOTE 4 - FAIR VALUE MEASUREMENTS

To the extent available, the Plan's investments are recorded at fair value as of December 31, 2023 and 2022. GASB Statement No. 72 defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. This statement establishes a hierarchy of valuation inputs based on the extent to which the inputs are observable in the marketplace. Inputs are used in applying the various valuation techniques and take into account the assumptions that market participants use to make valuation decisions. Inputs may include price information, credit data, interest and yield curve data, and other factors specific to the financial instrument. Observable inputs reflect market data obtained from independent sources. In contrast, unobservable inputs reflect the entity's assumptions about how market participants would value the financial instrument. Valuation techniques should maximize the use of observable inputs to the extent available.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following describes the hierarchy of inputs used to measure fair value and the primary valuation methodologies used for financial instruments measured at fair value on a recurring basis:

- Level 1 - Investments whose values are based on quoted prices (unadjusted) for identical assets in active markets that a government can access at the measurement date.
- Level 2 - Investments with inputs, other than quoted prices included within Level 1, that are observable for an asset, either directly or indirectly.

Level 3 - Investments classified as Level 3 have unobservable inputs for an asset and may require a degree of professional judgment.

Shares of registered investment companies: Shares of registered investment companies are valued at quoted market prices for identical assets in active markets for shares held by the Plan at year-end.

Collective trust fund: The fair value of the collective trust fund has been determined using the NAV per share of the underlying pool of securities as a practical expedient, which was provided to the Plan by the trustee.

NOTE 5 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Empower Retirement, LLC was both the trustee of the Plan, and the recordkeeper, as defined by the Plan. Fees paid by the Plan to the trustees and recordkeepers were included in administrative expenses in the statement of changes in fiduciary net position.

Certain plan investments are shares of registered investment companies managed by Empower Retirement LLC. Empower Retirement, LLC are the recordkeepers as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to change or to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts. Any unallocated assets of the Plan would be allocated to participant accounts and distributed in such a manner as the Employer may determine.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2021 statement of fiduciary net position.

NOTE 8 - TAX STATUS

Effective June 1, 2022, the Plan adopted a volume submitter plan document sponsored by Empower Retirement LLC. The volume submitter plan has received an opinion letter from the IRS dated November 14, 2022 that the volume submitter plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The volume submitter plan opinion letter has been relied upon by this Plan. The Plan has been amended subsequent to the date of the opinion letter.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
