INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of
Cooke Seafoods USA 401(k) Plan

We have performed audits of the accompanying financial statements of Cooke Seafoods USA 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. DESCRIPTION OF PLAN

General

The Plan was formerly known as True North Salmon US Inc. 401(k) Plan. On September 16, 2019, the Plan was restated under the name of Cooke Seafoods USA 401(k) Plan (the Plan). The following description of the Plan provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering substantially all employees of Cooke Aquaculture USA, Inc. and Affiliates (collectively referred to as the Company or the Plan Sponsor), with the exception of employees subject to a collective bargaining agreement, non-resident aliens, consultants, and seasonal employees who work less than 1,000 hours during the Plan year. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024, the Slade Gorton & Co., Inc. 401(k) Savings Plan was merged into the Plan. The merger is reflected in the statement of changes in net assets available for the year ended December 31, 2024.

Eligibility

Employees are eligible to participate in the Plan upon reaching age 18 and after completing three months of service, as defined by the Plan.

Contributions

Participant contributions – Each year, participants may contribute between 1% and 90% of pretax annual compensation, as defined in the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Employer discretionary matching contributions – The Company may elect to make discretionary matching contributions to the Plan up to 6% of eligible compensation. The discretionary matching contributions are determined by the Board of Directors each year. Participants must be employed as of the last day of the Plan year to be eligible to receive any contributions. There were no discretionary matching contributions made for the year ended December 31, 2024.

Company safe harbor matching contributions – The Company also makes safe harbor matching contributions equal to 100% of employee deferrals up to 4% of the participant's eligible compensation, regardless of the employee's hours of service or employment on the last day of the Plan year.

Contributions are subject to regulatory limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company's safe harbor matching contributions, as well as allocations of the Company's discretionary matching contributions and Plan earnings. Participant accounts are charged with an allocation of

administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their voluntary contributions, safe harbor matching contributions and profit-sharing contributions plus actual earnings on these contributions. Participants may be subject to vesting schedules for contributions made while participating in legacy plans, as defined by the Plan.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years. Under the terms of the Plan agreement, Plan loans will bear a rate of interest of 1% over the Prime Rate published in the Wall Street Journal.

Payment of Benefits

Participant contributions may be withdrawn for financial hardship subject to restrictions under Internal Revenue Code (IRC) and the Plan. Participant contributions may also be withdrawn after participants reach age 59½. On termination of service due to death, disability or retirement, a participant whose vested balance exceeds \$5,000 may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. If the participant's vested benefit in the Plan does not exceed \$5,000 at the time of termination of employment, the participant's benefit may be distributed in a single lump-sum payment as soon as administratively feasible. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures

Forfeitures are the nonvested portion of a participant's account that is lost upon termination of employment. Forfeitures are retained in the Plan and will be used to pay the Plan's administrative expenses, or reduce future Company contributions. As of December 31, 2024 and 2023, forfeited balances were \$119,889 and \$95,656, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation

The investments are reported at fair value, except for the group annuity contract, which is valued at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Contract value is the relevant measurement for assets invested in fully benefit-responsive group annuity contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes Receivable from Participants

Notes receivable from participants are measured at amortized cost, which represents the unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses paid by the Plan may include notes receivable and distribution fees charged to participants' accounts and administrative Plan fees. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through August 20, 2025, which is the date the financial statements were available to be issued, and has determined that there are no subsequent events that require disclosure under Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) Topic 855, *Subsequent Events*.

3. FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy FASB ASC Topic 820, *Fair Value Measurements*.

The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission.

Pooled separate accounts (PSAs): Valued at the NAV, as provided by the administrator, used as a practical expedient to estimate fair value. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV, as provided by the custodian of the fund, is valued and published daily.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

4. GUARANTEED INVESTMENT CONTRACT

The Plan entered into a fully benefit-responsive group annuity contract (FBRIC) with Empower Annuity Insurance Company (Empower Annuity) formerly, Great-West Life & Annuity Insurance Company. Empower Annuity maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a monthly basis for resetting. The FBRIC does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the FBRIC criteria; and is therefore, reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Annuity, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) An uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the issuer.

5. TAX STATUS

The Plan adopted a defined contribution pre-approved prototype plan sponsored by Empower Retirement, LLC (Empower). The Internal Revenue Service (IRS) has determined and informed Empower by a letter dated November 14, 2022 that the prototype document satisfies the applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Accordingly, the accompanying financial statements do not include a provision for income taxes.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that is more likely than not to be sustained upon examination by the IRS. The Plan is subject to audit by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.

7. INFORMATION CERTIFIED BY THE CUSTODIANS

Empower Annuity Insurance Company of America and Empower Trust Company, LLC serve as the custodians of the Plan. Certain information related to investments disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, and dividend and interest income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the custodians of the Plan.

8. PARTY-IN-INTEREST TRANSACTIONS

The Plan paid expenses related to the Plan's operations and investment management to various service providers. Certain Plan investments are managed by the respective custodians; therefore, these transactions with these entities qualify as exempt party-in-interest transactions.

9. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.
